The following categories apply to each column in this subsection.
Column A - principal 0-10 State-allotted teachers, assistant principal, career evaluator.
Column B - principal 11-21 teachers, supervisor, director, program administrator, career director coordinator.
Column C - principal 22-32 teachers, assistant superintendent.
Column D - principal 33-43 teachers, associate superintendent.
Column E - principal 44-54 teachers, superintendent of up to 5,000 students ADM.
Column F - principal 55-65 teachers, superintendent 5,001 to 10,000 students ADM.
Column G - principal $66 \&$ up teachers, superintendent 10,001 to 15,000 students ADM.
Column H - superintendent of 15,001 to 20,000 students ADM.
Column I - superintendent of 20,001 to 25,000 students ADM.
Column J - superintendent of 25,001 to 30,000 students ADM.
Column K - superintendent of 30,000 students and up ADM.
(b) All administrators shall be placed on the new salary schedule based on total years of certified experience, and shall receive the salary increases necessary to bring them to the appropriate level on the schedule; provided, however, that no administrator shall receive less than a fifty dollar (\$50.00) per month salary increase in 1990-91, and
no administrator's salary may be reduced as a result of the administrator's placement on the salary schedule. A minimum of five years' experience shall be required for placement on the schedule.
(c) Enactment of this salary schedule may not be construed to diminish or rescind additions to salary amounts provided by law for administrator participation in the Career Development Pilot Program, or for an administrator's possession of an advanced certificate or earned doctorate degree; nor may enactment of this salary schedule be construed to diminish or rescind rights or benefits conferred upon administrators by law, other than those which expressly refer to salary matters.
(d) The State Board of Education shall adopt rules and regulations necessary to implement this act.
Sec. 2. There is appropriated from the General Fund to the Department of Public Education $\$ 24,000,000$ for the $1989-90$ fiscal year, and $\$ 50,400,000$ for the $1990-91$ fiscal year, to be used for the implementation of this act.
Sec. 3. This act shall become effective July 1, 1989.
