A BILL TO BE ENTITLED

AN ACT TO CHANGE THE NAME OF THE DEPARTMENT OF COMMERCE TO THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, TO PROVIDE FOR A DIVISION OF HOUSING IN THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, TO PROVIDE FOR A TOLL-FREE TELEPHONE NUMBER FOR HOUSING ASSISTANCE INFORMATION WITHIN THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, AND TO MAKE TECHNICAL AND CONFORMING AMENDMENTS TO VARIOUS LAWS.

The General Assembly of North Carolina enacts:

Section 1. Article 10 of Chapter 143B of the General Statutes is amended by deleting the existing title and substituting "Department of Economic and Community Development".

Sec. 2. G.S. 143B-431, as amended by Section 25 of Chapter 76 of the 1989 Session Laws, reads as rewritten:

"§ 143B-431. Department of Commerce Economic and Community Development – functions.

(a) The functions of the Department of Commerce Economic and Community Development, except as otherwise expressly provided by Article 1 of this Chapter or by the Constitution of North Carolina, shall include:

- 1 (1) All of the executive functions of the State in relation to economic
2 development including by way of enumeration and not of limitation,
3 the expansion and recruitment of environmentally sound industry,
4 labor force development, the promotion of and assistance in the
5 orderly development of North Carolina counties and communities, the
6 promotion and growth of the travel and tourism industries, the
7 development of our State's ports, energy resource management and
8 energy policy development;
- 9 (2) All functions, powers, duties and obligations heretofore vested in any
10 agency enumerated in Article 15 of Chapter 143A, to wit:
11 a. The State Board of Alcoholic Control,
12 b. The North Carolina Utilities Commission,
13 c. The Employment Security Commission,
14 d. The North Carolina Industrial Commission,
15 e. State Banking Commission and the Commissioner of Banks,
16 f. Savings and Loan Association Division,
17 g. The State Savings Institutions Commission,
18 h. Credit Union Commission,
19 i. The North Carolina Milk Commission,
20 j. The North Carolina Mutual Burial Association Commission,
21 k. The North Carolina Rural Electrification Authority,
22 l. The North Carolina State Ports Authority, all of which
23 enumerated agencies are hereby expressly transferred by a Type
24 II transfer, as defined by G.S. 143A-6, to this recreated and
25 reconstituted Department of ~~Commer~~Economic and
26 Community Development; and,
- 27 (3) All other functions, powers, duties and obligations as are conferred by
28 this Chapter, delegated or assigned by the Governor and conferred by
29 the Constitution and laws of this State. Any agency transferred to the
30 Department of ~~Commer~~Economic and Community Development by
31 a Type II transfer, as defined by G.S. 143A-6, shall have the authority
32 to employ, direct and supervise professional and technical personnel,
33 and such agencies shall not be accountable to the Secretary of
34 ~~Commer~~Economic and Community Development in their exercise of
35 quasi-judicial powers authorized by statute, notwithstanding any other
36 provisions of this Chapter, provided that the authority of the North
37 Carolina State Ports Authority to employ, direct and supervise
38 personnel shall be as provided in Part 10 of this Article.
- 39 (b) The Department of ~~Commer~~Economic and Community Development is
40 authorized to establish and provide for the operation of North Carolina nonprofit
41 corporations to achieve the purpose of aiding the development of small businesses and
42 to achieve the purposes of the United States Small Business Administration's 504
43 Certified Development Company Program.

1 (c) The Department of Economic and Community Development shall have
2 the following powers and duties with respect to local planning assistance:

- 3 (1) To provide planning assistance to municipalities and counties and joint
4 and regional planning boards established by two or more governmental
5 units in the solution of their local planning problems. Planning
6 assistance as used in this section shall consist of making population,
7 economic, land use, traffic, and parking studies and developing plans
8 based thereon to guide public and private development and other
9 planning work of a similar nature. Planning assistance shall also
10 include the preparation of proposed subdivision regulations, zoning
11 ordinances, capital budgets, and similar measures that may be
12 recommended for the implementation of such plans. The term planning
13 assistance shall not be construed to include the providing of plans for
14 specific public works.
- 15 (2) To receive and expend federal and other funds for planning assistance
16 to municipalities and counties and to joint and regional planning
17 boards, and to enter into contracts with the federal government,
18 municipalities, counties, or joint and regional planning boards with
19 reference thereto.
- 20 (3) To perform planning assistance, either through the staff of the
21 Department or through acceptable contractual arrangements with other
22 qualified State agencies or institutions, local planning agencies, or with
23 private professional organizations or individuals.
- 24 (4) To assume full responsibility for the proper execution of a planning
25 program for which a grant of State or federal funds has been made and
26 for carrying out the terms of a federal grant contract.
- 27 (5) To cooperate with municipal, county, joint and regional planning
28 boards, and federal agencies for the purpose of aiding and encouraging
29 an orderly, coordinated development of the State.
- 30 (6) To establish and conduct, either with its own staff or through
31 contractual arrangements with institutions of higher education, State
32 agencies, or private agencies, training programs for those employed or
33 to be employed in community development activities."

34 Sec. 3. The Secretary of Economic and Community Development shall
35 establish the functions of community development and housing within the Department
36 of Economic and Community Development and shall establish the position of Deputy or
37 Assistant Secretary for Community Development and Housing within the Department,
38 which Deputy or Assistant Secretary shall be of the same status and position as the
39 Deputy or Assistant Secretary for Economic Development. The functions of the
40 Division of Community Assistance as transferred by this act shall be located under the
41 Deputy or Assistant Secretary for Community Development and Housing.

42 Sec. 4. Chapter 143B of the General Statutes is amended by adding a new
43 Part to read:

44 **“PART 1A.**

"HOUSING COORDINATION AND POLICY COUNCIL.**"§ 143B-433.1. Housing Coordination and Policy Council; creation; duties.**

(a) There is created the Housing Coordination and Policy Council of the Department of Economic and Community Development. The Housing Coordination and Policy Council shall have the following functions and duties:

- (1) To advise the Secretary of Economic and Community Development and the Deputy Secretary of Community Development and Housing regarding the coordination of various public and private low and moderate income housing programs;
- (2) To advise the Secretary of Economic and Community Development and the Deputy Secretary of Community Development and Housing in the preparation of an overall, comprehensive State housing plan with specific recommendations to address identified areas of need, which report shall be presented to the Governor and General Assembly;
- (3) To advise the Secretary of Economic and Community Development and the Deputy Secretary of Community Development and Housing with respect to the best use of housing resources under the Deputy Secretary; and
- (4) To advise the Secretary of Economic and Community Development regarding any other matter relating to housing the Secretary may refer to it.

(b) Nothing herein shall abrogate the existing statutory responsibility of any other agency to develop housing plans and policies relating to specific housing programs.

"§ 143B-433.2. Council membership; compensation; procedures.

(a) The Housing Coordination and Policy Council shall consist of 15 representatives, as follows:

- (1) Two members of the N.C. Housing Partnership who are experienced with housing programs for low-income persons, as designated by the chairman.
- (2) Two members of the Community Development Council who are experienced with federal, state and local housing programs, as designated by the chairman.
- (3) Two members of the N.C. Housing Finance Agency Board of Directors who are experienced with real estate finance and development, as designated by the chairman.
- (4) One member of the Weatherization Policy Advisory Council who is experienced with community weatherization programs, as designated by the chairman.
- (5) One member of the Governor's Advocacy Council for Persons with Disabilities who is familiar with the housing needs of the disabled.
- (6) The executive director of the Commission of Indian Affairs, or a designee familiar with Indian housing programs.

- 1 (7) The Deputy Secretary or Assistant Secretary of Community
2 Development and Housing, or a designee familiar with housing
3 programs related to community development and housing functions.
4 (8) The assistant secretary of the Division of Aging, or a designee familiar
5 with the housing programs of the division.
6 (9) The executive director of the N.C. Housing Finance Agency, or a
7 designee familiar with the housing programs of the agency.
8 (10) The director of the Division of Mental Health or a designee familiar
9 with housing for those with mental disabilities.
10 (11) The executive director of the N.C. Human Relations Council or a
11 designee familiar with federal and state fair housing laws.
12 (12) A chairman designated by the Secretary of Economic and Community
13 Development.

14 (b) All members except those serving ex officio shall be appointed by the
15 Secretary of Economic and Community Development. The Secretary of Economic and
16 Community Development shall designate one member of the Council to serve as Chair.

17 (c) The initial members of the Council other than those serving ex officio shall
18 be appointed to serve for terms of four years and until their successors are appointed
19 and qualified. Any appointment to fill a vacancy created by resignation, dismissal,
20 death, or disability of a member shall be for the balance of the term.

21 (d) Members of the Council may receive per diem and necessary travel and
22 subsistence expenses in accordance with the provisions of G.S. 138-5.

23 (e) A majority of the Council shall constitute a quorum for the transaction of
24 business.

25 (f) All clerical and other services required by the Council shall be supplied by
26 the Secretary of Economic and Community Development.

27 "**§ 143B-433.3. Council meetings; report.**"

28 (a) The Housing Coordination and Policy Council shall meet at least quarterly
29 and may hold special meetings at any time and place within the State at the call of the
30 Chair or upon written request of a majority of the members.

31 (b) The Council shall assist in the preparation and filing of an annual written
32 report which contains a review of work completed, a review of ongoing activities, and
33 housing policy recommendations. This report shall be filed with the General Assembly
34 and the Governor by May 1. The report to the 1991 Session of the General Assembly
35 shall contain specific recommendations regarding the further consolidation of housing
36 programs within State government."

1 Sec. 9. (a) References in the Session Laws to any department, division, or
2 other agency which is transferred by this act shall be deemed to refer to the successor
3 department, division, or other agency. Every Session Law which refers to any
4 department, division, or other agency to which this act applies or which relates to any
5 power, duty, function, or obligation of any such department, division or agency and
6 which continues in effect after this act becomes effective shall be construed so as to be
7 consistent with this act.

8 (b) The Revisor of Statutes is authorized to correct any reference or citation
9 in the General Statutes to any portion of the General Statutes which is recodified,
10 transferred, subdivided, or amended by this act by deleting incorrect references and
11 substituting correct references.

12 (c) The Revisor of Statutes is authorized to delete any reference to the
13 Department of Commerce, the Secretary of Commerce, the Department of Natural

16 Human Resources, or their predecessors in any portion of the General Statutes to which

7 in the area of coastal resources and environmental protection shall be
8 appointed by and serve at the pleasure of the Secretary of ~~the~~
9 ~~Department of Natural Resources and Community Development~~.
10 Environment, Health, and Natural Resources.
- 11 (6) One member representing the Department of Human Resources in the

19 subsequently transferred to the Department of Economic and Community Development
20 or to any other department.

21 Sec. 22. Every act of any department, agency, or officer to which this act
22 applies which occurred prior to the date this act is ratified and which is otherwise valid
23 continues to be valid and effective notwithstanding any change in name or transfer of
24 such department, agency, or officer.

25 Sec. 23. This act shall not be construed to obligate the General Assembly to
26 make any appropriation to implement the provisions of this act. Each department and
27 agency to which this act applies shall implement the provisions of this act from funds
28 otherwise appropriated to that department or agency.

29 Sec. 24. This act shall become effective 1 July 1989.
