1 A BILL TO BE ENTITLED
2 AN ACT TO AMEND ARTICLE 2, "LICENSE TAXES," OF THE REVENUE ACT
3 TO PROVIDE FOR TAX SIMPLIFICATION AND TO RAISE REVENUES.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 105-33(e) is repealed.

6 Sec. 2. G.S. 105-36 reads as rewritten:

7 "**§ 105-36. Amusements – Manufacturing, selling, leasing, or distributing moving**
8 **picture films or checking attendance at moving picture shows.**

9 Every person, firm, or corporation engaged in the business of manufacturing, selling,
10 leasing, furnishing and/or distributing films to be used in this State in moving picture
11 theatres or other places at which an admission fee is charged shall apply for and obtain
12 from the Secretary of Revenue a statewide license for the privilege of engaging in such
13 business in this State, and shall pay for such license a tax of six hundred and twenty-five
14 dollars (\$625.00). ~~(\$625.00):~~ ~~Provided, that persons, firms, or corporations engaged~~
15 ~~exclusively in the business of selling, leasing, furnishing and/or distributing films for use in~~
16 ~~places where no admission fee is charged or in schools, public or private, and other institutions~~
17 ~~of learning in this State, shall pay a tax of twenty five dollars (\$25.00).~~

18 ~~Any person, firm, or corporation engaged under contract or for compensation in the~~
19 ~~business of checking the attendance of any moving picture or show for the purpose of~~
20 ~~ascertaining attendance or amount of admission receipts at any theatre or theatres shall~~
21 ~~apply for and obtain from the Secretary of Revenue a statewide license for the privilege~~
22 ~~of engaging in such business in this State, and shall pay for such license an annual tax of~~
23 ~~two hundred and fifty dollars (\$250.00):~~ ~~Provided, that persons engaged in the public~~

1 ~~practice of accounting and licensed under G.S. 105-41(e) shall be exempt from the~~
 2 ~~payment of this license tax.~~

3 Counties, cities, and towns shall not levy a license tax on the business taxed under
 4 this section."

6 **"§ 105-36.1. Amusements – Outdoor theatres.**

7 (a) Every person, firm or corporation engaged in the business of operating an
 8 outdoor or drive-in moving picture show for compensation shall apply for and obtain in
 9 advance from the Secretary of Revenue a State license for the privilege of engaging in
 10 such business and shall pay a tax in accordance with the following schedule: for such
 11 license a tax of one hundred dollars (\$100.00).

 28 ~~operator of a business taxed under this section shall pay a tax of one dollar (\$1.00) for~~
 29 ~~each seat or seating space provided for patrons outside of motor vehicles driven into the~~
 30 ~~enclosure by patrons. For the purpose of this section, car capacity shall be determined~~
 31 ~~by the number of outlets provided for individual speakers. In the case of drive-in or~~
 32 ~~outdoor theatres not equipped with individual speakers or outlets therefor, but which are~~
 33 ~~equipped with one or more central speakers, the car capacity shall be regarded and rated~~
 34 ~~as 200.~~

35 ~~In the case of drive-in or outdoor theatres located within 10 miles of the corporate~~
 36 ~~limits of more than one municipality, the tax herein levied shall be paid in accordance~~

38 ~~For the purpose of this section, unincorporated communities shall be regarded as~~
 39 ~~incorporated municipalities, with the corporate limits deemed to extend one mile in~~

 41 ~~community; and if there is no such intersection, then from the recognized business~~
 42 ~~center of such unincorporated community.~~

43 ~~In the case of drive-in or outdoor theatres located more than 10 miles from the~~
 44 ~~corporate limits of any municipality, the tax shall be paid at the rate herein provided for~~

1 such theatres located within 10 miles of the corporate limits of a municipality having a
 2 population of 3,000 to 5,000.

3 In the case of drive-in or outdoor theatres operating less than six months each year,
 4 the tax shall be one half the tax herein levied.

5 (b) Cities and towns may levy a tax upon the businesses taxed in this section not
 6 in excess of the following amounts: that levied by the State.

23 (a) Every person, firm, or corporation engaged in the business of operating a
 24 moving picture show for compensation shall apply for and obtain in advance from the
 25 Secretary of Revenue a State license for the privilege of engaging in such business, and
 26 shall pay for such State license for each room, hall, or tent used ~~the following tax:~~ a tax of

8 (e) For any motion picture show operating three days or less each week, the tax
 9 levied shall be one half the annual tax provided above. ~~above, based upon the population~~
 10 ~~of the city or town in which such theatre is located.~~

11 (e1) Motion picture shows promoted and managed by a qualifying corporation that
 12 operates a center for the performing and visual arts are exempt from the license tax
 13 imposed under this section if the motion pictures are shown at the center and if the
 14 showing of motion pictures is not the primary purpose of the center. As used in this
 15 subsection, 'qualifying corporation' and 'center for the performing and visual arts' have
 16 the same meaning as in G.S. 105-37.1(a).

 43 specifically exempted in this Article, for which an admission is charged, shall pay an

1 annual license tax of fifty dollars (\$50.00) for each room, hall, tent or other place where
2 such admission charges are made. ~~made, graduated according to population, as follows:~~

15 In addition to the license tax levied above, ~~in the above schedule~~, such person, firm, or
16 corporation shall pay an additional tax upon the gross receipts of such business at the
17 rate of ~~tax levied in Article V, Schedule E, G.S. 105-164.1 to 105-164.44, upon retail sales of~~
18 ~~merchandise~~ three percent (3%). Reports shall be made to the Secretary of Revenue, in
19 such form as he may prescribe, within the first 10 days of each month covering all such
20 gross receipts for the previous month, and the additional tax herein levied shall be paid
21 monthly at the time such reports are made. The annual license tax herein levied shall be
22 treated as an advance payment of the tax upon gross receipts herein levied, and the
23 annual license tax shall be applied as a credit upon or advance payment of the gross
24 receipts tax.

25 Every person, firm, or corporation giving, offering, or managing any dance or
26 athletic contest of any kind, except high school and elementary school athletic contests,
27 for which an admission fee in excess of fifty cents (50¢) is charged, shall pay an annual
28 license tax of ~~five dollars (\$5.00)~~ fifty dollars (\$50.00) for each location where such
29 charges are made, and, in addition, a tax upon the gross receipts derived from admission
30 charges ~~in excess of fifty cents (50¢)~~ at the rate of ~~tax levied in Article V, Schedule E, G.S.~~
31 ~~105-164.1 to 105-164.44, upon retail sales of merchandise~~ three percent (3%). The additional
32 tax upon gross receipts shall be levied and collected in accordance with such regulations
33 as may be made by the Secretary of Revenue. No tax shall be levied on admission fees
34 for high school and elementary school contests.

35 Dances and other amusements actually promoted and managed by civic
36 organizations and private and public secondary schools, shall not be subject to the
37 license tax imposed by this section and the first one thousand dollars (\$1,000) of gross
38 receipts derived from such events shall be exempt from the gross receipts tax herein
39 levied when the entire proceeds of such dances or other amusements are used
40 exclusively for the school or civic and charitable purposes of such organizations and not
41 to defray the expenses of the organization conducting such dance or amusement. The
42 mere sponsorship of dance or other amusement by such a school, civic, or fraternal
43 organization shall not be deemed to exempt such dance or other amusement as provided
44 in this paragraph, but the exemption shall apply only when the dance or amusement is

1 actually managed and conducted by the school, civic, or fraternal organization and the
 2 proceeds are used as herein before required.

3 Dances and other amusements promoted and managed by a qualifying corporation
 4 that operates a center for the performing and visual arts are exempt from the license tax
 5 and the gross receipts tax imposed under this section if the dance or other amusement is
 6 held at the center. 'Qualifying corporation' means a corporation that is exempt from
 7 income tax under G.S. 105-130.11(a)(3). 'Center for the performing and visual arts'
 8 means a facility, having a fixed location, that provides space for dramatic performances,
 9 studios, classrooms and similar accommodations to organized arts groups and individual
 10 artists. This exemption shall not apply to athletic events.

11 The license and gross receipts taxes imposed by this section do not apply to a
 12 person, firm, or corporation that is exempt from income tax under Article 4 of this
 13 Chapter and is engaged in the business of operating a teen center. A 'teen center' is a
 14 fixed facility whose primary purpose is to provide recreational activities, dramatic
 15 performances, dances, and other amusements exclusively for teenagers."

16 Sec. 6. G.S. 105-38 reads as rewritten:

17 **"§ 105-38. Amusements – Circuses, menageries, wild west, dog and/or pony shows,**
 18 **etc.**

19 (a) Every person, firm, or corporation engaged in the business of exhibiting
 20 performances, such as a circus, menagerie, wild west show, dog and/or pony show, or
 21 any other show, exhibition or performance similar thereto, not taxed in other sections of
 22 this Article, shall apply for and obtain a State license from the Secretary of Revenue for
 23 the privilege of engaging in such business, and pay for such license ~~the following tax for~~
 24 ~~each day or part of a day: a tax of fifty dollars (\$50.00) for each day or part of a day for~~
 25 each place in the State where exhibitions or performances are to be given.

5 ~~(3)~~ (b) Every person, firm, or corporation by whom any show or exhibition taxed
6 under this section is owned or controlled shall file with the Secretary of Revenue, not
7 less than five days before entering this State for the purpose of such exhibitions or
8 performances therein, a statement, under oath, setting out in detail such information as
9 may be required by the Secretary of Revenue covering the places in the State where
10 exhibitions or performances are to be given, the character of the exhibitions, ~~the mode of~~
11 ~~travel, the number of cars or other conveyances used in transferring such shows,~~ and such
12 other and further information as may be required. Upon receipt of such statement, the
13 Secretary of Revenue shall fix and determine the amount of State license tax with which
14 such person, firm, or corporation is chargeable, shall endorse his findings upon such
15 statement, and shall transmit a copy of such statement and findings to each such person,
16 firm, or corporation to be charged, to the sheriff or tax collector of each county in which
17 exhibitions or performances are to be given, and to the division deputy of the Secretary
18 of Revenue, with full and particular instructions as to the State license tax to be paid.
19 Before giving any of the exhibitions or performances provided for in such statement, the
20 person, firm, or corporation making such statement shall pay the Secretary of Revenue
21 the tax so fixed and determined. If one or more of such exhibitions or performances
22 included in such statement and for which the tax has been paid shall be canceled, the
23 Secretary of Revenue may, upon proper application made to him, refund the tax for such
24 canceled exhibitions or performances. Every such person, firm, or corporation shall give
25 to the Secretary of Revenue a notice of not less than five days before giving any of such
26 exhibitions or performances in each county.

27 (4) (c) The sheriff of each county in which such exhibitions or performances are
28 advertised to be exhibited shall promptly communicate such information to the
29 Secretary of Revenue; and if the statement required in this section has not been filed as
30 provided herein, or not filed in time for certified copies thereof, with proper
31 instructions, to be transmitted to the sheriffs of the several counties and the division
32 ~~deputy, deputy commissioner,~~ the Secretary of Revenue shall cause his division deputy to
33 attend at one or more points in the State where such exhibitions or performances are
34 advertised or expected to exhibit, for the purpose of securing such statement prescribed
35 in this section, of fixing and determining the amount of State license tax with which
36 such person, firm, or corporation is taxable, and to collect such tax or give instructions
37 for the collection of such tax.

38 (5) (d) Every such person, firm, or corporation by whom or which any such
39 exhibition or performance described in this section is given in any county, city or town,
40 or within five miles thereof, wherein is held an annual agricultural fair, during the week
41 of such annual agricultural fair, shall pay a State license of one thousand dollars
42 (\$1,000) for each exhibition or performance in addition to the license tax first levied in
43 this section, to be assessed and collected by the Secretary of Revenue or his duly
44 authorized deputy.

1 ~~(6)~~ (e) The provisions of this section, or any other section of this Article, shall
2 not be construed to allow without the payment of the tax imposed in this section, any
3 exhibition or performance described in this section for charitable, benevolent,
4 educational, or any other purpose whatsoever, by any person, firm, or corporation who
5 is engaged in giving such exhibitions or performances, no matter what terms of contract
6 may be entered into or under what auspices such exhibitions or performances are given.
7 It being the intent and purpose of this section that every person, firm, or corporation
8 who or which is engaged in the business of giving such exhibitions or performances,
9 whether a part or all of the proceeds are for charitable, benevolent, educational, or other
10 purposes or not, shall pay the State license tax imposed in this section.

11 ~~(7)~~ Every such person, firm, or corporation who shall give any such exhibitions
12 or performances mentioned in this section within this State, before the statement
13 provided for has been filed with the Secretary of Revenue, or before the State license
14 tax has been paid, or which shall, after the filing of such statement, give any such
15 exhibitions or performances taxable at a higher rate than the exhibition or performance
16 authorized by the Secretary of Revenue upon the statement filed, shall pay a State
17 license tax of fifty percent (50%) greater than the tax hereinbefore prescribed, to be
18 assessed and collected either by the Secretary of Revenue or by his division deputy.

19 (f) Upon all performances taxable under this section there is levied, in addition
20 to the license tax levied in this section, a tax upon the gross receipts of such business at
21 the rate of ~~tax levied in Schedule E, G.S. 105-164.1 to 105-164.44, upon retail sales of~~
22 ~~merchandise~~ three percent (3%). The license tax herein levied shall be treated as an
23 advance payment of the tax upon gross receipts herein levied, and the license tax shall
24 be applied as a credit upon or advance payment of the gross receipts tax. The Secretary
25 of Revenue may adopt such regulations as may be necessary to effectuate the provisions
26 of this section and shall prescribe the form and character of reports to be made, and
27 shall have such authority of supervision as may be necessary to effectuate the purpose
28 of this Subchapter.

29 ~~(8)~~ (g) In lieu of the tax levied in G.S. 105-86, each circus, or other form of
30 amusement taxed under this section, advertising by means of outdoor advertising
31 displays, a bill posting or as otherwise defined in G.S. 105-86, shall pay a tax of one
32 hundred dollars (\$100.00) for a statewide license for the privilege of advertising in this
33 manner, said tax to be in addition to the other taxes levied in this section.

34 ~~(9)~~ (h) Counties, cities, and towns may levy a license tax on the business taxed
35 under this section not in excess of one half of the license tax levied by the State, but
36 shall not levy a parade tax or a tax under ~~subdivision (8)~~ subsection (h) of this section."

38 **"§ 105-41. Attorneys-at-law and other professionals.**

39 (a) Every practicing attorney-at-law, practicing physician, veterinary, surgeon,
40 osteopath, chiropractor, chiropodist, dentist, oculist, optician, optometrist, any person
41 practicing any professional art of healing for a fee or reward, every practicing
42 professional engineer as defined in Chapter 89C of the General Statutes, every
43 practicing land surveyor as defined in Chapter 89C of the General Statutes, every
44 architect and landscape architect, photographer, canvasser for any photographer, agent

1 of a photographer in transmitting pictures or photographs to be copied, enlarged or
2 colored (including all persons enumerated in this section employed by the State, county,
3 municipality, a corporation, firm or individual), and every person, whether acting as an
4 individual, as a member of a partnership, or as an officer and/or agent of a corporation,
5 who is engaged in the business of selling or offering for sale, buying or offering to buy,
6 negotiating the purchase, sale, or exchange of real estate, or who is engaged in the
7 business of leasing or offering to lease, renting or offering to rent, or of collecting any
8 rents as agent for another for compensation, or who is engaged in the business of
9 soliciting and/or negotiating loans on real estate as agent for another for a commission,
10 brokerage and/or other compensation, shall apply for and obtain from the Secretary of
11 Revenue a statewide license for the privilege of engaging in such business or profession,
12 or the doing of the act named, and shall pay for such license ~~twenty-five dollars (\$25.00):~~
13 fifty dollars (\$50.00); Provided, that no professional man or woman shall be required to
14 pay a privilege tax after he or she has arrived at the age of 75 years. Further provided,
15 that it shall be unlawful for a nonresident of this State to engage in the real estate
16 business in this State, as defined in this section, unless the State of residence of such
17 person will permit a resident of this State to engage in such business. Any person who
18 shall engage in the real estate business in this State in violation of the terms of this
19 provision shall be guilty of a misdemeanor and shall be punished in the discretion of the
20 court; and further provided, that the obtaining of a real estate dealer's license by such
21 person shall not authorize such nonresident to engage in the real estate business in this
22 State, and provided further that in all prosecutions under this section, a certificate under
23 the hand and seal of the Secretary of Revenue that the accused filed no income tax
24 returns with his department for the preceding taxable year shall be prima facie evidence
25 that the accused is a nonresident and that his license is void.

26 (b) Persons practicing the professional art of healing for a fee or reward shall be
27 exempt from the payment of the license tax levied in the preceding paragraph of this
28 section, if such persons are adherents of established churches or religious organizations
29 and confine their healing practice to prayer or spiritual means.

30 (c) Every person engaged in the public practice of accounting as a principal, or as
31 a manager of the business of public accountant, shall pay for such license ~~twenty-five~~
32 ~~dollars (\$25.00),~~ fifty dollars (\$50.00), and in addition shall pay a license of twelve
33 dollars and fifty cents (\$12.50) for each person employed who is engaged in the
34 capacity of supervising or handling the work of auditing, devising or installing systems
35 of accounts.

36 (d) Every licensed mortician or embalmer shall in like manner apply for and
37 obtain from the Secretary of Revenue a statewide license for practicing his profession,
38 whether for himself or in the employ of another, ~~another of ten dollars (\$10.00).~~ and pay
39 for such license a tax of fifty dollars (\$50.00).

40 (e) Licenses issued under this section are issued as personal privilege licenses
41 and shall not be issued in the name of a firm or corporation: Provided, that a licensed
42 photographer having a located place of business in this State, shall be liable for a license
43 tax on each agent or solicitor, employed by him for soliciting business. If any person
44 engages in more than one of the activities for which a privilege tax is levied by this

1 section, such person shall be liable for a privilege tax with respect to each activity
2 engaged in.

20 for each license shall be fifty dollars (\$50.00) and one license shall be obtained for each
21 location at which any of the businesses enumerated in subsection (b) is engaged in;
22 however, only one general business license is required for any one location regardless of
23 how many of the enumerated businesses are being engaged in at that location by the
24 person, firm, or corporation.

25 (b) The general business license shall be procured and the tax paid by the person,
26 firm, or corporation engaged in any one or more of the following business activities:

27 (1) Selling, leasing, furnishing, and/or distributing movies, including
28 video movies, for use in places where no admission fee is charged or
29 in schools, public or private, or other institutions of learning in this
30 State.

31 (2) Selling bicycles, bicycle supplies, or accessories.

32 (3) Selling or renting office machines, home appliances, or burglar alarms,
33 smoke alarms, or other warning devices. As used in this subdivision,
34 the term 'office machine' includes cash registers, typewriters, word
35 processing equipment, addressograph machines, adding machines,
36 bookkeeping machines, calculators, billing machines, check writing
37 machines, copying machines, dictating equipment, and data processing
38 equipment. As used in this subdivision, the term 'home appliances'
39 includes washing machines, clothes dryers, refrigerators, freezers,
40 vacuum cleaners, air conditioning units other than permanently
41 installed units using internal ductwork, and sewing machines.

42 (4) Operating a campground, trailer park, tent camping area, or similar
43 place for profit, advertising in any manner for transient patronage, or

- 1 soliciting such business, regardless of whether the rental to patrons is
2 on a daily, weekly, biweekly or monthly basis.
- 3 (5) Operating billiard or pool tables, whether operated by slot or
4 otherwise.
- 5 (6) Operating a bowling alley, or alleys of like kind.
- 6 (7) Selling sandwiches (such term not to be construed to include crackers
7 or cookies in combination with any food filling) in drug stores or any
8 other stands or places not operating as a restaurant; operating,
9 maintaining or placing on location fewer than five cigarette or other
10 tobacco products dispensers, soft drink dispensers, food or other
11 merchandising dispensers, or weighing machines; retailing soft drinks;
12 or retailing or jobbing cigarettes or any other tobacco products.
- 13 (8) Operating a bagatelle table, merry-go-round, other riding device,
14 hobbyhorse, switchback railway, shooting gallery, swimming pool,
15 skating rink, other amusement of a like kind, or a place for other
16 games or play with or without name (unless used solely and
17 exclusively for private amusement or exercise) at a permanent
18 location.
- 19 (9) Selling, offering, ordering for sale, repairing, or servicing pianos,
20 organs, record players, records, tape players, tape cartridges designed
21 for use in tape players, television sets, television accessories or repair
22 parts, radios, or radio accessories or repair parts, including radios
23 designed for exclusive use in motor vehicles.
- 24 (10) Manufacturing ice cream using freezer equipment and selling the ice
25 cream at retail; and selling at retail ice cream purchased from a
26 manufacturer other than a manufacturer who has paid the tax imposed
27 in G.S. 105-97(a). For the purpose of this subdivision, 'ice cream'
28 means ice cream, frozen custards, sherbets, water ices, yogurt, and/or
29 similar frozen products.
- 30 (c) Where applicable, the chain store license tax levied in G.S. 105-98 shall be in
31 addition to the general business license tax levied in subsection (a).
- 32 (d) Exemptions.
- 33 (1) A person, firm, or corporation required to be licensed under G.S. 105-
34 36.1, 105-37, 105-62, 105-65.1, 105-74, 105-85, 105-89, or 105-89.1
35 is not required to procure for the same location the general business
36 license imposed by this section.
- 37 (2) The tax levied on the businesses described in subdivisions (5) and (6)
38 of subsection (b) of this section does not apply to fraternal
39 organizations having a national charter, American Legion Posts, posts
40 or other local organizations of other veterans' organizations chartered
41 by Congress or organized and operating on a statewide or nationwide
42 basis, Young Men's Christian Associations, Young Women's Christian
43 Associations, or nonstock, nonprofit charitable recreational

1 corporations, foundations, or centers to which a municipality or county
2 contributes any portion of the operating expense.

3 (3) The tax levied on the businesses described in subdivision (7) of
4 subsection (b) of this section does not apply to the sale, through
5 dispensers or otherwise, of milk, milk drinks, dairy products, or
6 newspapers, or to dispensers dispensing merchandise for five cents
7 (5¢) or less.

8 (4) The tax levied on the businesses described in subdivision (8) of
9 subsection (b) of this section does not apply to machines and devices
10 licensed under G.S. 105-65 or G.S. 105-66.1. An organization
11 obtaining a license under G.S. 14-309.7 is not required to obtain a
12 license under subdivision (8) of subsection (b) of this section, but is
13 subject to subsection (e) of this section as if a State license were
14 required.

15 (5) A person, firm, or corporation licensed under this section to conduct a
16 business described in subdivision (9) of subsection (b) is not required
17 to procure a license under G.S. 105-89 by reason of being engaged in
18 the business of selling, installing, or servicing motor vehicle radios.

19 (e) Local Licenses. For the businesses described under subdivisions (1) through
20 (4), (7), (9), and (10) of subsection (b) of this section, counties may not levy a license
21 tax. For the businesses described under subdivision (5) of this section, counties may
22 levy on each business located outside of cities a license tax not in excess of twenty-five
23 dollars (\$25.00). For the businesses described under subdivision (6), counties may levy
24 on each business located outside of cities a license tax not in excess of ten dollars
25 (\$10.00) per alley kept or maintained. For the businesses described under subdivision
26 (8), counties may levy on each business located outside of cities a license tax not in
27 excess of twenty-five dollars (\$25.00).

28 Cities may not levy a license tax on the businesses described under subdivision (3)
29 of subsection (b) of this section. Cities may levy on each of the businesses
30 described in subdivisions (1), (2), (5), and (8) a license tax not in excess of twenty-five
31 dollars (\$25.00); on the businesses described in subdivision (4), cities may levy a
32 license tax not in excess of twelve dollars and fifty cents (\$12.50); on the businesses
33 described in subdivision (6), cities may levy a license tax not in excess of ten dollars
34 (\$10.00) per alley kept or maintained; on the businesses described in subdivision (9),
35 cities may levy a license tax not in excess of five dollars (\$5.00); on the businesses
36 described in subdivision (7), cities may levy a license tax not in excess of four dollars
37 (\$4.00); and on the businesses described in subdivision (10), cities may levy a license
38 tax not in excess of two dollars and fifty cents (\$2.50).

39 Counties and cities may not levy a license tax under this section on a person, firm, or
40 corporation required to be licensed under G.S. 105-65.1."
