A BILL TO BE ENTITLED

1 AN ACT TO PROVIDE FUNDS TO QUALIFYING NORTH CAROLINA A&T
2 GRADUATES WHO ENTER GRADUATE ARCHITECTURE PROGRAMS AT
3 NORTH CAROLINA STATE UNVIERSITY.

5 The General Assembly of North Carolina enacts:

6 Section 1. There is appropriated from the General Fund to the Board of
7 Governors of The University of North Carolina the sum of fifteen thousand dollars
8 (\$15,000) for the 1989-90 fiscal year, and the sum of thirty thousand dollars (\$30,000)
9 for the 1990-91 fiscal year, to provide scholarship funds for qualified graduates of North
10 Carolina Agricultural and Technical State University who enter graduate study
11 programs in architecture at North Carolina State University. The funds appropriated
12 under this section shall be allocated as follows: the sum of five thousand dollars
13 (\$5,000) for each of three qualified students in fiscal year 1989-90, and the sum of five
14 thousand dollars (\$5,000) for each of six qualified students in fiscal year 1990-91.
15 Funds appropriated under this section shall be limited to a maximum of three students
16 entering the first year of the graduate program per year. If less than three students enter
17 the program at the first year level in either of the fiscal years of this biennium, the
18 unused funds shall revert to the General Fund.

19 Sec. 2. Students eligible for scholarship funds under this act shall either (i)
20 have been a resident of North Carolina at the time the student entered North Carolina
21 Agricultural and Technical State University, or (ii) if the student was not a resident of
22 North Carolina at the time the student entered North Carolina Agricultural and
23 Technical State University, eligibility for scholarship funds under this act shall be
24 conditioned upon the student's agreement to work in North Carolina for at least three

1 years following the student's graduation from the graduate program. If the nonresident
2 qualifying student fails to complete three years of work in North Carolina following
3 graduation from the graduate program, the student shall repay the scholarship funds he
4 received, such repayment to be calculated on the following basis: if the student
5 completes two years of work following graduation, the student shall repay one-half of
6 the scholarship funds received by the student; if the student completes less than two
7 years of work in North Carolina, the student shall repay the entire amount of scholarship
8 funds received by the student.

9 Sec. 3. The Board of Governors of The University of North Carolina shall
10 promulgate the rules necessary to carry out the provisions of this act.

11 Sec. 4. This act shall become effective July 1, 1989.
