 3 HOUSE DISTRICT FOR LOCAL PUBLIC PURPOSES, PROJECTS,
- 4 PROGRAMS, AND SERVICES.
- 5 The General Assembly of North Carolina enacts:

6 Section 1. There is appropriated from the General Fund to Wesley Hall of 7 Alamance, Inc., \$5,000 for the 1989-90 fiscal year for operating expenses to enable the 8 continued drug addiction treatment of Alamance, Rockingham, Caswell, and other area 9 patients.

10 Sec. 2. There is appropriated from the General Fund to Alamance County 11 \$5,000 for the 1989-90 fiscal year for operating support for Alamance County 12 restitution programs for juvenile, undisciplined, and delinquent children (Friends of 13 Youth).

14 Sec. 3. There is appropriated from the General Fund to the Alamance County 15 Historical Museum, Inc., \$5,000 for the 1989-90 fiscal year for continued operations or 16 capital improvements.

17 Sec. 4. There is appropriated from the General Fund to the Alamance County 18 Council on Elderly Services and Support, Inc., \$5,000 for the 1989-90 fiscal year to 19 help meet ongoing meals on wheels services to provide hot and frozen meals to the 20 home bound elderly in Alamance County.

21 Sec. 5. There is appropriated from the General Fund to the Friendship Center 22 of Alamance, Inc., \$5,000, for the 1989-90 fiscal year for expansion of the day care and

respite services for persons suffering from Alzheimer's and other memory impairing 1 2 diseases. 3 Sec. 6. There is appropriated from the General Fund to the Swepsonville 4 Sanitary District \$5,000 for the 1989-90 fiscal year for operational expenses. 5 Sec. 7. There is appropriated from the General Fund to the Snow Camp Historical Drama Society, Inc., \$5,000 for the 1989-90 fiscal year for operating 6 7 expenses for the outdoor drama, "Sword of Peace", in Alamance County. 8 Sec. 8. There is appropriated from the General Fund to the Rockingham 9 County Historical Society, Incorporated, \$5,000 for the 1989-90 fiscal year for 10 operating expenses and capital expenditures. Sec. 9. There is appropriated from the General Fund to the Madison Colored 11 12 and Charles Drew Alumni Association, Inc., \$5,000 for the 1989-90 fiscal year for 13 renovation of the old Madison Colored School to be used as a community center for 14 youth and public groups. 15 Sec. 10. There is appropriated from the General Fund to REMMSCO, Inc., 16 \$5,000 for the 1989-90 fiscal year for an Alcoholic's Half-Way House for Rockingham 17 County. 18 Sec. 11. There is appropriated from the General Fund to the Rockingham 19 Council on Mental Retardation, Inc., \$5,000 for the 1989-90 fiscal year for operating 20 expenses and capital expenditures. 21 Sec. 12. There is appropriated from the General Fund to the Rockingham 22 County Public Library \$5,000 for the 1989-90 fiscal year for the Genealogy Department 23 of the Madison Branch Library to be used to add new machines and additional shelving 24 and to buy genealogy books as they become available. 25 Sec. 13. There is appropriated from the General Fund to the Volunteer Fire Departments serving the Sandy Ridge, Pinehall, and Mitchell Election Precincts of 26 27 Stokes County \$5,000 for the 1989-90 fiscal year for operating expenses and capital 28 expenditures. 29 Sec. 14. This act shall become effective July 1, 1989.
