A BILL TO BE ENTITLED

1 AN ACT TO AUTHORIZE THE CITY OF RALEIGH TO REGULATE
2 STORMWATER.

4 The General Assembly of North Carolina enacts:

5 Section 1. The governing body of the City of Raleigh may adopt such
6 ordinances as it deems appropriate to regulate stormwater, by requiring the submission
7 of plans in order to control stormwater from the site of any construction, landscaping,
8 clearing projects or any other project which in any manner alters the natural structure of
9 the land mass within said City of Raleigh and its extraterritorial planning jurisdiction,
10 provided however, that such ordinance shall not be applicable to land-disturbing
11 activities that are listed in G.S. 113A-56. The governing body of the City may establish
12 by ordinance a program of regulations whereby prior to any land disturbing activity
13 within the City of Raleigh and its extraterritorial planning jurisdiction, a permit must be
14 obtained in the manner prescribed by the ordinance, and in accordance with the criteria
15 and standards as established by the governing board.

16 The ordinance may provide that in lieu of the required improvements shown
17 on the plan, a developer may be required to provide funds that the City may use for the
18 construction of devices, structures, drainage easements, and impoundments to control
19 stormwater within the drainage basin; these funds may be used to serve more than one
20 site or development within the area. Any formula adopted to determine the amount of
21 funds the developer is to pay in lieu of required improvements, shall be based on either
22 impervious surfaces of the site or quantity of stormwater generated from the surfaces of
23 the site or quantity of stormwater generated from the site. The ordinance may require a

1 combination of partial payment of funds and partial construction when the governing
2 body of the City determines that a combination is in the best interest of the citizens of
3 the area to be served.

4 Sec. 2. This act is effective upon ratification.
