1 A BILL TO BE ENTITLED
2 AN ACT TO INCREASE THE FEE FOR FILING A CORPORATION'S ANNUAL
3 REPORT WITH THE SECRETARY OF STATE.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 55-1-22, as enacted by Chapter 265 of the 1989 Session Laws
6 and amended by Chapter 714 of the 1989 Session Laws, reads as rewritten:

7 "§ 55-1-22. Filing, service, and copying fees.

8 (a) The Secretary of State shall collect the following fees when the documents
9 described in this subsection are delivered to him for filing:

Rows include: (1) Articles of incorporation \$100.00, (2) Application for reserved name 10.00, (3) Notice of transfer of reserved name 10.00, (4) Application for registered name 10.00, (5) Application for renewal of registered name 10.00, (6) Corporation's statement of change of registered agent or registered office or both 5.00, (7) Agent's statement of change of registered office for each affected corporation 5.00, (8) Agent's statement of resignation No fee.

31 (b) The Secretary of State shall collect a fee of ten dollars (\$10.00) each time
32 process is served on him under this act. The party to a proceeding causing service of
33 process is entitled to recover this fee as costs if he prevails in the proceeding.

34 (c) The Secretary of State shall collect the following fees for copying and
35 certifying the copy of any filed document relating to a domestic or foreign corporation:

- 36 (1) Fifty cents (\$.50) a page for copying; and
37 (2) Five dollars (\$5.00) for the certificate."
