A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR VARIOUS STATEWIDE PROJECTS.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources, Division of Maternal and Child Health, the sum of \$150,000 for the 1990-91 fiscal year for sickle cell and genetic counseling. Of these funds, the sum of \$50,000 shall be used for fetus neural tube defect testing of pregnant women who are not eligible for Medicaid and \$100,000 shall be used for contract funding of sickle cell centers.

- Sec. 2. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources, Division of Maternal and Child Health, the sum of \$50,000 for the 1990-91 fiscal year for diagnostic and laboratory tests for pregnant women who are not eligible for Medicaid.
- Sec. 3. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources, Division of Epidemiology, the sum of \$78,399 for the 1990-91 fiscal year for an industrial hygiene consultant and a clerk typist to provide service to industry in evaluating hazardous conditions and recommending solutions and improvements for the prevention of occupational disease.
- Sec. 4. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources, the sum of \$289,407 for the 1990-91 fiscal year for Health Aid to Counties.
- Sec. 5. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources, Division of Adult Health, the sum of \$459,335 for the 1990-91 fiscal year for the health promotion and disease prevention

- program, hypertension and arthritis contracts and funding to counties, migrant health care, epilepsy services, and in-home health care and cancer services.
- Sec. 6. There is appropriated from the General Fund to the Department of Human Resources, Division of Social Services, the sum of \$493,865 for the 1990-91 fiscal year to provide funds for unexpected crises in and some expansion of child welfare services.
- Sec. 7. There is appropriated from the General Fund to the Department of Human Resources, Division of Social Services, the sum of \$348,997 for the 1990-91 fiscal year for AFDC-Emergency Assistance.
- Sec. 8. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of \$500,000 for the 1990-91 fiscal year for need-based scholarships.
- Sec. 9. This act shall become effective July 1, 1990.
