2 AN ACT TO CODIFY THE JOINT RESOLUTION ACCEPTING PROPERTIES IN 3 THE STATE NATURE AND HISTORIC PRESERVE, TO REMOVE CERTAIN LAND FROM JOCKEY'S RIDGE STATE PARK AND MORROW MOUNTAIN 4 STATE PARK FROM THE STATE NATURE AND HISTORIC PRESERVE, 5 AND TO REPEAL TWO STATUTES CONCERNING THAT PRESERVE. 6 Whereas, Article XIV, Section 5 of the North Carolina Constitution 7 authorizes the dedication of State and local government properties as part of the State 8 9 Nature and Historic Preserve, upon acceptance by resolution adopted by a vote of threefifths of the members of each house of the General Assembly and removal of properties 10 from that Preserve by law adopted by three-fifths of the members of each house of the 11 12 General Assembly; Now, therefore, The General Assembly of North Carolina enacts: 13 14 Section 1. The Attorney General's Division of Legislative Drafting and Codification of Statutes is directed to recodify any joint resolution dedicating properties 15 to the State Nature and Historic Preserve adopted by the General Assembly, pursuant to 16 Article XIV of the State Constitution, as an amendment of or a replacement for G.S. 17 18 143-260.10. 19 Sec. 2. The following parcels or tracts of land are removed, pursuant to 20 Article XIV (5) of the State Constitution, from the State Nature and Historic Preserve: 21 That certain tract or parcel of land at Jockey's Ridge State Park in Dare (1)County, Nags Head Township more particularly described as follows: 22 BEGINNING at a point which is located north 39° 07' 08"67.86 feet 23
