## A BILL TO BE ENTITLED

1	A BILL TO BE ENTITLED
2	AN ACT TO LEVY A TEMPORARY INCOME TAX SURTAX ON INDIVIDUALS
3	TO RAISE REVENUE FOR EDUCATION.
4	The General Assembly of North Carolina enacts:
5	Section 1. Division II of Article 4 of Chapter 105 of the General Statutes is
6	amended by adding a new section to read:
7	"§ 105-134.2A. Temporary income tax surtax.
8	(a) Tax. In addition to the income tax imposed by G.S. 105-134.2, every taxpayer
9	required to file a return under this Division shall pay an income tax surtax equal to three
10	percent (3%) of the tax payable by the taxpayer under G.S. 105-134.2 for the taxable
11	year. This surtax is due at the time prescribed for filing income tax returns in G.S. 105-
12	<u>155.</u>
13	(b) Purpose. The purpose of the surtax imposed by this section is to provide
14	revenue for education. The revenue generated by this surtax shall be appropriated
15	annually only for public schools, community colleges, and The University of North
16	Carolina system."
17	Sec. 2. Notwithstanding G.S. 105-163.15, no addition to tax may be made
18	under that statute for a taxable year beginning on or after January 1, 1991, and before
19	January 1, 1992, with respect to an underpayment of individual income tax to the extent
20	the underpayment was created or increased by this act.
21	Sec. 3. This act is effective for taxable years beginning on or after January 1,
22	1991, and expires for taxable years beginning on or after January 1, 1993.
