1 A BILL TO BE ENTITLED
2 AN ACT TO ESTABLISH SENATORIAL DISTRICTS AND TO APPORTION
3 SEATS IN THE SENATE AMONG DISTRICTS.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 120-1 reads as rewritten:

6 "§ 120-1. Senators.

7 (a) For the purpose of nominating and electing members of the Senate in 1984
8 1992 and every two years thereafter, senatorial districts are established and seats in the
9 Senate are apportioned among those districts so that each District elects one Senator,
10 except that Districts 12, 13, 14, 16, 17, 20, 27, and 28 each elects two Senators, and the
11 composition of each district is as follows:
