BILL SUMMARY: Reference previous fiscal note prepared by Ruth Sappie on July 16, 1992 (attached) on SB 971 (Third Edition), Subject: Railroad Transfer, introduced by Senators Lee, Daughtry, and Block.

No change has been made to previous fiscal note except as noted below:

House Appropriations Committee amended HB 1447 to make April 1, 1993 the effective date of the Rail Safety Program transfer from the Utilities Commission to the Department of Transportation. This delay will reduce the expenditure requirement in 92-93 of \$189,000 from the Highway Fund noted in the previous fiscal note to \$47,250 from the Highway Fund in 92-93. The amendment further amends the current operations bill for 92-93 and appropriates \$47,250 in 92-93 from the Highway Fund and specified a further reduction in the Equipment Fund of the same amount to cover this program transfer for the last quarter of the 92-93 fiscal year. Previously, the bill did not state from where funds would come to support this program transfer, and if enacted in that manner, would have placed the Highway Fund out-of-balance.
