A BILL TO BE ENTITLED

1 AN ACT TO AUTHORIZE THE CONSTRUCTION AND THE FINANCING,
2 WITHOUT APPROPRIATIONS FROM THE GENERAL FUND, OF CERTAIN
3 CAPITAL IMPROVEMENTS PROJECTS, OR SUPPLEMENTS TO CAPITAL
4 IMPROVEMENTS PROJECTS, OF THE CONSTITUENT INSTITUTIONS OF
5 THE UNIVERSITY OF NORTH CAROLINA AND THE UNIVERSITY OF
6 NORTH CAROLINA HOSPITALS AT CHAPEL HILL.

7 The General Assembly of North Carolina enacts:

8 Section 1. The purpose of this act is to authorize construction by certain
9 constituent institutions of The University of North Carolina and the University of North
10 Carolina Hospitals at Chapel Hill, of the capital improvements projects, or supplements
11 to capital improvements projects, listed in this act for the respective institutions, and
12 authorize the financing of these projects or project supplements with funds available to
13 the institutions from gifts, grants, receipts, including patient receipts at the University of
14 North Carolina Hospitals at Chapel Hill, self-liquidating indebtedness, or other funds, or
15 any combination of these funds, but not including funds appropriated from the General
16 Fund of the State.

17 Sec. 2. The capital improvements projects authorized by this act to be
18 constructed and financed as provided in Section 1 of this act are as follows:

- 5 Women's Hospital, and Support Space 133,870,800

6 Sec. 3. The supplements to capital improvements projects authorized by this
7 act to be constructed and financed as provided in Section 1 of this act are as follows.
8 These projects were partially financed through proceeds available from the Education,
9 Clean Water, and Parks Bond Act of 1993 and through appropriations of the General
10 Assembly in a prior session.

- 12 a. Chidley Hall Complex \$ 4,690,200
- 13 2. The University of North Carolina at Chapel Hill
- 14 a. Addition to the School of Dentistry 8,430,500

19 Sec. 4. At the request of the Board of Governors of The University of North
20 Carolina and upon determining that it is in the best interest of the State to do so, the
21 Director of the Budget may authorize an increase or decrease in the scope of or a change
22 in the method of funding for any project or project supplement authorized by this act.
23 In making a determination of whether to authorize a change in scope or funding, the
24 Director of the Budget may consult with the Advisory Budget Commission. In no event
25 may appropriations from the General Fund be used for a project authorized by this act,
26 except for appropriations made by the General Assembly in a prior session.

27 Sec. 5. This act is effective upon ratification.
