A BILL TO BE ENTITLED

AN ACT TO PROMOTE THE CREATION OF HEALTH PLAN PURCHASING ALLIANCES TO PROVIDE ACCESS TO HEALTH BENEFITS FOR EMPLOYEES OF SMALL EMPLOYER GROUPS AND SELF-EMPLOYED INDIVIDUALS.

The General Assembly of North Carolina enacts:

Section 1. Chapter 143 of the General Statutes is amended by adding a new Article to read:

"ARTICLE 64.

"HEALTH CARE PURCHASING ALLIANCE ACT.

"§ 143-591. Purpose and intent.

The purpose and intent of this Article is to increase the affordability, efficiency, and fairness of health coverage for small employers.

The Article promotes the development of voluntary purchasing Alliances to provide affordable health care coverage for self-employed individuals and employees of participating small employers in the manner of large employer groups. The Alliances will allow members to benefit from the contracting expertise and the administrative savings that can result from the pooling of small employers and self-employed individuals.

These Alliances will make available through their contracting processes a choice of Accountable Health Carriers that arrange for quality health services in a cost-effective manner. The Article establishes rules for fair competition among competing

1 Accountable Health Carriers. These rules include the offering of comparable benefits
2 by competing Accountable Health Carriers, risk assessment, and risk adjustment to
3 assure competition based on a fair allocation of risk among Accountable Health
4 Carriers, and the providing of data that measures clinical outcomes and other valid areas
5 of Accountable Health Carrier performance.

6 Carriers throughout the health coverage market for small employers are required to
7 use adjusted community rating, guarantee the continuity of coverage, adhere to
8 limitations on the use of preexisting conditions, abolish individual medical
9 underwriting, and follow rules limiting the use of participation requirements.

10 **"§ 143-592. Definitions.**

11 As used in this Article:

- 12 (1) 'Accountable Health Carrier' means a carrier registered with the Board
13 pursuant to G.S. 143-596.
- 14 (2) 'Adjusted community rating' means a method used to develop carrier
15 premiums which spreads financial risk across a large population and
16 allows adjustments only for the following demographic factors: age,
17 gender, number of family members covered, and geographic areas, as
18 determined pursuant to G. S. 58-50-130(b).
- 19 (3) 'Alliance' means a State-chartered, nonprofit organization that provides
20 health insurance purchasing services to member small employers in a
21 market area regarding qualified health care plans offered by
22 Accountable Health Carriers established pursuant to G.S. 143-599.
- 23 (4) 'Alliance Board' means the Alliance Board of Directors for a market
24 area established pursuant to G.S. 143-597.
- 25 (5) 'Antitrust laws' means federal and State laws intended to protect
26 commerce from unlawful restraints, monopolies, and unfair business
27 practices.
- 28 (6) 'Board' means the State Health Plan Purchasing Alliance Board.
- 29 (7) 'Carrier' means that as defined in G.S. 58-50-110(5).
- 30 (8) 'Community sponsor' means an organization that assumes
31 responsibility for serving as the host for an Alliance in a market area.
- 32 (9) 'Dependent' means that as defined in G.S. 58-50-110(9).
- 33 (10) 'Eligible employee' means that as defined in G.S. 58-50-110(10).
- 34 (11) 'Employee enrollee' means an eligible employee or dependent of an
35 eligible employee who is enrolled in a qualified health care plan.
- 36 (12) 'Fund' means the State Health Plan Purchasing Alliance Fund
37 established under G.S. 143-605.
- 38 (13) 'Grievance procedure' means an established set of rules that specify a
39 process for appeal of an organizational decision.
- 40 (14) 'Health benefit plan' means that as defined in G.S. 58-50-110(11).
- 41 (15) 'Late enrollee' means an eligible employee or a dependent of an
42 eligible employee who requests enrollment in a qualified health care
43 plan after the initial enrollment period for a member small employer,
44 provided the enrollment is consistent with the Alliance's rules for

1 initial enrollment and provided that the initial enrollment period shall
2 extend for at least 30 consecutive calendar days. However, an eligible
3 employee or dependent shall not be considered a late enrollee if:

4 a. The individual was covered under a public or private health
5 benefit plan that provided at least the minimum level of benefits
6 in qualified health care plans established pursuant to G.S. 58-
7 50-120 at the time the individual was eligible to enroll and
8 either:

9 1. Lost coverage under another health plan as a result of
10 termination of employment, the termination of coverage
11 under another health plan, or the death of a spouse or
12 divorce and requests enrollment in a qualified health care
13 plan within 30 days after termination of coverage; or

14 2. Stated, in writing, during the enrollment period that
15 coverage under another employer's health benefit plan
16 was the reason for declining coverage;

17 b. The individual elects a different health plan offered through an
18 Alliance during an open enrollment period;

19 c. An eligible employee requests enrollment within 30 days of
20 becoming an employee of a member small employer;

21 d. A court has ordered that coverage be provided for a spouse or
22 minor child under a covered employee's health benefit plan and
23 the request for enrollment is made within 30 days after issuance
24 of the court order; or

25 e. The individual or employee enrollee makes a request for
26 enrollment of the spouse or child within 30 days of his or her
27 marriage or the birth or adoption of a child.

28 (16) 'Lowest cost plan' means the lowest cost qualified health care plan
29 selected by a member small employer and offered to the employer's
30 employee enrollees.

31 (17) 'Market area' means a clearly defined, nonoverlapping, and exclusive
32 geographical area determined by the Board for the purpose of defining
33 the region in which an Alliance shall operate.

34 (18) 'Member small employer' means a small employer who enrolls in an
35 Alliance.

36 (19) 'Preexisting condition provision' means that as defined in G.S. 58-50-
37 110(17).

38 (20) 'Premium' means that as defined in G.S. 58-50-110(18).

39 (21) 'Qualified health care plans' means the basic or standard health care
40 plans offered by an Accountable Health Carrier to member small
41 employers and as authorized by the Small Employer Carrier
42 Committee pursuant to G.S. 58-50-120.

43 (22) 'Risk adjustment mechanism' means the process established pursuant
44 to G.S. 143-603.

1 (23) 'Self-employed individual' means that as defined in G.S. 58-50-
2 110(21a).

3 (24) 'Service area' means a geographic region in which a carrier is licensed
4 to operate.

5 (25) 'Small employer' means that as defined in G.S. 58-50-110(22).

6 **"§ 143-593. Health benefit plans subject to Article.**

7 A health benefit plan is subject to this Article if it provides health benefits for small
8 employers and if any of the following conditions are met:

9 (1) Any part of the premiums or benefits is paid by a small employer, or
10 any covered individual is reimbursed, whether through wage or
11 adjustments or otherwise, by a small employer for any portion of the
12 premium;

13 (2) The health benefit plan is treated by the employer or any of the
14 covered self-employed individuals as part of a plan or program for the
15 purposes of Sections 106, 125, or 162 of the United States Internal
16 Revenue Code; or

17 (3) The small employer has permitted payroll deductions for the eligible
18 enrollees for the health benefit plans.

19 **"§ 143-594. Jurisdiction of the Department of Insurance.**

20 Nothing in this Article shall be deemed to be in conflict with or in limitation of the
21 duties and powers granted to the Commissioner of Insurance under Chapter 58 of the
22 General Statutes. The Board and Alliances established under this Article shall bring to
23 the attention of the Department of Insurance any suspected or alleged violations of this
24 Article.

25 **"§ 143-595. Establishment of the Board; membership; terms; personnel.**

26 (a) There is established the State Health Plan Purchasing Alliance Board. The
27 Board shall be established within the Department of Administration for administrative,
28 organizational, and budgetary purposes only. The Department of Administration shall
29 provide administrative and staff support to the Board. The Department of Insurance
30 shall provide technical assistance as requested by the Board.

31 (b) The Board shall consist of 11 members, as follows:

32 (1) Three appointed by the Governor, at least one of whom shall be an
33 owner or manager of a member small employer of an Alliance
34 operating in North Carolina; and at least one of whom shall be an
35 employee enrollee of an Alliance operating in North Carolina;

36 (2) Three appointed by the General Assembly upon the recommendation
37 of the Speaker of the House of Representatives, in accordance with
38 G.S. 120-121, at least one of whom shall be an owner or manager of a
39 member small employer of an Alliance operating in North Carolina;
40 and at least one of whom shall be an employee enrollee of an Alliance
41 operating in North Carolina;

42 (3) Three appointed by the General Assembly upon the recommendation
43 of the President Pro Tempore of the Senate in accordance with G.S.
44 120-121, at least one of whom shall be an owner or manager of a

1 member small employer of an Alliance operating in North Carolina;
2 and at least one of whom shall be an employee enrollee of an Alliance
3 operating in North Carolina;

4 (4) The Lieutenant Governor or his or her representative; and

5 (5) The Commissioner of Insurance or his or her representative.

6 (c) Members of the Board who are not officers or employees of the State shall
7 receive compensation of two hundred dollars (\$200.00) for each day or part of a day of
8 service plus reimbursement for travel and subsistence expenses at the rates specified in
9 G.S. 138-5. Members of the Board who are officers or employees of the State shall
10 receive reimbursement for travel and subsistence at the rates specified in G.S. 138-6.

11 (d) Appointed members shall serve for four-year terms except that the initial
12 terms of:

13 (1) Two members appointed by the Governor, two members appointed by
14 the General Assembly upon the recommendation of the President Pro
15 Tempore of the Senate, and one member appointed by the General
16 Assembly upon the recommendation of the Speaker of the House of
17 Representatives, shall expire January 1, 1995; and

18 (2) One member appointed by the Governor, one member appointed by
19 the General Assembly upon the recommendation of the President Pro
20 Tempore of the Senate, and two members appointed by the General
21 Assembly upon the recommendation of the Speaker of the House of
22 Representatives, shall expire January 1, 1997.

23 (e) At the end of a term, a member shall continue to serve until a successor is
24 appointed. A member who is appointed after a term has begun serves only for the
25 remainder of the term and until a successor is appointed. A member who serves two
26 consecutive full four-year terms shall not be reappointed until four years after
27 completion of those terms. A vacancy in a legislative appointment shall be filled in
28 accordance with G.S. 120-122.

29 (f) The Board shall elect officers biennially. Officers shall serve no more than
30 two consecutive terms in an office.

31 (g) The Board shall appoint an executive director who shall serve at the pleasure
32 of the Board. The executive director shall administer the affairs of the Board. The
33 executive director may employ and direct staff necessary to carry out the provisions of
34 this Article. Staff of the Board shall be covered under the State Personnel Act.

35 (h) The Board shall meet as needed at the times and places it determines. Such
36 meetings and procedures shall be governed by the procedures and policies set forth in
37 the North Carolina Open Meetings Law, Article 33C of Chapter 143 of the General
38 Statutes. A majority of the fully authorized membership of the Board is a quorum.

39 (i) No Board members or their spouses shall be employed by, affiliated with an
40 agent of, or otherwise a representative of any carrier or health care provider.

41 (j) No individual shall be appointed to or remain a member of the Board if the
42 individual, the individual's spouse, or the individual and spouse together, held securities
43 or are otherwise the beneficiaries of securities worth ten thousand dollars (\$10,000) or
44 more at fair market value as of December 31 of the preceding year in a single health

1 care business or aggregated among multiple health care businesses. For the purposes of
2 this subsection, the term, 'health care business':

- 3 (1) Includes an association, corporation, enterprise, joint venture,
4 organization, partnership, proprietorship, trust, and every other
5 business interest that provides or insures human health care.
6 (2) Does not include a widely held investment fund, regulated investment
7 company, or pension or deferred compensation plan if neither the
8 individual nor the individual's spouse has the ability to exercise control
9 over the financial interests held by the fund.

10 **"§ 143-596. Duties of the Board.**

11 The Board shall:

- 12 (1) Establish no less than four and no more than 12 market areas in this
13 State. In establishing such market areas, the Board shall ensure that
14 every location is a part of a market area. To the largest extent
15 possible, the Board should consider metropolitan standard areas and
16 other existing markets. The Board may redefine market areas where it
17 determines there will be insufficient numbers of enrollees, health care
18 providers, or qualifying Accountable Health Carriers to make such
19 requirements feasible. Any such modifications are subject to annual
20 review by the Board.
21 (2) Accept applications by carriers to qualify as Accountable Health
22 Carriers, determine the eligibility of carriers to become Accountable
23 Health Carriers according to criteria described in G.S. 143-599, and
24 designate carriers as Accountable Health Carriers.
25 (3) Establish Alliances with community sponsors pursuant to G.S. 143-
26 597 for each market area determined by the Board.
27 (4) Conduct annual reviews of the performance of each Alliance to ensure
28 that the Alliance is in compliance with this Article. To assist the
29 Board in its review, each Alliance shall submit data to the Board
30 quarterly including, but not limited to, employer enrollment by
31 employer size; industry sector; previous insurance status and number
32 of employees within each insurance status; number of total eligible
33 employers in the market area participating in the Alliance; number of
34 insured lives by county and insured category, including employees,
35 dependents and other insured categories, represented by Alliance
36 members; profiles of potential employer membership by county;
37 premium ranges for each qualified health care plan for Alliance
38 member categories; type and resolution of member grievances;
39 surcharges; and Alliance financial statements. A summary of this
40 annual review shall be provided to the General Assembly and each
41 Alliance.
42 (5) Develop standard enrollment procedures to be used in enrolling small
43 employers and their eligible employees.

- 1 (6) Establish conditions of participation for small employers and self-
2 employed individuals which shall conform to the requirements of this
3 Article and G. S. 58-50-125(d) and include, but not be limited to, the
4 following:
5 a. Assurances that the member small employer is a valid small
6 employer group and is not formed for the purpose of securing
7 health benefits coverage. This assurance must include
8 requirements that sole proprietors and self-employed
9 individuals have been in business for a reasonable period of
10 time as established by the Board, have provided filings to verify
11 employment status, and have provided other evidence, in the
12 Board's discretion, to ensure that the individual is working;
13 b. A member small employer who opts to pay eighty percent
14 (80%) or more of the cost of coverage may choose to offer a
15 single qualified health care plan to its eligible employees.
16 Eligible employees of other member small employers shall have
17 the choice of at least two qualified health care plans. All
18 member small employers may offer the qualified health care
19 plans of more than one Accountable Health Carrier. The Board
20 and Alliances shall encourage all member small employers to
21 consider offering more than one Accountable Health Carrier;
22 c. Minimum employer contribution requirements that shall be an
23 amount not less than fifty percent (50%) of the premium for an
24 employee's coverage of the lowest cost plan. The Alliance shall
25 require that the employer contribute the same dollar amount for
26 each employee regardless of the qualified health care plan
27 chosen by the employee;
28 d. A mechanism that will provide for participation if an employer
29 chooses not to participate but one hundred percent (100%) of
30 the eligible employees who are not covered under a health
31 benefit plan elect to purchase their coverage through the
32 Alliance; and
33 e. Prepayment of premiums or other mechanisms to assure that
34 payment will be made for coverage.
35 (7) Ensure that any small employer or any employee of a small employer
36 who meets the requirements established by the Board pursuant to
37 subdivision (6) of this section may purchase health care coverage
38 through an Alliance.
39 (8) Assure compliance with this Article by Alliances, small employers,
40 and employee enrollees.
41 (9) Have the authority to request carrier information about the financial
42 condition of the carrier consistent with the financial information
43 required to be submitted by the carrier to the Department of Insurance.

- 1 (10) Assure fair and affirmative marketing of the qualified health care plans
2 consistent with standards established by the Department of Insurance,
3 the Small Employer Carrier Committee, and G.S. 143-602.
- 4 (11) Adopt rules in compliance with Chapter 150B of the General Statutes
5 as necessary to administer the provisions of this Article.
- 6 (12) Appoint advisory committees that shall include persons with expertise
7 in health benefits management and representatives of Accountable
8 Health Carriers.
- 9 (13) Develop uniform standards for the data that Alliances collect from
10 Accountable Health Carriers. In formulating such standards, the Board
11 shall strive for consistency with health care data collection activities
12 underway in North Carolina and nationally. Any data collection
13 requirements promulgated by the Board shall be based on a study of
14 their feasibility and cost-effectiveness, including their consistency with
15 national standards for electronic data interchange, and their necessity
16 for supporting the evaluation of Accountable Health Carriers and their
17 provider networks with respect to cost containment, quality, control of
18 expensive technology, and customer satisfaction. All enrollee
19 satisfaction surveys employed by Alliances shall be in a standardized
20 format promulgated by the Board.
- 21 (14) Have the authority to sue or be sued, including taking action necessary
22 for securing legal remedies on behalf of, or against Alliances, member
23 small employers, or employee enrollees and dependants of those
24 employees.
- 25 (15) Have the authority to receive and accept grants or funds from any
26 public or private agency and receive and accept contributions from any
27 source of money, property, labor, or any other thing of value.
- 28 (16) Develop and implement standardized forms for use by Accountable
29 Health Carriers in conformance with applicable national standards.
- 30 (17) Review, and limit if necessary, surcharges charged by each Alliance
31 for administrative costs.
- 32 (18) Develop guidelines for any authorized marketing materials to be used
33 in providing member small employers and their eligible employees
34 with information regarding Accountable Health Carriers and their
35 respective qualified health care plans in accordance with G.S. 143-602.
36 Such guidelines shall be consistent with standards established by the
37 Department of Insurance and the Small Employer Carrier Committee.
- 38 (19) Develop grievance procedures to be used in resolving disputes
39 between member small employers and Alliances. A member small
40 employer, Alliance or Accountable Health Carrier may appeal to the
41 Board any grievance that is not resolved.
- 42 (20) Receive, review, and act on appeals of grievances not resolved.
- 43 (21) Analyze information collected from Accountable Health Carriers and
44 other sources and report findings that assist consumers, Alliances,

1 Accountable Health Carriers, or health care providers in improving the
2 delivery or purchase of cost-effective health care.

3 (22) Report annually on the operation of the Board to the Joint Legislative
4 Commission on Governmental Operations and the Governor.

5 **"§ 143-597. Alliances authorized.**

6 (a) The Board is authorized to create a single Alliance within each designated
7 market area for the benefit of its member small employers. Each Alliance shall be
8 operated as a State-chartered, nonprofit private organization.

9 (b) Each Alliance shall operate under the supervision of an Alliance Board of
10 Directors, which shall consist of 11 members. The majority of members on each
11 Alliance Board shall be small employers.

12 (1) The Board shall initially appoint six members for a term of two years.
13 The community sponsor shall initially appoint five members for a term
14 of two years. In so doing, the Board and community sponsor shall
15 consider, among other things, whether all member small employers are
16 fairly represented and assure that a majority of the Alliance Board
17 shall be small employers.

18 (2) Subsequent members of the Alliance Board of Directors shall be
19 elected pursuant to the Alliance Board's bylaws.

20 (c) Each Alliance Board shall adopt bylaws that shall include a procedure for the
21 election of Alliance Board members by the Alliance's member small employers.

22 (d) Of the initially elected members of each Alliance Board, six members shall
23 be designated to serve two-year terms and the remaining five members shall have four-
24 year terms. Thereafter, the term of an elected member shall be four years.

25 (e) Vacancies on an Alliance Board shall be filled for the remaining period of the
26 term by a majority vote of the remaining Board members. A member to fill a vacancy
27 may serve for the remainder of the term and until a qualified successor is elected for a
28 new term.

29 (f) A member who serves two consecutive full four-year terms shall not be
30 reelected for four years after completion of those terms.

31 (g) Members of the Alliance Board shall be bound by the financial interest
32 restrictions set forth for Board members in G.S. 143-595(i) and (j).

33 (h) The Alliance Board shall elect officers from among its members every two
34 years. Officers shall not serve more than two consecutive terms in an office.

35 (i) The Alliance Board shall meet at times and places as it determines necessary
36 to operate the Alliance in accordance with this section and G.S. 143-598. Such
37 meetings shall be governed by the procedures and polices set forth by the North
38 Carolina Open Meetings Law, Article 33C of Chapter 143 of the General Statutes.

39 (j) There shall be no liability on the part of, and no cause of action of any nature
40 shall arise against any member of the Alliance Board, or its employees or agents, for
41 any action taken in good faith by them in the performance of their powers and duties as
42 defined under G.S. 143-598.

43 (k) The Alliance Board shall have the powers and duties regarding operation of
44 the Alliance set forth in G.S. 143-598.

"§ 143-598. Powers and duties of the Health Plan Purchasing Alliance.

An Alliance shall have the following powers and duties:

- (1) Enter into contracts with Accountable Health Carriers for the provision of qualified health care plans for members of the Alliance pursuant to G.S. 143-599. Each Alliance shall contract with all Accountable Health Carriers which offer qualified health care plans operating in its market area and apply to serve member small employers;
- (2) Enter into contracts with small employers pursuant to G.S. 143-600;
- (3) Maintain eligibility records as appropriate to carry out the functions of this Article;
- (4) Transmit enrollment and eligibility information to Accountable Health Carriers on a timely basis;
- (5) Establish procedures for collection of premiums from member small employers, including the share of premiums paid by employee enrollees pursuant to G. S. 143-600;
- (6) Pay contracted rates to Accountable Health Carriers on a monthly basis or as otherwise mutually agreed pursuant to G.S. 143-601;
- (7) Impose annual surcharges established at the beginning of the fiscal year to be paid monthly by member small employers for necessary costs incurred in connection with the operation of the Alliance. The amount of annual surcharges shall cover any default on insurer premium payments by member small employer.
- (8) Provide that in the event a member small employer terminates coverage purchased through the Alliance, the former member small employer shall be ineligible to purchase a qualified health care plan through the Alliance for a period of two years, except as permitted by the Alliance Board and the Board for good cause;
- (9) Contract, as authorized by the Alliance Board of Directors, with a qualified third party for any service necessary to carry out the powers and duties as defined in this section, including contracts with agents to assist in contracting with Accountable Health Carriers and small employers and to assist the Alliance in undertaking activities necessary to administer the Alliance, such as marketing and publicizing the availability of the qualified health care plans;
- (10) Provide to member small employers clear, standardized information on each Accountable Health Carrier and qualified health care plans offered by each Accountable Health Carrier, including information on price, enrollee costs, quality, patient satisfaction, enrollment, and enrollee responsibilities and obligations; and provide qualified health care plan comparison sheets in accordance with Board rules to be used in providing members and their employees with information regarding coverage that may be obtained through the Accountable Health Carriers;

- 1 (11) Appoint an executive director to serve as the chief operating officer of
2 the Alliance, who may employ other staff as needed to administer the
3 Alliance. The executive director shall serve at the pleasure of the
4 Alliance Board;
- 5 (12) Establish advisory boards as necessary to assist with carrying out the
6 duties established pursuant to this section;
- 7 (13) Establish administrative and accounting procedures for operating the
8 Alliance, providing services to member small employers and employee
9 enrollees, and preparing an annual budget;
- 10 (14) Prepare annual reports on the operations of the Alliance, including
11 program and financial operations as required by the Board, and
12 provide for annual internal and independent audits;
- 13 (15) Sue or be sued, including taking any legal actions necessary or proper
14 for recovering any penalties for or on behalf of the Alliance;
- 15 (16) Maintain records and submit reports to the Board as required; and
- 16 (17) Accept and expend funds received through grants, appropriations, or
17 other appropriate and lawful means.

18 **"§ 143-599. Accountable health carriers.**

19 (a) By July 1, 1994, the Board shall establish a process whereby a carrier that
20 fulfills the qualifications of subsection (b) of this section shall be designated as an
21 Accountable Health Carrier.

22 (b) In order to be eligible to be designated as an Accountable Health Carrier, a
23 carrier must be able to demonstrate the following operating characteristics to the Board:

- 24 (1) Licensure and in good standing with the Department of Insurance;
- 25 (2) Capacity to administer the qualified health care plans;
- 26 (3) In the case of a carrier with a contractual obligation to provide or
27 arrange for the covered health services, the ability to provide enrollees
28 with adequate access to covered services within the carrier's service
29 area;
- 30 (4) Grievance procedures, including the ability to respond to enrollees'
31 calls, questions, and complaints;
- 32 (5) Established utilization management procedures;
- 33 (6) Ability to arrange and pay for the appropriate level and type of health
34 care services;
- 35 (7) Ability to monitor and evaluate the quality and cost-effectiveness of
36 care;
- 37 (8) Ability to assure enrollees with adequate numbers and types of health
38 care providers;
- 39 (9) Ability to provide information on enrollee satisfaction based on
40 standard surveys prescribed by the Board; and
- 41 (10) Ability to provide information on the types of treatments and outcomes
42 with respect to the clinical health, functional status, and well-being of
43 the enrollees based on standard data elements prescribed by the Board.

1 Carriers receiving accreditation by nationally recognized accreditation organizations,
2 including, but not limited to, the National Committee on Quality Assurance (NCQA),
3 the Utilization Review Accreditation Commission (URAC), Joint Commission on
4 Accreditation of Health Care Organizations (JCAHO), or qualification by federal
5 agencies, shall be deemed to be in compliance with the requirements of subdivisions (2)
6 through (10) of this subsection as they pertain to the relevant accreditation activities of
7 the organization.

8 (c) After notice and hearing, the Board may suspend or revoke the designation as
9 an Accountable Health Carrier of any carrier that fails to maintain compliance with the
10 requirements listed in subsections (b), (d), or (e) of this section.

11 (d) Each Accountable Health Carrier shall:

12 (1) Offer qualified health care plans;

13 (2) Provide for the collection and reporting to the Board and to the
14 appropriate Alliance of information on the performance of
15 Accountable Health Carriers regarding the effectiveness and outcomes
16 in providing selected services; provided, however, that data reporting
17 requirements adopted by the Board shall be consistent with the method
18 of operation of Accountable Health Carriers, shall be consistent with
19 national standards where available, and shall not impose an
20 unreasonable cost for compliance;

21 (3) Not deny, limit, or condition coverage under qualified health care
22 plans based on health status, claims experience, receipt of health care,
23 medical history, or lack of evidence of insurability of an eligible
24 employee or dependent pursuant to the provisions of this act;

25 (4) Establish premium rates for each qualified health care plan pursuant to
26 the adjusted community rating method described in G.S. 58-50-130(b);

27 (5) Comply with all rules regarding rating, underwriting, claims handling,
28 sales, solicitation, licensing, unfair trade practices and other provisions
29 in this act and Chapter 58 of the General Statutes.

30 (6) Issue a qualified health care plan to any member small employer that
31 elects to be covered under a qualified health care plan offered by an
32 Accountable Health Carrier during the open enrollment period
33 established pursuant to subsection (e) of this section;

34 (7) Renew each qualified health care plan with respect to any member
35 small employer except in the following cases:

36 a. Nonpayment of the required premiums;

37 b. Fraud or material misrepresentation of the member small
38 employer, or the employee enrollee, or a dependent of the
39 member small employer or the employee enrollee;

40 c. Noncompliance by a small employer with requirements
41 regarding employer contribution or participation as required by
42 the Board;

43 d. Repeated misuse of a provider network provision including, but
44 not limited to, unreasonable refusal of the enrollee to follow a

1 prescribed course of treatment, or violation of reasonable
2 policies of an Accountable Health Carrier;

3 e. Election by the Accountable Health Carrier to terminate its
4 contract with an Alliance. In such a case, the Accountable
5 Health Carrier shall:

6 1. Provide advance notice of its decision in accordance
7 with this sub-subdivision to the Alliance and to the
8 Board;

9 2. Provide notice of the decision at least 180 days prior to
10 the nonrenewal of any qualified health care plan to the
11 enrollees. Except as provided in sub-subdivision f. of
12 this subdivision an Accountable Health Carrier that
13 elects not to renew a qualified health care plan with an
14 Alliance shall be prohibited from writing new business
15 with the Alliance for a period of three years from the
16 date of notice to the Alliance or until the Alliance invites
17 the carrier to renew participation, whichever is sooner;
18 and

19 f. Determination by an Alliance, subject to review by the Board,
20 that continuation of coverage would not be in the best interest
21 of the employee enrollees and member small employers or
22 would impair the Accountable Health Carrier's ability to meet
23 its contractual obligations. In this instance, the Alliance shall
24 assist affected employee enrollees in finding replacement
25 coverage;

26 (8) Provide a procedure for addressing grievances that arise between the
27 Accountable Health Carrier and the Alliance, member small
28 employers, or employee enrollees; and

29 (e) Each Accountable Health Carrier shall offer an open enrollment period to
30 small employers at the anniversary date of the member small employers' qualified
31 health care plan. The open enrollment period shall be at least 30 consecutive calendar
32 days. Member small employers may choose from the Accountable Health Carriers
33 selected from the qualified health care plans that are offered in the market area in which
34 they reside. An Accountable Health Carrier shall not be required to offer coverage or
35 accept enrollments if:

36 (1) The eligible employee or dependent does not reside within the
37 Accountable Health Carrier's approved service area;

38 (2) An Accountable Health Carrier provides 90 days' prior notice that it
39 will not have the capacity to deliver service adequately in a market
40 area to additional enrollees because of its obligations to existing
41 groups and enrollees; or

42 (3) The Commissioner of Insurance determines that the acceptance of an
43 application or applications would place an Accountable Health Carrier
44 in a financially impaired condition.

1 (f) An Accountable Health Carrier that cannot offer coverage pursuant to
2 subdivision (2) of subsection (e) of this section shall not offer coverage to or accept
3 applications from a new employer group or an individual until the later of 90 days
4 following such refusal or the date on which the Accountable Health Carrier notifies the
5 Alliance and the Board that it has regained capacity to deliver services to eligible
6 employees and their dependents in the service area. An Accountable Health Carrier that
7 cannot offer coverage pursuant to subdivision (3) of subsection (e) of this section shall
8 not offer coverage or accept applications for any individual or employer group until a
9 determination by the Commissioner of Insurance that acceptance of an application will
10 not put the Accountable Health Carrier in a financially impaired condition.

11 (g) Nothing in this Article or any other provision of the General Statutes shall
12 prohibit an Accountable Health Carrier from providing a qualified health care plan in an
13 Alliance through a managed care system, and from contracting with particular health
14 care providers or types, classes, or categories of health care providers.

15 **"§ 143-600. Payment to Alliance by member small employers.**

16 The contracts between Alliances and member small employers and between
17 Accountable Health Carriers and Alliances shall provide that payment of all premiums
18 shall be transmitted by member small employers on their behalf and on behalf of the
19 employee enrollee, directly to the Alliance for the benefit of the Accountable Health
20 Carrier. Premiums shall be payable on a monthly basis. Alliances may provide for
21 penalties and grace periods for late payment. Nonpayment of premiums by a member
22 small employer or employee enrollee shall constitute a breach of contract and a breach
23 of the insurance policy.

24 **"§ 143-601. Payment by Alliance to Accountable Health Carriers.**

25 (a) Under a contract between an Accountable Health Carrier and an Alliance, the
26 Alliance shall forward to each Accountable Health Carrier with enrollees under a
27 qualified health care plan an amount equal to:

- 28 (1) Premiums determined by the Accountable Health Carrier's contracted
29 rates; and
- 30 (2) Adjustments in payments, if any, resulting from a risk adjustment
31 mechanism determined in accordance with G.S. 143-603.

32 (b) The Alliances shall pay the Accountable Health Carrier on a monthly basis.

33 **"§ 143-602. Marketing qualified health care plans.**

34 (a) Each Alliance shall use efficient and standardized means to notify small
35 employers of the availability of sponsored health coverage through the Alliance.

36 (b) Each Alliance shall make available to member small employers marketing
37 materials accurately summarizing the benefit plans, rates, cost, and accreditation
38 information that its Accountable Health Carriers offer through the Alliance.

39 (c) If authorized by the Board, an Accountable Health Carrier may provide,
40 directly or through an agent, broker, or contractor, marketing material relating to health
41 plans offered through the Alliance. Accountable Health Carriers shall not need
42 authorization from an Alliance for advertisement to the public at large through the
43 means of mass media.

1 (d) Nothing in this section shall be construed to or explicitly prohibit an Alliance
2 or Accountable Health Carrier from using the services of an agent or broker in order to
3 assist in marketing. An Accountable Health Carrier shall not vary compensation or
4 commissions to such agents or brokers based, directly or indirectly, on the anticipated or
5 actual claims experience or health status associated with particular small employers to
6 which each plan is sold.

7 (e) No Accountable Health Carrier, agent of an Accountable Health Carrier or
8 independent insurance agent shall engage, directly or indirectly, in any activity of
9 marketing practices that would encourage member small employers or eligible
10 employees to:

11 (1) Refrain from enrolling in the Accountable Health Carrier because of
12 their health status or claim experience; or

13 (2) Seek coverage from other Accountable Health Carriers because of
14 their health status or claim experience.

15 (f) An Alliance shall notify the Board of any marketing practices or materials
16 that it finds contrary to the fair and affirmative marketing requirements of this Article.
17 Furthermore, the Board shall monitor compliance with this section, including the
18 conduct of Accountable Health Carriers and their agents, brokers, or contractors, and
19 shall report to the Department of Insurance any unfair trade practices and misleading or
20 unfair conduct that has been reported to the Board by Alliances, agents, consumers, or
21 any other individual. The Department of Insurance shall investigate all reports and,
22 upon a finding of noncompliance with this section or of unfair and misleading practices,
23 shall take action against violators as permitted under Chapter 58 of the General Statutes
24 or this Article. The Board shall forward all reports of cases or abuse to the Department
25 of Insurance for investigation.

26 **"§ 143-603. Risk adjustment mechanism.**

27 (a) The Board shall establish a payment mechanism to adjust for the amount of
28 risk covered by each qualified health care plan offered by an Accountable Health
29 Carrier. Risk adjustment shall be based on prospectively determined factors that predict
30 utilization of health care services.

31 (b) On an annual basis, the Board shall establish a factor that represents the
32 difference between the average risk of persons covered through the Alliance and the risk
33 covered by each qualified health care plan offered by each Accountable Health Carrier
34 through the Alliance. The Board shall apply that factor in determining amounts
35 received by Accountable Health Carriers. This may be done directly or it may be done
36 indirectly by adjusting quoted premiums. The mechanism by which the adjustment is
37 made shall be established after consultation with a technical advisory committee.

38 (c) In addition to the risk adjustment mechanism described in subsections (a) and
39 (b) of this section, the Board may develop a list of a limited number of high cost
40 diagnoses. The Board may develop a mechanism to protect an Accountable Health
41 Carrier that has a disproportionate share of one or more of the listed diagnoses.

42 (d) Any payments to Accountable Health Carriers under this section shall be
43 determined on an annual basis. No payments under this section shall be based on claims
44 or the health care costs of an Accountable Health Carrier.

1 **"§ 143-604. Antitrust protection.**

2 In addition to the duties described in G.S. 143-596, the Board shall actively
3 supervise the Alliances to ensure that actions affecting market competition are not for
4 private interests, but accomplish the legislative intent of this Article. The Board shall
5 also monitor conduct throughout the small employer market to ensure that the
6 legislative intent of this Article to improve the competitiveness of the small employer
7 health coverage market is not impeded.

8 **"§ 143-605. State Health Plan Purchasing Alliance Fund.**

9 (a) There is established in the Office of the State Treasurer, the State Health Plan
10 Purchasing Alliance Fund. The Fund shall be placed in an interest-bearing account and
11 any interest or other income derived from the Fund shall be credited to the Fund.
12 Moneys in the Fund shall be spent only in accordance with subsection (b) of this
13 section. The Fund shall be administered in accordance with the Executive Budget Act.

14 (b) All money credited to the Fund shall be used as set forth by the Board.

15 (c) Moneys appropriated by the General Assembly shall be deposited in the Fund
16 and shall become part of the continuation budget of the Department of Administration.

17 **"§ 143-606. Continuation and conversion of coverage.**

18 (a) For member small employers not covered by Title III Pub. L. 100-646(26
19 USC Sec. 4908B et al.), enrollees who lose their health care coverage due to loss of
20 employment shall be offered the option of continuing health care coverage for one year,
21 provided such enrollee pays the entire required premium charged to the enrollee's
22 former employer and remains a resident of the State. An enrollee shall transmit
23 payment of premium payments through the enrollee's former employer, who shall
24 submit it to the respective Alliance.

25 (b) At the end of one year of continuation coverage, such enrollees shall be
26 offered a conversion option if such option, where available, is available for former
27 group enrollees."

28 Sec. 2. G.S. 58-50-130(b) reads as rewritten:

19 rating limitations set forth in this section.
- 20 (5) Premium rates for health benefit plans shall comply with the
21 requirements of this section notwithstanding any reinsurance
22 premiums and assessments paid or payable by small employer carriers
23 in accordance with G.S. 58-50-150.
- 24 (6) In any case where a small employer carrier uses industry as a case
25 characteristic in establishing premium rates, the rate factor associated
26 with any industry classification may not vary from the arithmetic
27 average of the rate factors associated with all industry classifications
28 by greater than ~~fifteen percent (15%)~~ seven and one-half percent (7 ½%)

- 30 (7) In the case of health benefit plans issued before January 1, 1992, a

16 the 1994-95 fiscal year shall be used for the initial operation of the Health Care
17 Purchasing Alliance Board and other activities related to the duties and responsibilities
18 of the Alliances and the State Health Purchasing Alliance Board authorized by Section 1
19 of this act.

20 Sec. 12. Section 2 of this act becomes effective January 1, 1994. Sections 3
21 through 7 of this act become effective January 1, 1995. Alliances shall become
22 operational on or after January 1, 1995. The remainder of this act is effective upon
23 ratification.
