A BILL TO BE ENTITLED

AN ACT TO FULFILL THE INTENT OF THE INSURANCE EQUALITY STATUTE  
BY CORRECTING OMISSIONS IN THAT STATUTE.

The General Assembly of North Carolina enacts:

Section 1. G.S. 58-50-30 reads as rewritten:

**"§ 58-50-30. Discrimination forbidden; right to choose services of optometrist, podiatrist, dentist or chiropractor.**

Discrimination between individuals of the same class in the amount of premiums or rates charged for any policy of insurance covered by Articles 50 through 55 of this Chapter, or in the benefits payable thereon, or in any of the terms or conditions of such policy, or in any other manner whatsoever, is prohibited.

Whenever any policy of insurance governed by Articles 1 through 64 of this Chapter provides for payment of or reimbursement for any service rendered in connection with a condition or complaint which is within the scope of practice of a duly licensed optometrist, or duly licensed podiatrist, or a duly licensed dentist, ~~or a duly licensed chiropractor, chiropractic physician,~~ or duly licensed practicing psychologist, the insured or other persons entitled to benefits under such policy shall be entitled to payment of or reimbursement for such services, whether such services be performed by a duly licensed physician or a duly licensed optometrist, or a duly licensed podiatrist, or a duly licensed ~~dentist, dentist, or a duly licensed chiropractor, chiropractic physician,~~ or a duly licensed practicing psychologist, notwithstanding any provision contained in such policy. Whenever any policy of insurance governed by Articles 1 through 64 of this Chapter provides for certification of disability which is within the scope of practice of a duly licensed physician, or a duly licensed optometrist, or a duly licensed podiatrist, or a duly

2 licensed practicing psychologist, the insured or other persons entitled to benefits under  
3 such policy shall be entitled to payment of or reimbursement for such disability whether  
4 such disability be certified by a duly licensed physician, or a duly licensed optometrist,  
5 or a duly licensed podiatrist, or a duly licensed dentist, or a duly licensed ~~chiropractor~~,  
6 chiropractic physician, or a duly licensed practicing psychologist, notwithstanding any  
7 provisions contained in such policy. The policyholder, insured, or beneficiary shall  
8 have the right to choose the provider of such services notwithstanding any provision to  
9 the contrary in any other statute.

10 Whenever any policy of insurance provides coverage for necessary treatment, the  
11 insurer shall not impose any limitation on treatment if performed by a duly licensed  
12 chiropractic physician acting within the scope of his practice unless a comparable  
13 limitation is imposed on treatment if performed by any other duly licensed physician.

14 No insurer shall issue a policy which has the effect, in its actual application, of  
15 denying coverage for those services routinely offered by chiropractic physicians.

16 For the purposes of this section, a 'duly licensed practicing psychologist' shall be  
17 defined to only include a psychologist who is duly licensed or certified in the State of  
18 North Carolina and has a doctorate degree in psychology and at least two years clinical  
19 experience in a recognized health setting, or has met the standards of the National  
20 Register of Health Providers in Psychology."

21 Sec. 2. This act is effective upon ratification.
