2	AN ACT TO PERMIT TEACHER ASSISTANTS AND OTHER INSTRUCTIONAL
3	PERSONNEL WHO DO NOT REQUIRE A SUBSTITUTE TO TAKE
4	VACATION LEAVE WHEN STUDENTS ARE IN ATTENDANCE.
5	The General Assembly of North Carolina enacts:
6	Section 1. G.S. 115C-316(a)(3) reads as rewritten:
7	"(3) Notwithstanding any provisions of this section to the contrary no
8	person shall be entitled to pay for any vacation day not earned by that
9	person. The first 10 days of annual leave earned by a 10- or 11-month
10	employee during any fiscal year period shall be scheduled to be used
11	in the school calendar adopted by the respective local boards of
12	education. Vacation days shall not be used for extending the term of
13	employment of individuals. Ten- or 11-month employees may
14	accumulate annual vacation leave days as follows: annual leave may
15	be accumulated without any applicable maximum until June 30 of each
16	year. On June 30 of each year, any of these employees with more than
17	30 days of accumulated leave shall have the excess accumulation
18	cancelled so that only 30 days are carried forward to July 1 of the same
19	year. All vacation leave taken by these employees will shall be upon
20	the authorization of their immediate supervisor and under policies
21	established by the local board of education. Vacation leave for
22	instructional personnel who do not require a substitute shall not be
23	restricted to days that students are not in attendance. An employee

1	shall be paid in a lump sum for accumulated annual leave not to
2	exceed a maximum of 240 hours when separated from service due to
3	resignation, dismissal, reduction in force, death or service retirement.
4	If the last day of terminal leave falls on the last workday in the month,
5	payment shall be made for the remaining nonworkdays in that month.
6	Employees retiring on disability retirement may exhaust annual leave
7	rather than be paid in a lump sum. The provisions of this subdivision
8	shall be accomplished without additional State and local funds being
9	appropriated for this purpose. The State Board of Education shall
10	adopt rules and regulations for the administration of this subdivision."
11	Sec. 2. This act becomes effective July 1, 1993.
