A BILL TO BE ENTITLED

AN ACT TO PROVIDE THAT IN PAROLING INMATES UNDER THE PRISON POPULATION CAP THE GOVERNOR MAY CONSENT TO THE RELEASE OF NONVIOLENT INMATES WHO WOULD NOT OTHERWISE BE ELIGIBLE FOR RELEASE.

Section 1. G.S. 148-4.1 is amended by adding a new subsection to read:

- "(g1) Notwithstanding any other provision of law, whenever the Parole Commission is required to release inmates in order to meet the requirements of this section, the Parole Commission may, with the specific consent of the Governor, parole nonviolent inmates who would not otherwise be eligible for parole instead of paroling violent inmates who are eligible for parole."
 - Sec. 2. Effective January 1, 1995, G.S. 148-4.1(g1) reads as rewritten:
- "(g1) Notwithstanding any other provision of law, law except for subsection (h) of this section, whenever the Post-Release Supervision and Parole Commission is required to release inmates in order to meet the requirements of this section, the Post-Release Supervision and Parole Commission may, with the specific consent of the Governor, parole nonviolent inmates who would not otherwise be eligible for parole instead of paroling violent inmates who are eligible for parole."
 - Sec. 3. This act is effective upon ratification, and expires on July 1, 1996.
