A BILL TO BE ENTITLED 1 2 AN ACT TO SIMPLIFY THE TRANSFER OF CREDIT BETWEEN NORTH 3 CAROLINA INSTITUTIONS OF HIGHER EDUCATION. 4 The General Assembly of North Carolina enacts: 5 Section 1. The Board of Governors of The University of North Carolina and the State Board of Community Colleges shall develop a plan for the transfer of credits 6 between the institutions of the North Carolina Community College System and between 7 the institutions of the North Carolina Community College System and the constituent 8 institutions of The University of North Carolina. The Board of Governors and the State 9 Board of Community Colleges shall make a preliminary report to the General Assembly 10 prior to January 1, 1996. 11 12 Sec. 2. It is the intent of the General Assembly to review the plan developed by the Board of Governors and the State Board of Community Colleges pursuant to 13 Section 1 of this act and to enact a plan prior to July 1, 1996, for the transfer of credits 14 between the institutions of the North Carolina Community College System and between 15 the institutions of the North Carolina Community College System and the constituent 16 institutions of The University of North Carolina. 17 Sec. 3. If the General Assembly does not enact a plan prior to July 1, 1996, for 18 19 the transfer of credits between the institutions of the North Carolina Community College
