- Sec. 2. G.S. 120-4.25 reads as rewritten:

# "§ 120-4.25. Return of accumulated contributions.

5 If a member ceases to be a member of the General Assembly except by death or 6 retirement, or makes an irrevocable election to be excluded from the Retirement System, 7 he shall, upon submission of an application, be paid not earlier than 60 days following the 8 date of termination of service, the sum of his contributions if he has less than five years 9 of creditable service, or the sum of his accumulated contributions if he has five or more years of creditable service, provided he has not in the meantime returned to service. 10 Upon payment of this sum his membership in the System ceases. If he becomes a 11 12 member afterwards, no credit shall be allowed for any service previously rendered except as provided in G.S. 120-4.14 and the payment shall be in full and complete discharge of 13 14 any rights in or to any benefits otherwise payable under this Article. Upon receipt of 15 proof satisfactory to the Board of Trustees of the death, prior to retirement, of a member or former member, there shall be paid to the person or persons he nominated by written 16 17 designation duly acknowledged and filed with the Board of Trustees, if the person or 18 persons are living at the time of the member's death, otherwise to the member's legal representatives, the amount of his accumulated contributions at the time of his death, 19 20 unless the beneficiary elects to receive the alternate benefit under the provisions of G.S. 21 120-4.28."
