A BILL TO BE ENTITLED

AN ACT TO MAKE TECHNICAL CORRECTIONS AND CONFORMING CHANGES
TO THE GENERAL STATUTES AND SESSION LAWS AS RECOMMENDED
BY THE GENERAL STATUTES COMMISSION AND TO MAKE OTHER
TECHNICAL AND CONFORMING CHANGES TO THE GENERAL STATUTES
AND SESSION LAWS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 1C-1807 reads as rewritten:

"§ 1C-1807. Situations not covered by Article.

This Article does not prevent the recognition of foreign ~~judgment~~ judgments in situations not covered by this Article."

Sec. 2. Effective October 1, 1995, G.S. 7A-29(a) reads as rewritten:

"(a) From any final order or decision of the North Carolina Utilities Commission not governed by subsection (b) of this section, the Department of Human Resources pursuant to G.S. 131E-188(b), the Commissioner of Banks pursuant to Articles ~~17 and 18,~~ 18A, 17, 18, and 18A of Chapter 53 of the General Statutes, the Administrator of Savings and Loans pursuant to Article 3A of Chapter 54B of the General Statutes, the North Carolina Industrial Commission, the North Carolina State Bar pursuant to G.S. 84-28, the

1 Property Tax Commission pursuant to G.S. 105-290 and G.S. 105-342, the Board of State
 2 Contract Appeals pursuant to G.S. 143-135.9, the Commissioner of Insurance pursuant to
 3 G.S. 58-2-80, or the Secretary of Environment, Health, and Natural Resources under G.S.
 4 104E-6.2, appeal as of right lies directly to the Court of Appeals."

5 Sec. 3. G.S. 7A-41(c)(3) reads as rewritten:

6 "(3) The change is approved by ~~the~~the county board of elections where the
 7 precinct is located, State Board of Elections and by the Secretary of
 8 State upon finding that the change:

- 9 a. Will improve election administration; and
- 10 b. Complies with subdivisions (1) and (2) of this subsection."

11 Sec. 4. G.S. 7A-343.1 reads as rewritten:

12 **"§ 7A-343.1. Distribution of copies of the appellate division reports.**

13 The Administrative Officer of the Courts shall, at the State's expense distribute such

1 Each justice of the Supreme Court and judge of the Court of Appeals shall receive for
2 his private use, one complete and up-to-date set of the appellate division reports. The
3 copies of reports furnished each justice or judge as set out in the table above may be
4 retained by him personally to enable him to keep up-to-date his personal set of reports."

5 Sec. 5. G.S. 7A-675(a) reads as rewritten:

6 "(a) The clerk of superior court shall maintain a complete record of all juvenile
7 cases filed in the clerk's office to be known as the juvenile record, which shall be
8 withheld from public inspection and, except as provided in this subsection, may be
9 examined only by order of the judge. The record shall include the summons, petition,
10 custody order, court order, written motions, the electronic or mechanical recording of the
11 hearing, and other papers filed in the proceeding. The recording of the hearing shall be
12 reduced to a written transcript only when notice of appeal has been timely given. After
13 the time for appeal has expired with no appeal having been filed, the recording of the
14 hearing may be erased or destroyed upon the written order of the judge.

15 The following persons may examine the juvenile's record without an order of the
16 judge:

17 (1) The juvenile, the juvenile's parent, guardian, or custodian, or another
18 authorized representative of the juvenile.

19 (2) The prosecutor in a subsequent criminal proceeding against the juvenile.

20 The juvenile's record of an adjudication of delinquency for an offense that would be a
21 Class A, ~~B~~, B1, B2, C, D, or E felony if committed by an adult may be used in a
22 subsequent criminal proceeding against the juvenile either under G.S. 8C-1, Rule 404(b),
23 or to prove an aggravating factor at sentencing under G.S. 15A-1340.4(a), G.S. 15A-
24 1340.16(d), or G.S. 15A-2000(e). The record may be so used only by order of the judge
25 in the subsequent criminal proceeding, upon motion of the prosecutor, after an in camera
26 hearing to determine whether the record in question is admissible."

27 Sec. 6. G.S. 7A-676(b) reads as rewritten:

28 "(b) Any person who has attained the age of 16 years may file a petition in the court
29 where the person was adjudicated delinquent for expunction of all records of that
30 adjudication provided:

31 (1) The offense for which the person was adjudicated would have been a
32 crime other than a Class A, ~~B~~, B1, B2, C, D, or E felony if committed
33 by an adult.

34 (2) The person has not subsequently been adjudicated delinquent or
35 convicted as an adult of any felony or misdemeanor other than a traffic
36 violation under the laws of the United States or the laws of this State or
37 any other state.

38 Records relating to an adjudication for an offense that would be a Class A, ~~B~~, B1, B2,
39 C, D, or E felony if committed by an adult shall not be expunged."

40 Sec. 7. G.S. 8C-1, Rule 404(b) reads as rewritten:

41 "(b) Other crimes, wrongs, or acts. – Evidence of other crimes, wrongs, or acts is
42 not admissible to prove the character of a person in order to show that he acted in
43 conformity therewith. It may, however, be admissible for other purposes, such as proof of

1 motive, opportunity, intent, preparation, plan, knowledge, identity, or absence of mistake,
2 entrapment or accident. Admissible evidence may include evidence of an offense
3 committed by a juvenile if it would have been a Class A, ~~B~~, B1, B2, C, D, or E felony if
4 committed by an adult."

5 Sec. 8. G.S. 14-39(a) reads as rewritten:

6 "(a) Any person who shall unlawfully confine, restrain, or remove from one place
7 to another, any other person 16 years of age or over without the consent of such person,
8 or any other person under the age of 16 years without the consent of a parent or legal
9 custodian of such person, shall be guilty of kidnapping if such confinement, restraint or
10 removal is for the purpose of:

- 11 (1) Holding such other person for ransom or as a hostage or using such
12 other person as a shield; or
- 13 (2) Facilitating the commission of any felony or facilitating flight of any
14 person following the commission of a felony; or
- 15 (3) Doing serious bodily harm to or terrorizing the person so confined,
16 restrained or removed or any other ~~person~~ person; or
- 17 (4) Holding such other person in involuntary servitude in violation of G.S.
18 14-43.2."

19 Sec. 9. G.S. 14-72.1(e) reads as rewritten:

20 "(e) Punishment. – For a first conviction under ~~subsections~~ subsection (a) or (d), or
21 for a subsequent conviction for which the punishment is not specified by this subsection,
22 the defendant may be guilty of a Class 3 misdemeanor. The term of imprisonment may
23 be suspended only on condition that the defendant perform community service for a term
24 of at least 24 hours. For a second offense committed within three years after the date the
25 defendant was convicted of an offense under this section, the defendant may be guilty of
26 a Class 2 misdemeanor. The term of imprisonment may be suspended only on condition
27 that the defendant be imprisoned for a term of at least 72 hours as a condition of special
28 probation, perform community service for a term of at least 72 hours, or both. For a third
29 or subsequent offense committed within five years after the date the defendant was
30 convicted of two other offenses under this section, the defendant may be guilty of a Class
31 1 misdemeanor. The term of imprisonment may be suspended only if a condition of
32 special probation is imposed to require the defendant to serve a term of imprisonment of
33 at least 14 days. However, if the sentencing judge finds that the defendant is unable, by
34 reason of mental or physical infirmity, to perform the service required under this section,
35 and the reasons for such findings are set forth in the judgment, he may pronounce such
36 other sentence as he finds appropriate."

37 Sec. 10. G.S. 14-401.14(a) reads as rewritten:

38 "(a) If a person shall, because of race, color, religion, nationality, or country of
39 origin, assault another person, or damage or deface the property of another person, or
40 threaten to do any such act, he shall be guilty of a ~~misdemeanor punishable by imprisonment~~
41 ~~up to two years, or a fine, or both.~~ Class 1 misdemeanor."

42 Sec. 11. G.S. 14-413 reads as rewritten:

43 "**§ 14-413. Permits for use at public exhibitions.**

1 For the purpose of enforcing the provisions of this ~~article~~, Article, the board of county
2 commissioners of any county ~~are~~ is hereby empowered and authorized to issue permits
3 for use in connection with the conduct of public exhibitions, such as fairs, carnivals,
4 shows of all descriptions and public exhibitions, but only after satisfactory evidence is
5 produced to the effect that said pyrotechnics will be used for the aforementioned
6 purposes and none other. Provided that no such permit shall be required for a public
7 exhibition authorized by ~~the~~ The University of North Carolina or the University of North
8 Carolina at Chapel Hill and conducted on lands or buildings in Orange County owned by
9 The University of North Carolina or the University of North Carolina at Chapel Hill."

10 Sec. 12. G.S. 14-455(a) reads as rewritten:

11 "(a) It is unlawful to willfully and without authorization alter, damage, or destroy a
12 computer, computer system, computer network, or any part thereof. A violation of this
13 subsection is a Class G felony if the damage caused by the alteration, damage, or
14 destruction is more than one thousand dollars (\$1,000). Any other violation of this
15 subsection is a Class 1 misdemeanor.

16 ~~Class 1~~."

17 Sec. 13. G.S. 15A-1340.16(d)(18a) reads as rewritten:

18 "(18a) The defendant has previously been adjudicated delinquent for an
19 offense that would be a Class A, ~~B~~, B1, B2, C, D, or E felony if
20 committed by an adult."

21 Sec. 14. G.S. 15A-2000(e)(3) reads as rewritten:

22 "(2) The defendant had been previously convicted of another capital felony
23 or had been previously adjudicated delinquent in a juvenile proceeding
24 for committing an offense that would be a capital felony if committed
25 by an adult.

26 (3) The defendant had been previously convicted of a felony involving the
27 use or threat of violence to the person or had been previously
28 adjudicated delinquent in a juvenile proceeding for committing an
29 offense that would be a Class A, ~~B~~, B1, B2, C, D, or E felony involving
30 the use or threat of violence to the person if the offense had been
31 committed by an adult."

32 Sec. 14.1. G.S. 17C-6(a)(8) reads as rewritten:

33 "(8) Investigate and make such evaluations as may be necessary to determine
34 if criminal justice agencies, schools, and individuals are complying with
35 the ~~provision~~ provisions of this Chapter;".

36 Sec. 15. G.S. 18B-1000(1) reads as rewritten:

37 "(1) Community theatre. – An establishment owned and operated by a bona
38 fide nonprofit organization that is engaged solely in the business of
39 sponsoring or presenting ~~an~~ amateur or professional theatrical events to
40 the public. A permit issued for a community theatre is valid only during
41 regularly scheduled theatrical events sponsored by such nonprofit
42 organization."

43 Sec. 16. G.S. 18B-1001(3) reads as rewritten:

1 "(3) On-Premises Unfortified Wine Permit. – An on-premises unfortified
2 wine permit authorizes the retail sale of unfortified wine for
3 consumption on the premises, either alone or mixed with other
4 beverages, and the retail sale of unfortified wine in the manufacturer's
5 original container for consumption off the premises. The permit may be
6 issued for any of the following:

- 7 a. Restaurants;
- 8 b. Hotels;
- 9 c. Eating establishments;
- 10 d. Private clubs;
- 11 e. Convention centers;
- 12 f. Cooking schools;
- 13 g. Community ~~theatres~~ theatres;
- 14 h. ~~Winery~~ Wineries."

15 Sec. 17. G.S. 18B-1001(5) reads as rewritten:

16 "(5) On-Premises Fortified Wine Permit. – An on-premises fortified wine
17 permit authorizes the retail sale of fortified wine for consumption on the
18 premises, either alone or mixed with other beverages, and the retail sale
19 of fortified wine in the manufacturer's original container for
20 consumption off the premises. The permit may be issued for any of the
21 following:

- 22 a. Restaurants;
- 23 b. Hotels;
- 24 c. Private clubs;
- 25 d. Community ~~theatres~~ theatres;
- 26 e. Wineries;
- 27 f. Convention centers."

28 Sec. 18. G.S. 18B-1001(7) reads as rewritten:

29 "(7) Brown-Bagging Permit. – A brown-bagging permit authorizes each
30 individual patron of an establishment, with the permission of the
31 permittee, to bring up to eight liters of fortified wine or spirituous
32 liquor, or eight liters of the two combined, onto the premises and to
33 consume those alcoholic beverages on the premises. The permit may be
34 issued for any of the following:

- 35 a. Restaurants;
- 36 b. Hotels;
- 37 c. Private clubs;
- 38 d. Community ~~theaters~~ theatres;
- 39 e. ~~Congressionally chartered~~ Congressionally chartered veterans
40 organizations."

41 Sec. 19. G.S. 19A-1 reads as rewritten:

42 "**§ 19A-1. Definitions.**

1 For the purposes of this Chapter the following definition of terms shall be applicable:
2 The following definitions apply in this Article:

- 3 (1) The terms 'animals' and 'dumb animals' ~~shall be held to include every~~
4 useful living creature.
- 5 (2) The terms 'cruelty' and 'cruel treatment' ~~shall be held to include every act,~~
6 omission, or neglect whereby unjustifiable physical pain, suffering, or
7 death is caused or permitted; but ~~such term~~ these terms shall not be
8 construed to include lawful taking of animals under the jurisdiction and
9 regulation of the Wildlife Resources Commission, lawful activities
10 sponsored by agencies conducting biomedical research or training,
11 lawful activities for sport, the production of livestock or poultry, or the
12 lawful destruction of any animal for the purpose of protecting such
13 livestock or poultry.
- 14 (3) The term 'person' ~~as used herein shall be held to include~~ includes any
15 persons, firm or corporation, including any nonprofit corporation, such
16 as a society for the prevention of cruelty to animals."

17 Sec. 20. G.S. 19A-2 reads as rewritten:

18 **"§ 19A-2. Purpose.**

19 It shall be the purpose of this ~~Chapter~~ Article to provide a civil remedy for the
20 protection and humane treatment of animals in addition to any criminal remedies that are
21 available and it shall be proper in any action to combine causes of action against one or
22 more defendants for the protection of one or more animals. A real party in interest as
23 plaintiff shall be held to include any 'person' as hereinbefore defined even though such
24 person does not have a possessory or ownership right in an animal; a real party in interest
25 as defendant shall include any person who owns or has possession of an animal."

26 Sec. 21. G.S. 25-2A-103(1)(g) reads as rewritten:

- 27 "(g) 'Finance lease' means a lease with respect to which: (i) the lessor does
28 not select, ~~manufacturer,~~ manufacture, or supply the goods; (ii) the
29 lessor acquires the goods or the right to possession and use of the goods
30 in connection with the lease; and (iii) one of the following occurs:
- 31 (A) the lessee receives a copy of the contract by which the lessor
32 acquired the goods or the right to possession and use of the goods
33 before signing the lease contract;
- 34 (B) the lessee's approval of the contract by which the lessor acquired
35 the goods or the right to possession and use of the goods is a
36 condition to effectiveness of the lease contract;
- 37 (C) the lessee, before signing the lease contract, receives an accurate
38 and complete statement designating the promises and warranties,
39 and any disclaimers of warranties, limitations or modifications of
40 remedies, or liquidated damages, including those of a third party,
41 such as the manufacturer of the goods, provided to the lessor by
42 the person supplying the goods in connection with or as part of

1 the contract by which the lessor acquired the goods or the right to
2 possession and use of the goods; or

- 3 (D) if the lease is not a consumer lease, the lessor, before the lessee
4 signs the lease contract, informs the lessee in writing (a) of the
5 identity of the person supplying the goods to the lessor, unless
6 the lessee has selected that person and directed the lessor to
7 acquire the goods or the right to possession and use of the goods
8 from that person, (b) that the lessee is entitled under this Article
9 to the promises and warranties, including those of any third
10 party, provided to the lessor by the person supplying the goods in
11 connection with or as part of the contract by which the lessor
12 acquired the goods or the right to possession and use of the
13 goods, and (c) that the lessee may communicate with the person
14 supplying the goods to the lessor and receive an accurate and
15 complete statement of those promises and warranties, including
16 any disclaimers and limitations of them or of remedies."

17 Sec. 22. The catch line of G.S. 25-2A-305 reads as rewritten:

18 "**§ 25-2A-305. Sale or sublease of goods by lease-lessee.**"

19 Sec. 23. G.S. 25-2A-526(3) reads as rewritten:

20 "(3)(a) To stop ~~deliver~~, delivery, a lessor shall so notify as to enable the bailee
21 by reasonable diligence to prevent delivery of the goods."

22 (b) ~~after~~ After notification, the bailee shall hold and deliver the goods
23 according to the directions of the lessor, but the lessor is liable to the
24 bailee for any ensuing charges or damages.

25 (c) ~~a~~ A carrier who has issued a nonnegotiable bill of lading is not obliged
26 to obey a notification to stop received from a person other than the
27 consignor."

28 Sec. 24. G.S. 36A-136(20) reads as rewritten:

29 "(20) To borrow money for such periods of time and upon such terms and
30 conditions as to rates, maturities, renewals, and security as the
31 trustee deems advisable, including the power of a corporate trustee
32 to borrow from the trustee's own banking department, for the sole
33 purpose of paying debts, taxes, and other claims against the trust
34 property as may be required to secure such loan or loans, and to
35 renew existing loans either as to ~~make~~ maker or endorser."

36 Sec. 25. G.S. 45-21.21(d) reads as rewritten:

37 "(d) If a sale is not held at the time fixed therefor and is not postponed as provided
38 by this section, or if a postponed sale is not held at the time fixed therefor or within 90
39 days of the date originally fixed for the sale, then prior to such sale taking place the
40 provisions of G.S. 45-21.16 need not be complied with but the provisions of G.S. 45-
41 21.16A, 45-21.17, and 45-21.17A shall be again complied with, or if on appeal, the
42 appellate court orders the sale to be held, as to such sale so authorized the provisions of

1 G.S. 45-21.16 need not be complied with again but those of G.S. 45-21.16A, 45-21.17,
2 and 45-21.17A shall be."

3 Sec. 26. G.S. 45-21.33(c)(3) reads as rewritten:

4 "(3) Proof as required by the clerk, which may be by affidavit, that notices of
5 hearing, sale and resale were served upon all parties entitled thereto
6 under G.S. 45-21.16, ~~G.S. 45-21.17~~, 45-21.17A, and 45-21.30. In the
7 absence of an affidavit to the contrary filed with the clerk, an affidavit
8 by the person holding the sale that the notice of sale was posted in the
9 area designated by the clerk of superior court for posting public notices
10 in the county or counties in which the property is situated 20 days prior
11 to the sale shall be proof of compliance with the requirements of G.S.
12 45-21.17(1)a."

13 Sec. 27. G.S. 55A-7-27(b)(3) reads as rewritten:

14 "(3) Two or more persons hold the membership as cotenants or fiduciaries
15 and the name signed purports to be the name of at least one of the
16 coholders and the person signing appears to be acting on behalf of all
17 the coholders; ~~and or~~."

18 Sec. 28. Effective July 1, 1994, G.S. 55A-8-05(a) reads as rewritten:

19 "(a) The articles of incorporation or bylaws may specify the terms of directors. In
20 the absence of a contrary provision in the articles ~~or of~~ incorporation or bylaws, the term
21 of each director shall be one year, and directors may serve successive terms."

22 Sec. 29. Effective July 1, 1994, G.S. 55A-8-23(a) reads as rewritten:

23 "(a) A director may waive any notice required by this Chapter, the articles of
24 ~~corporation, incorporation,~~ or bylaws before or after the date and time stated in the notice.
25 Except as provided by subsection (b) of this section, the waiver shall be in writing, signed
26 by the director entitled to the notice, and filed with the minutes or corporate records."

27 Sec. 30. Effective July 1, 1994, G.S. 55A-10-30 reads as rewritten:

28 **"§ 55A-10-30. Approval by third persons.**

29 The articles of incorporation or bylaws may require an amendment to the articles ~~or of~~
30 incorporation or bylaws to be approved in writing by a specified person or persons other
31 than the board of directors. Such a provision in the articles of incorporation or bylaws
32 may only be amended with the approval in writing of such person or persons."

33 Sec. 32. Effective July 1, 1994, G.S. 55A-15-30(a)(6) reads as rewritten:

34 "(6) The Secretary of State receives a duly authenticated certificate from the
35 secretary of state or other official having custody of corporate records in
36 the state or country under whose law the foreign corporation is
37 incorporated stating that ~~is it~~ has been dissolved or disappeared as the
38 result of a merger;"

39 Sec. 33. Effective July 1, 1994, G.S. 55A-16-05(1) reads as rewritten:

40 "(1) Used to solicit money or property unless such money or property will be
41 used solely to solicit the votes of the members in an election to be held
42 by the ~~corporation; corporation;~~"

43 Sec. 34. G.S. 62-3(23)a.1. reads as rewritten:

1 "1. Producing, generating, transmitting, delivering or
2 furnishing electricity, piped gas, steam or any other like
3 agency for the production of light, heat or power to or for
4 the public for compensation; provided, however, that the
5 term 'public utility' shall not include persons who
6 construct or operate an electric generating facility, the
7 primary purpose of which facility is for such person's own
8 use and not for the primary purpose of producing
9 electricity, heat, or steam for sale to or for the public for
10 ~~compensation.~~ compensation."

11 Sec. 35. G.S. 78A-2(2)d.1. reads as rewritten:

12 "1. The security is exempted under subdivisions (1), (2), (3),
13 (4), ~~(5)~~, (7), (9), (10), (11), (13), or (14) of G.S. 78A-
14 16, or the transaction is exempted under G.S. 78A-17, and
15 such exemption has not been denied or revoked under
16 G.S. 78A-18, or"

17 Sec. 36. G.S. 88A-23 reads as rewritten:

18 **"§ 88A-23. Reports and immunity from suit.**

19 disapproval by first-class mail addressed to the voter at his residence address or at the

22 election to which it relates and on that day he shall destroy the container-return envelope
23 and the ballots therein, without, however, revealing the manner in which the voter
24 marked the ballots."

26 "(f) Notwithstanding the exception specified in ~~G.S. 163-119~~, G.S. 163-130,
27 counties which operate a modified full-time office shall remain open five days each week
28 during regular business hours consistent with daily hours presently observed by the
29 county board of elections, commencing with the date prescribed in G.S. 163-227.2(b) and
30 continuing until 5:00 P.M. on the Friday prior to that election or primary. The boards of
31 county commissioners shall provide necessary funds for the additional operation of the

15 Commission made by the Speaker of the House of Representatives, the President of the

32 of the court after consideration of all of the circumstances. Any act of illicit sexual
33 behavior by either party that has been ~~condone~~ condoned by the other party shall not be
34 considered by the court.

35 The claim for alimony may be heard on the merits prior to the entry of a judgment for
36 equitable distribution, and if awarded, the issues of amount and of whether a spouse is a
37 dependent or supporting spouse may be reviewed by the court after the conclusion of the
38 equitable distribution claim."

34 A person who wishes, for good cause shown, to change his name must file his
35 application before the clerk of the superior court of the county in which he lives, having
36 first given 10 days' notice of the application by publication at the courthouse door.

37 Applications to change the name of minor children may be filed by their parent or
38 parents or guardian or next friend of such minor children, and such applications may be
39 joined in the application for a change of name filed by their parent or parents: Provided
40 nothing herein shall be construed to permit one parent to make such application on behalf
41 of a minor child without the consent of the other parent of such minor child if both
42 parents be living, except that a minor who has reached the age of 16 years, upon proper

3 has abandoned the minor. Provided, further, that a change of parentage or the addition of
4 information relating to parentage on the birth certificate of any person shall be made

6 Notwithstanding any other provisions of this section, the consent of a parent who has
7 abandoned a minor child shall not be required if there is filed with the clerk a copy of an
8 order of a court of competent jurisdiction adjudicating that such parent has abandoned
9 such minor child. In the event that a court of competent jurisdiction has not therefore
10 declared the minor child to be an abandoned child, then on written notice of not less than
11 10 days to the parent alleged to have abandoned the child, by registered or certified mail
12 directed to such parent's last known address, the clerk of superior court is hereby
13 authorized to determine whether an abandonment has taken place. If said parent denies
14 that an abandonment has taken place, this issue of fact shall be determined as provided in
15 G.S. 1-273, and if abandonment is determined, then the consent of said parent shall not
16 be required. Upon final determination of this issue of fact the proceeding shall be
17 transferred back to the special proceedings docket for further action by the clerk."

18 (g) Section 4.1 of Chapter 360 of the 1995 Session Laws became effective
19 upon ratification of that act.

20 (h) G.S. 120-2.1, as enacted by Section 1 of Chapter 355 of the 1995 Session
21 Laws, is recodified as G.S. 120-2.2.

4 "(8) Employees or independent contractors of a hospital or health care
5 facility licensed under Article 5 or Part A of Article 6 of Chapter 131E
6 or Article 2 of Chapter 122C of the General Statutes."

7 (t) Effective October 1, 1995, G.S. 55-7-44(d) as enacted by Chapter 149 of
8 the 1995 Session Laws reads as rewritten:

9 "(d) If a derivative proceeding is commenced after a determination has been made
10 rejecting a demand by a shareholder, the complaint shall allege with particularity facts
11 establishing that the requirements of subsection (a) of this section have not been met.
12 Defendants may make a motion to dismiss a complaint under subsection (a) of this
13 section for failure to comply with this subsection. Prior to the court's ruling on such a
14 motion to ~~dismiss for failure to comply with this subsection,~~ dismiss, the plaintiff shall be
15 entitled to discovery only with respect to the issues presented by the motion and only if
16 and to the extent that the plaintiff has alleged such facts with particularity. The
