A BILL TO BE ENTITLED

**AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE.**

Whereas, G.S. 120-121 authorizes the General Assembly to make certain appointments to public offices upon the recommendation of the President Pro Tempore of the Senate; and Whereas, the President Pro Tempore of the Senate has made recommendations; Now, therefore,

The General Assembly of North Carolina enacts:

Section 1. Janet Smith of Davie County is appointed to the Information Resource Management Commission for a term expiring June 30, 1999.

Sec. 2. Robert J. Reo of Alamance County is appointed to the Acupuncture Licensing Board for a three-year term expiring June 30, 1998.

Sec. 3. Charles A. Hayes of Guilford County is appointed to the North Carolina Global TransPark Authority Board of Directors for a term expiring June 30, 1997.

Sec. 4. Gary Stepp of Cherokee County (cochair), Terry Mitchell of Pasquotank County, Brenda Tinkam of Hertford County and Fred Bartholomew of
