2 AN ACT TO PROVIDE TAX REFORM AND TAX RELIEF FOR THE CITIZENS OF
3 NORTH CAROLINA BY REPEALING THE UNCONSTITUTIONAL
4 CORPORATE TAX CREDIT FOR NORTH CAROLINA WINE, REPEALING THE
5 UNCONSTITUTIONAL CORPORATE TAX DEDUCTION FOR NORTH
6 CAROLINA DIVIDENDS, REPEALING THE UNCONSTITUTIONAL
7 INDIVIDUAL INCOME TAX CREDIT FOR NORTH CAROLINA DIVIDENDS,
8 REVISING THE UNCONSTITUTIONAL TAX CREDIT FOR QUALIFIED
9 BUSINESS INVESTMENTS, CLARIFYING THE TAX TREATMENT OF
10 REFUNDS OF UNCONSTITUTIONAL TAXES, CLARIFYING THE SALES AND
11 USE TAX TREATMENT OF ITEMS GIVEN AWAY BY MERCHANTS,
12 PROVIDING THE SECRETARY OF REVENUE AUTHORITY TO IMPROVE
13 USE TAX COLLECTION, EXEMPTING FROM SALES AND USE TAX
14 INVENTORY THAT IS DONATED BY A MERCHANT TO A CHARITABLE
15 NONPROFIT ORGANIZATION, AND REPEALING MOST STATE PRIVILEGE
16 LICENSE TAXES.

6 **PART I. REFORM UNCONSTITUTIONAL TAX PROVISIONS**

7 Section 1. G.S. 105-130.38 and G.S. 105-151.15 are repealed.

8 Sec. 2. G.S. 105-151.19 is repealed.

9 Sec. 3. G.S. 105-130.7 reads as rewritten:

10 **"§ 105-130.7. Deductible portion of dividends.**

11 Dividends from stock issued by any a corporation shall be deducted to the extent herein
12 provided. ~~are deductible to the extent provided in this section.~~

13 (1) ~~As soon as may be practicable after September 30 of each year, the~~
14 ~~Secretary of Revenue shall determine from the corporate income tax~~
15 ~~return filed during the year ending September 30 by each corporation~~
16 ~~required to file a return during that period the proportion of the entire~~
17 ~~net income or loss of the corporation allocable to this State under the~~
18 ~~provisions of G.S. 105-130.4, except as provided herein. If a~~
19 ~~corporation has a net income in North Carolina and a net loss from all~~
20 ~~sources wherever located, or if a corporation has a net loss in North~~
21 ~~Carolina and a net income from all sources wherever located, the~~
22 ~~Secretary shall require the use of the allocation fraction determined~~
23 ~~under the provisions of G.S. 105-130.4. A corporation which is a~~
24 ~~stockholder in any such corporation shall be allowed to deduct the same~~
25 ~~proportion of the dividends received by it from such corporation during~~
26 ~~its income year ending on or after September 30. No deduction shall be~~
27 ~~allowed for any part of any dividend received from any corporation that~~
28 ~~was required to file an income tax return during the year ending~~
29 ~~September 30 but failed to file the return. In the case of dividends~~
30 ~~received from a corporation that was not required to file a return during~~
31 ~~the year ending September 30, the proportion of dividends deductible by~~
32 ~~the stockholder shall be determined by the Secretary from the best~~
33 ~~information available.~~

34 (2) ~~Dividends received by a corporation from stock in any insurance~~
35 ~~company of this State taxed under the provisions of G.S. 105-228.5~~
36 ~~shall be deductible by such corporation, and a proportionate part of any~~
37 ~~dividends received from stock in any foreign insurance corporation shall~~
38 ~~be deductible, such part to be determined on the basis of the ratio of~~
39 ~~premiums reported for taxation in this State to total premiums collected~~
40 ~~both in and out of this State.~~

41 (3) ~~A corporation shall be allowed to~~ may deduct such proportionate part of
42 dividends received by it from a regulated investment company or a real
43 estate investment trust, as defined in G.S. 105-130.12, as represents and

1 corresponds to income received by such regulated investment company
2 or real estate investment trust which would not be taxed by this State if
3 received directly by the corporation.

4 ~~(3a) Dividends received on shares of capital stock owned in a stock-owned~~
5 ~~savings and loan association taxed under Article 8D of this Chapter~~
6 ~~shall be deductible.~~

7 (4) ~~Notwithstanding the provisions of subdivisions (1) through (3a) of this~~
8 ~~section, a corporation which, A corporation that, at the close of its taxable~~
9 ~~year, has its commercial domicile within North Carolina shall be~~
10 ~~allowed to deduct all dividends received from corporations in which it~~
11 ~~owns more than fifty percent (50%) of the outstanding voting stock.~~

12 (5) ~~Notwithstanding any other provisions of this Division, a corporation~~
13 ~~which is a shareholder in a holding company shall be allowed as a~~
14 ~~deduction an amount equal to those dividends received by it from such~~
15 ~~holding company, multiplied by a fraction, the numerator of which shall~~
16 ~~be the dividends received by such holding company attributable to~~
17 ~~North Carolina, and the denominator of which shall be the gross~~
18 ~~dividends received by such holding company; provided, however, that~~
19 ~~no deduction shall be allowed where the fraction is smaller than one-~~
20 ~~third (1/3). For purposes of this section, "dividends attributable to~~
21 ~~North Carolina" shall be the amount of dividend income received by the~~
22 ~~holding company on stock owned in other corporations equal to the total~~
23 ~~of the proportion of each of such corporation's dividends as shall be~~
24 ~~determined deductible by the Secretary under subdivisions (1) through~~
25 ~~(3a) of this section; provided that a holding company which owns more~~
26 ~~than fifty percent (50%) of the outstanding voting stock of one or more~~
27 ~~holding companies as defined in this subdivision shall be permitted a~~

5 ~~distributions received from a partnership by a corporation owning more~~
6 ~~than a fifty percent (50%) interest in the partnership.~~

7 (6) In no case shall the total amount of dividends that are allowed as a
8 deduction to a corporation as a result of the application of subdivisions (1)
9 ~~through (3a)~~ under subdivision (3) of this section be in excess of exceed
10 fifteen thousand dollars (\$15,000) for the taxable year."

11 Sec. 4. G.S. 105-130.5(b)(3) reads as rewritten:

12 "(3) The deductible portion of dividends from stock issued by any corporation
13 as provided under G.S. 105-130.7."

14 Sec. 5. G.S. 105-130.4(f) reads as rewritten:

15 "(f) Interest and net dividends are allocable to this State if the corporation's
16 commercial domicile is in this State ~~subject to the following limitations:~~ State. For

17 (1) ~~Net dividends received by a corporation from another corporation in~~
18 ~~which the recipient corporation owns fifty (50%) or more per centum of~~
19 ~~the paying corporation's voting stock, shall be allocated to this State if~~
20 ~~the paying corporation is subject to income tax in this State. In such~~
21 ~~case, the net amount of such dividends received by the recipient~~
22 ~~corporation from the paying corporation is allocable to this State by use~~

30 Sec. 6. G.S. 105-163.012(b) reads as rewritten:

31 "(b) The total amount of all tax credits allowed to taxpayers under G.S. 105-
32 163.011 for investments made in a calendar year may not exceed ~~twelve million dollars~~
33 ~~(\$12,000,000).~~ six million dollars (\$6,000,000). The Secretary of Revenue shall calculate
34 the total amount of tax credits claimed from the applications filed pursuant to G.S. 105-
35 163.011(c). If the total amount of tax credits claimed for investments made in a calendar
36 year exceeds ~~twelve million dollars (\$12,000,000),~~ six million dollars (\$6,000,000) the
37 Secretary shall allow a portion of the credits claimed ~~on the following basis:~~ by allocating a
38 total of six million dollars (\$6,000,000) in tax credits in proportion to the size of the
39 credit claimed by each taxpayer.

40 (1) ~~A total of six million dollars (\$6,000,000) in tax credits for investments~~

7 ~~million dollars (\$6,000,000), the Secretary shall allow additional credits~~

9 ~~amount of all tax credits allowed equals twelve million dollars~~

11 Sec. 7. Division V of Article 4 of Chapter 105 of the General Statutes, as
12 amended by this act, reads as rewritten:

13 **"DIVISION V. TAX CREDITS FOR QUALIFIED BUSINESS INVESTMENTS.**

14
15 **"§ 105-163.010. (Repealed effective for investments made on or after January 1,**
16 **1999) Definitions.**

17 The following definitions apply in this Division:

- 18 (1) Affiliate. – An individual or business that controls, is controlled by, or
19 is under common control with another individual or business.
- 20 (2) Business. – A corporation, partnership, association, or sole
21 proprietorship operated for profit.
- 22 (3) Control. – A person controls an entity if the person owns, directly or
23 indirectly, more than ten percent (10%) of the voting securities of that
24 entity. As used in this subdivision, the term 'voting security' means a
25 security that (i) confers upon the holder the right to vote for the election
26 of members of the board of directors or similar governing body of the
27 business or (ii) is convertible into, or entitles the holder to receive upon
28 its exercise, a security that confers such a right to vote. A general
29 partnership interest is a voting security.
- 30 (4) Equity security. – Common stock, preferred stock, or an interest in a
31 partnership, or subordinated debt that is convertible into, or entitles the
32 holder to receive upon its exercise, common stock, preferred stock, or
33 an interest in a partnership.
- 34 (5) Financial institution. – A business that is (i) a bank holding company, as
35 defined in the Bank Holding Company Act of 1956, 12 U.S.C. §§ 1841
36 et seq., or its wholly-owned subsidiary, (ii) registered as a broker-dealer
37 under the Securities Exchange Act of 1934, 15 U.S.C. §§ 78a et seq., or
38 its wholly-owned subsidiary, (iii) an investment company as defined in
39 the Investment Company Act of 1940, 15 U.S.C. §§ 80a-1 et seq.,
40 whether or not it is required to register under that act, (iv) a small
41 business investment company as defined in the Small Business
42 Investment Act of 1958, 15 U.S.C. §§ 661 et seq., (v) a pension or
43 profit-sharing fund or trust, or (vi) a bank, savings institution, trust

1 company, financial services company, or insurance company; provided,
2 however, that a business, other than a small business investment
3 company, is not a financial institution if its net worth, when added to the
4 net worth of all of its affiliates, is less than ten million dollars
5 (\$10,000,000); provided further, however, that a business is not a
6 financial institution if it does not generally market its services to the
7 public and it is controlled by a business that is not a financial institution.

8 (6) Repealed by Session Laws 1991, c. 637.

9 (6a) North Carolina Enterprise Corporation. – A corporation established in
10 accordance with Article 3 of Chapter 53A of the General Statutes or a
11 limited partnership in which a North Carolina Enterprise Corporation is
12 the only general partner.

13 (6b) Pass-through entity. – An entity or business, including a limited
14 partnership, a general partnership, a joint venture, a Subchapter S
15 Corporation, or a limited liability company, all of which is treated as
16 owned by individuals or other entities under the federal tax laws, in
17 which the owners report their share of the income, losses, and credits
18 from the entity or business on their income tax returns filed with this
19 State. For the purpose of this Division, an owner of a pass-through
20 entity is an individual or entity who is treated as an owner under the
21 federal tax laws.

22 (7) Qualified business venture. – A ~~North Carolina~~ business that (i) engages
23 primarily in manufacturing, processing, warehousing, wholesaling,
24 research and development, or a service-related industry, and (ii) is
25 registered with the Secretary of State under G.S. 105-163.013.

26 (8) Qualified grantee business. – A ~~North Carolina~~ business that (i) has
27 received during the preceding three years a grant or other funding from
28 the North Carolina Technological Development Authority, the North
29 Carolina Technological Development Authority, Inc., North Carolina
30 First Flight, Inc., the North Carolina Biotechnology Center, the
31 Microelectronics Center of North Carolina, the Kenan Institute for
32 Engineering, Technology and Science, or the Federal Small Business
33 Innovation Research Program, and (ii) is registered with the Secretary of
34 State under G.S. 105-163.013.

35 (9) Repealed by Session Laws 1993, c. 443, s. 1.

36 (9a) Real estate-related business. – A business that is involved in or related
37 to the brokerage, selling, purchasing, leasing, operating, or managing of
38 hotels, motels, nursing homes or other lodging facilities, golf courses,
39 sports or social clubs, restaurants, storage facilities, or commercial or
40 residential lots or buildings is a real estate-related business, except that a
41 real estate-related business does not include (i) a business that purchases
42 or leases real estate from others for the purpose of providing itself with
43 facilities from which to conduct a business that is not itself a real estate-

1 related business or (ii) a business that is not otherwise a real estate-
2 related business but that leases, subleases, or otherwise provides to one
3 or more other persons a number of square feet of space which in the
4 aggregate does not exceed fifty percent (50%) of the number of square
5 feet of space occupied by the business for its other activities.

6 (9b) Selling or leasing at retail. – A business is selling or leasing at retail if
7 the business either (i) sells or leases any product or service of any nature
8 from a store or other location open to the public generally or (ii) sells or
9 leases products or services of any nature by means other than to or
10 through one or more other businesses.

11 (9c) Service-related industry. – A business is engaged in a service-related
12 industry, whether or not it also sells a product, if it provides services to
13 customers or clients and does not as a substantial part of its business
14 engage in a business described in G.S. 105-163.013(b)(4). A business is
15 engaged as a substantial part of its business in an activity described in
16 G.S. 105-163.013(b)(4) if (i) its gross revenues derived from all
17 activities described in that subdivision exceed twenty-five percent
18 (25%) of its gross revenues in any fiscal year or (ii) it is established as
19 one of its primary purposes to engage in any activities described in that
20 subdivision, whether or not its purposes were stated in its articles of
21 incorporation or similar organization documents.

22 (10) Security. – A security as defined in Section 2(1) of the Securities Act of
23 1933, 15 U.S.C. § 77b(1).

24 (11) Subordinated debt. – Indebtedness that (i) by its terms matures five or
25 more years after its issuance, (ii) is not secured, and (iii) is subordinated
26 to all other indebtedness of the issuer issued or to be issued to a
27 financial institution other than a financial institution described in
28 subdivisions (5)(ii) through (5)(v) of this section. Any portion of
29 indebtedness that matures earlier than five years after its issuance is not
30 subordinated debt.

31 **"§ 105-163.011. (Repealed effective for investments made on or after January 1,
32 1999) Tax credits allowed.**

33 (a) No Credit for Brokered Investments. – No credit is allowed under this section
34 for a purchase of equity securities or subordinated debt if a broker's fee or commission or
35 other similar remuneration is paid or given directly or indirectly for soliciting the
36 purchase.

37 ~~Corporations.— Subject to the limitations contained in G.S. 105-163.012, a corporation~~
38 ~~that purchases the equity securities of a North Carolina Enterprise Corporation directly~~
39 ~~from the Enterprise Corporation is allowed as a credit for the taxable year an amount~~
40 ~~equal to twenty five percent (25%) of the amount invested. The aggregate amount of~~
41 ~~credit allowed a corporation for one or more investments in a single taxable year under~~
42 ~~this Division, whether directly or indirectly as owner of a pass-through entity, may not~~

1 exceed seven hundred fifty thousand dollars (\$750,000). The credit is allowed against one
2 or more of the following taxes:

- 3 (1) The income tax imposed by Division I of this Article.
- 4 (2) The franchise tax imposed by G.S. 105-116, 105-120.2, and 105-122.
- 5 (3) The gross premiums tax imposed by G.S. 105-228.5 and G.S. 105-
6 228.8.

7 The credit may not be taken for the year in which the investment is made but shall be
8 taken for the taxable year beginning during the calendar year in which the application for
9 the credit becomes effective as provided in subsection (c) of this section. This
10 subsection does not apply to a corporation that is also a pass-through entity.

11 (b) Individuals. – Subject to the limitations contained in G.S. 105-163.012, an
12 individual who purchases the equity securities or subordinated debt of ~~(i) a qualified~~
13 ~~business venture, (ii) a qualified grantee business, or (iii) a North Carolina Enterprise~~
14 ~~Corporation~~ a qualified business venture or a qualified grantee business directly from that
15 ~~entity~~ business is allowed as a credit against the tax imposed by Division II of this Article
16 for the taxable year an amount equal to twenty-five percent (25%) of the amount
17 invested. The aggregate amount of credit allowed an individual for one or more
18 investments in a single taxable year under this Division, whether directly or indirectly as
19 owner of a pass-through entity, may not exceed fifty thousand dollars (\$50,000). The
20 credit may not be taken for the year in which the investment is made but shall be taken
21 for the taxable year beginning during the calendar year in which the application for the
22 credit becomes effective as provided in subsection (c) of this section.

23 (b1) Pass-Through Entities. – This subsection does not apply to a pass-through
24 entity that has committed capital under management in excess of five million dollars
25 (\$5,000,000) or to a pass-through entity that is a qualified grantee business, a qualified
26 business venture, or a North Carolina Enterprise Corporation. Subject to the limitations
27 provided in G.S. 105-163.012, a pass-through entity that purchases the equity securities
28 or subordinated debt of a qualified grantee ~~business, business or a qualified business~~
29 ~~venture, or a North Carolina Enterprise Corporation~~ venture directly from the business or
30 ~~Corporation~~ is eligible for a tax credit equal to twenty-five percent (25%) of the amount
31 invested. The aggregate amount of credit allowed a pass-through entity for one or more
32 investments in a single taxable year under this Division, whether directly or indirectly as
33 owner of another pass-through entity, may not exceed seven hundred fifty thousand
34 dollars (\$750,000). The pass-through entity is not eligible for the credit for the year in
35 which the investment by the pass-through entity is made but shall be eligible for the
36 credit for the taxable year beginning during the calendar year in which the application for
37 the credit becomes effective as provided in subsection (c) of this section.

38 Each individual who is an owner of a pass-through entity is allowed as a credit against
39 the tax imposed by Division II of this Article for the taxable year an amount equal to the
40 owner's allocated share of the credits for which the pass-through entity is eligible under
41 this subsection. The aggregate amount of credit allowed an individual for one or more
42 investments in a single taxable year under this Division, whether directly or indirectly as
43 owner of a pass-through entity, may not exceed fifty thousand dollars (\$50,000).

1 Each corporation that is an owner of a pass-through entity is allowed as a credit for
2 the taxable year an amount equal to the corporation's allocated share of the tax credits for
3 which the pass-through entity is eligible under this subsection as a result of the pass-
4 through entity's investment in equity securities of a North Carolina Enterprise
5 Corporation. The credit is allowed against one or more of the following taxes:

- 6 (1) The income tax imposed by Division I of this Article.
- 7 (2) The franchise tax imposed by G.S. 105-116, 105-120.2, and 105-122.
- 8 (3) The gross premiums tax imposed by G.S. 105-228.5 and G.S. 105-
9 228.8.

10 The aggregate amount of credit allowed a corporation for one or more investments in
11 a single taxable year under this Division, whether directly or indirectly as owner of a
12 pass-through entity, may not exceed seven hundred fifty thousand dollars (\$750,000).

13 If an owner's share of the pass-through entity's credit is limited due to the maximum
14 allowable credit under this section for a taxable year or if a corporate owner is not eligible
15 for the credit because the investment was not made in a North Carolina Enterprise Corporation,
16 year, the pass-through entity and its owners may not reallocate the unused credit among
17 the other owners.

18 (c) Application. – To be eligible for the tax credit provided in this section, the
19 taxpayer must file an application for the credit with the Secretary on or before April 15 of
20 the year following the calendar year in which the investment was made. The Secretary
21 may grant extensions of this deadline, as the Secretary finds appropriate, upon the request
22 of the taxpayer, except that the application may not be filed after September 15 of the
23 year following the calendar year in which the investment was made. An application is
24 effective for the year in which it is timely filed. The application shall be on a form
25 prescribed by the Secretary and shall include any supporting documentation that the
26 Secretary may require. If an investment for which a credit is applied for was paid for
27 other than in money, the taxpayer shall include with the application a certified appraisal
28 of the value of the property used to pay for the investment. The application for a credit
29 for an investment made by a pass-through entity must be filed by the pass-through entity.

30 (d) Penalties. – The penalties provided in G.S. 105-236 apply in this Division.

31 **"§ 105-163.012. (Repealed effective for investments made on or after January 1,
32 1999) Limit; carry-over; ceiling; reduction in basis.**

33 (a) The credit allowed a taxpayer under G.S. 105-163.011 may not exceed the
34 amount of income tax imposed by Division I or II of this Article, the amount of franchise
35 tax imposed by Article 3 of this Chapter, or the amount of gross premiums tax imposed by
36 Article 8B of this Chapter, as appropriate, Article for the taxable year reduced by the sum of
37 all other credits allowable except tax payments made by or on behalf of the taxpayer. The
38 amount of unused credit allowed under G.S. 105-163.011 may be carried forward for the
39 next five succeeding years. The fifty thousand dollar (\$50,000) and seven hundred fifty
40 thousand dollar (\$750,000) limitations limitation on the amount of credit allowed a taxpayer
41 under G.S. 105-163.011 ~~do~~ does not apply to unused amounts carried forward under this
42 subsection.

1 (b) The total amount of all tax credits allowed to taxpayers under G.S. 105-
2 163.011 for investments made in a calendar year may not exceed six million dollars
3 (\$6,000,000). The Secretary of Revenue shall calculate the total amount of tax credits
4 claimed from the applications filed pursuant to G.S. 105-163.011(c). If the total amount
5 of tax credits claimed for investments made in a calendar year exceeds six million dollars
6 (\$6,000,000), the Secretary shall allow a portion of the credits claimed by allocating a
7 total of six million dollars (\$6,000,000) in tax credits in proportion to the size of the
8 credit claimed by each taxpayer.

- (1) Itinerant merchant. – A person, other than a merchant with an established retail store in the county, who transports an inventory of goods to a building, vacant lot, or other location in a county and who, at that location, displays the goods for sale and sells the goods at retail or offers the goods for sale at retail.
- (2) Peddler. – A person who travels from place to place with an inventory of goods, who sells the goods at retail or offers the goods for sale at retail, and who delivers the identical goods.
- (3) Person. – An individual, a firm, an association, a partnership, a limited liability company, a corporation, a unit of government, or another group acting as a unit.
- (4) Specialty market. – A location, other than a permanent retail store, where space is rented to others for the purpose of selling goods at retail or offering goods for sale at retail.
- (5) Specialty market operator. – A person, other than the State or a unit of local government, who rents space, at a location other than a permanent retail store, to others for the purpose of selling goods at retail or offering goods for sale at retail.
- (6) Specialty market vendor. – A person, other than a merchant with an established retail store in the county, who transports an inventory of goods to a specialty market and, at that location, displays the goods for sale and sells the goods at retail or offers the goods for sale at retail.

"§ 66-251. Itinerant merchant and peddler must have permission of property owner.

An itinerant merchant or a peddler who travels from place to place by vehicle must obtain a written statement signed by the owner or lessee of any property upon which the itinerant merchant or peddler offers goods for sale giving the owner's or lessee's permission to offer goods for sale upon the property of the owner or lessee. This statement must clearly state the name of the owner or lessee, the location of the premises for which the permission is granted, and the dates during which the permission is valid. The statement must be conspicuously and prominently displayed, so as to be visible for inspection by patrons of the itinerant merchant or peddler, at the places or locations at which the goods are to be sold or offered for sale.

"§ 66-252. Display and possession of retail sales tax license.

(a) When Required. – An itinerant merchant must keep the merchant's retail sales tax license conspicuously and prominently displayed, so as to be visible for inspection by patrons of the itinerant merchant at the places or locations at which the goods are to be sold or offered for sale. A peddler must carry the peddler's retail sales tax license when the peddler offers goods for sale and must produce the license upon the request of any customer, State or local revenue agent, or law enforcement agent. A specialty market vendor must keep the retail sales tax license conspicuously and prominently displayed, so

1 as to be visible for inspection by patrons of the specialty market vendor at the places or
2 locations at which the goods are to be sold or offered for sale. A specialty market
3 operator must have its retail sales tax license, if any, available for inspection during all
4 times that the specialty market is open and must produce it upon the request of any
5 customer, State or local revenue agent, or law enforcement agent.

6 (b) Compliance. – The requirement that a retail sales tax license be displayed is
7 satisfied if the vendor displays either of the following:

8 (1) A copy of the license.

9 (2) Evidence that the license has been applied for and the applicable license
10 fee has been paid within 30 days before the date the license was
11 required to be displayed.

12 **"§ 66-253. Display of identification upon request.**

13 Upon the request of any customer, State or local revenue agent, or law enforcement
14 agent, a peddler, an itinerant merchant, a specialty market operator, or a specialty market
15 vendor must provide its name and permanent address. A peddler, itinerant merchant,
16 specialty market operator, or specialty market vendor who is an individual must, upon the
17 request of any customer, State or local revenue agent, or law enforcement agent, provide
18 a valid drivers license, a special identification card issued under G.S. 20-37.7, a military
19 identification, or a passport bearing a physical description of the person named
20 reasonably describing the peddler, itinerant merchant, specialty market operator, or
21 specialty market vendor. A peddler, itinerant merchant, specialty market operator, or
22 specialty market vendor that is a corporation must, upon the request of any customer,
23 State or local revenue agent, or law enforcement agent, give the name and registered
24 agent of the corporation and the address of the registered office of the corporation, as
25 filed with the Secretary of State.

26 **"§ 66-254. Records of source of new merchandise.**

27 (a) Record Required. – Each peddler, itinerant merchant, and specialty market
28 vendor must keep a written record of the source of new merchandise the merchant offers
29 for sale. The record must be a receipt or an invoice from the person who sold the
30 merchandise to the merchant. The receipt or invoice must specifically identify the
31 product being sold by product name and quantity purchased and must contain the
32 complete business name of the seller and a description of the type of business. If the
33 seller was an individual, the receipt or invoice must contain the seller's drivers license
34 number, its state of issuance and expiration date, and the seller's date of birth. The
35 merchant must verify this information by comparing the seller's drivers license to the
36 receipt or invoice and signing the receipt or invoice. A special identification card issued
37 by the Division of Motor Vehicles may be used in place of the seller's drivers license for
38 the purposes of providing and verifying information required under this section. If the
39 seller was a corporation, the receipt or invoice must contain the corporation's federal tax
40 identification number, the state of incorporation, the name and address of the
41 corporation's registered agent in this State, if any, and the corporation's principal office
42 address.

1 (b) Keeping the Record. – Each peddler, itinerant merchant, and specialty market
2 vendor must keep the record required by subsection (a) of this section with the new
3 merchandise being offered for sale. Once the new merchandise is sold, the merchant
4 must keep the record for a period of three years after the date of the sale.

5 (c) Displaying Record or Affidavit. – A peddler, an itinerant merchant, or a
6 specialty market vendor must produce either of the following upon the request of a law
7 enforcement agent:

8 (1) The record required by subsection (a) of this section of the source of
9 new merchandise the merchant offers for sale.

10 (2) An affidavit under oath or affirmation identifying the source of new
11 merchandise the merchant offers for sale, including the name and
12 address of the seller, the license number of any auctioneer seller, and the
13 date and place of purchase of the merchandise.

14 A merchant's failure to produce the requested record or an affidavit within a
15 reasonable time of request by a law enforcement agent is prima facie evidence of
16 possession of stolen property. Pending the production of the requested record or
17 affidavit, the agent may take the merchandise into custody as evidence at the time the
18 request is made. Merchandise impounded under this subsection must be disposed of in
19 accordance with G.S. 15-11.1.

20 (d) Posted Notice. – A specialty market operator must conspicuously post in plain
21 view of all specialty market vendors a sign informing all vendors that failure to produce,
22 upon the request of a law enforcement agent, either the records or affidavit required
23 under this section is prima facie evidence of possession of stolen property.

24 **"§ 66-255. Specialty market registration list.**

25 A specialty market operator must maintain a daily registration list of all specialty
26 market vendors selling or offering goods for sale at the specialty market. The registration
27 list must clearly and legibly show each specialty market vendor's name, permanent
28 address, and retail sales and use tax registration number. The specialty market operator
29 must require each specialty market vendor to exhibit a valid retail sales tax license for
30 visual inspection by the specialty market operator at the time of registration, and must
31 require each specialty market vendor to keep the retail sales tax license conspicuously
32 and prominently displayed, so as to be visible for inspection by patrons of the specialty
33 market vendor at the places or locations at which the goods are offered for sale. Each
34 daily registration list maintained pursuant to this section must be retained by the specialty
35 market operator for no less than two years and must at any time be made available upon
36 request to any law enforcement officer.

37 **"§ 66-256. Exemptions from Article.**

38 This Article does not apply to the following:

39 (1) A peddler or an itinerant merchant who sells only one or more of the
40 following types of merchandise:

41 a. Farm or nursery products produced by the merchant.

42 b. Crafts or goods made by the merchant.

43 c. The merchant's own household personal property.

- 1 d. Printed material.
2 e. Wood for fuel.
3 f. Ice, seafood, meat, poultry, livestock, eggs, dairy products,
4 bread, cakes, or pies.
5 (2) A peddler or an itinerant merchant who is an authorized automobile
6 dealer licensed pursuant to Chapter 20 of the General Statutes.
7 (3) A peddler or an itinerant merchant who is a nonprofit charitable,
8 educational, religious, scientific, or civic organization.
9 (4) A peddler who maintains a fixed permanent location from which at least
10 ninety percent (90%) of the peddler's sales are made but who sells some
11 goods in the county of the fixed location by peddling.
12 (5) An itinerant merchant who meets any of the following descriptions:
13 a. Locates at a farmer's market.
14 b. Is part of the State Fair or an agriculture fair that is licensed by
15 the Commissioner of Agriculture pursuant to G.S. 106-520.3.
16 c. Sells goods at an auction conducted by an auctioneer licensed
17 pursuant to Chapter 85B of the General Statutes.
18 (6) A peddler who complies with the requirements of G.S. 25A-38 through
19 G.S. 25A-42, or who complies with the requirements of G.S. 14-401.13.

20 **"§ 66-257. Misdemeanor violations.**

21 (a) Class 1 Misdemeanors. – A person who does any of the following commits a
22 Class 1 misdemeanor:

- 23 (1) Fails to keep a record of new merchandise and fails to produce a record
24 or an affidavit pursuant to G.S. 66-254.
25 (2) Falsifies a record of new merchandise required by G.S. 66-254.

26 (b) Class 2 Misdemeanors. – A person who does any of the following commits a
27 Class 2 misdemeanor:

- 28 (1) If the person is an itinerant merchant or a specialty market vendor, fails
29 to display the retail sales tax license as required by G.S. 66-252.
30 (2) If the person is a specialty market operator, fails to maintain the daily
31 registration list as required by G.S. 66-255.

32 (c) Class 3 Misdemeanors. – A person who does any of the following commits a
33 Class 3 misdemeanor:

- 34 (1) If the person is a peddler or an itinerant merchant, fails to obtain the
35 permission of the property owner as required by G.S. 66-251.
36 (2) If the person is a peddler or a specialty market operator, fails to produce
37 the retail sales tax license as required by G.S. 66-252.
38 (3) Fails to provide name, address, or identification upon request as
39 required by G.S. 66-253 or provides false information in response to the
40 request.
41 (4) Knowingly gives false information when registering pursuant to G.S.
42 66-255.

1 (d) Defense. – Whenever satisfactory evidence is presented in any court of the fact
2 that permission to use property was not displayed as required by G.S. 66-251 or that a
3 retail sales tax license was not displayed or produced as required by G.S. 66-252, the
4 person charged may not be found guilty of that violation if the person produces in court a
5 valid permission or a valid retail sales tax license, respectively, that had been issued prior
6 to the time the person was charged.

7 **"§ 66-258. Local regulation not affected.**

8 This Article does not affect the authority of a county or city to impose additional
9 requirements on peddlers, itinerant merchants, specialty market vendors, or specialty
10 market operators by an ordinance adopted under G.S. 153A-125 or G.S. 160A-178."

11 12 **PART IV. EFFECTIVE DATES**

13 Sec. 25. Notwithstanding G.S. 105-163.15 and G.S. 105-163.41, no addition to
14 tax may be made under either of those statutes for a taxable year beginning on or after
15 January 1, 1996, and before January 1, 1997, with respect to an underpayment of
16 individual or corporation income tax to the extent the underpayment was created or
17 increased by this act.

18 Sec. 26. This act does not affect the rights or liabilities of the State, a taxpayer,
19 or another person arising under a statute amended or repealed by this act before its
20 amendment or repeal; nor does it affect the right to any refund or credit of a tax that
21 would otherwise have been available under the amended or repealed statute before its
22 amendment or repeal.

23 Prosecutions for offenses committed before the effective date of this act are not
24 abated or affected by this act, and the statutes that would be applicable but for this act
25 remain applicable to those prosecutions.

26 Sec. 27. This act becomes effective as follows:

- 27 (1) Unconstitutional Tax Preferences. – Sections 1 through 5 and 9 and 10
28 of Part I of this act are effective for taxable years beginning on or after
29 January 1, 1996. Section 10.1 of Part I of this act becomes effective
30 November 1, 1996, and applies to taxes paid on or after that date.
- 31 (2) Cap on Qualified Investments. – Section 6 of Part I of this act is
32 effective for investments made on or after January 1, 1996.
- 33 (3) Modify Qualified Business Investment Credits. – Sections 7 and 8 of
34 Part I of this act become effective for investments made on or after
35 January 1, 1997.
- 36 (4) Sales and Use Tax Collection. – Part II of this act becomes effective
37 August 1, 1996.
- 38 (5) Repeal State Privilege License Taxes. – Part III of this act becomes
39 effective July 1, 1997.
- 40 (6) Remainder. – The remainder of this act is effective upon ratification.
