1	A BILL TO BE ENTITLED
2	AN ACT TO CREATE A SPECIAL LICENSE PLATE TO PROMOTE SOIL AND
3	WATER CONSERVATION AND TO PROVIDE THAT A PORTION OF THE
4	SALES REVENUE GOES TO FUND WATER QUALITY AND
5	ENVIRONMENTAL EDUCATION.
6	The General Assembly of North Carolina enacts:
7	Section 1. G.S. 20-79.4 is amended by adding a new subdivision to read:
8	"(22a1) Soil and Water Conservation. – Issuable to the registered owner
9	of a motor vehicle in accordance with G.S. 20-81.12. The plate
10	shall bear a picture appropriate to the subject of water quality and
11	environmental protection in North Carolina and the letters 'WQ'."
12	Section 2. G.S. 20-79.7(a) reads as rewritten:
13	"(a) Fees. – Upon request, the Division shall provide and issue free of charge one
14	registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
15	veteran, and an ex-prisoner of war. All other special registration plates are subject to the
16	regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee
17	in the following amount:
18	Special Plate <u>Additional Fee Amount</u>
19	Historical Attraction \$30.00

10 Section 3. G.S. 20-79.7(b) reads as rewritten: 11 "(b) Distribution of Fees. – The Special Registration Plate Account and the 12 Collegiate and Cultural Attraction Plate Account are established within the Highway 13 Fund. The Division must credit the additional fee imposed for the special registration 14 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the 15 Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage

16 Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

28 Section 4. G.S. 20-81.12 is amended by adding a new subsection to read:

29 "(b5) Soil and Water Conservation Plates. – The Division must receive 300 or more

30 <u>applications for a soil and water conservation plate before the plate may be developed.</u>

31 The Division shall transfer, quarterly, the money in the Collegiate and Cultural Attraction

32 Plate Account derived from the sale of the water quality plates to the Soil and Water

33 <u>Conservation Account established by G.S. 143B-297.1.</u>"

### 36 "<u>§ 143B-297.1. Soil and Water Conservation Account.</u>

The Soil and Water Conservation Account is established as a nonreverting fund and is
subject to the oversight of the State Auditor pursuant to Article 5A of Chapter 147 of the
General Statutes. Revenue derived from the sale of water quality license plates is
credited to the account. The Commission shall use the revenue from the account to fund
environmental education and water quality education in North Carolina."
Section 6. This act becomes effective July 1, 1997.
