Section 1. G.S. 40A-42(a) reads as rewritten:

6 When a local public condemnor is acquiring property by condemnation for a "(a) purpose set out in G.S. 40A-3(b)(1), (4) or (7), or when a city is acquiring property for a 7 purpose set out in G.S. 160A-311(1), (2), (3), (4), (6), or (7), or when a county is 8 9 acquiring property for a purpose set out in G.S. 153A-274(1), (2) or (3), or when a local board of education is acquiring property for any purpose set forth in G.S. 115C-517, or 10 when a condemnor is acquiring property by condemnation as authorized by G.S. 40A-11 3(c)(8), (9), (10) or (12), title to the property and the right to immediate possession shall 12 vest pursuant to this subsection. Unless an action for injunctive relief has been initiated, 13 14 title to the property specified in the complaint, together with the right to immediate possession thereof, shall vest in the condemnor upon the filing of the complaint and the 15 making of the deposit in accordance with G.S. 40A-41." 16

Local boards of education may acquire suitable sites for schoolhouses or other school 1 2 facilities either within or without the local school administrative unit; but no school may 3 be operated by a local school administrative unit outside its own boundaries, although 4 other school facilities such as repair shops, may be operated outside the boundaries of the 5 local school administrative unit. Whenever any such board is unable to acquire or enlarge 6 a suitable site or right-of-way for a school, school building, school bus garage or for a 7 parking area or access road suitable for school buses or for other school facilities by gift 8 or purchase, condemnation proceedings to acquire same may be instituted by such board 9 under the provisions of Chapter 40A of the General Statutes, including the rights and 10 procedures pursuant to G.S. 40A-42(a), et seq., and the determination of the local board of education of the land necessary for such purposes shall be conclusive. A local board 11 12 shall not initiate a proceeding under G.S. 40A-42(a) unless the action is approved by a 13 resolution adopted by the board of county commissioners." Section 3. This act is effective when it becomes law. 14
