3	(b) The immunity provided in subsection (a) of this section applies only to shelter
4	or services:
5	(1) The facility or home care agency is licensed to provide during its
6	ordinary course of business.
7	(2) <u>Provided in accordance with an agreement between the health care</u>
8	facility or home care agency and the emergency management agency.
9	(3) Provided for not more than 45 days after the declaration of the
10	emergency or disaster, unless the 45-day immunity period is extended
11	by an executive order issued by the Governor under the Governor's
12	emergency executive powers.
13	(c) <u>The immunity provided in subsection (a) of this section does not apply if it is</u>
14	determined that the personal injury, wrongful death, property damage, or other loss was
15	caused by the gross negligence, wanton conduct, or intentional wrongdoing of the health
16	care facility or home care agency.
17	(d) <u>The Division of Facility Services may temporarily waive, during disasters or</u>
18	emergencies declared in accordance with Article 1 of Chapter 166A of the General
19	Statutes, any rules of the Commission pertaining to facilities or home care agencies to the
20	extent necessary to allow the facility or home care agency to provide the temporary
21	shelter and temporary services requested by the emergency management agency as
22	authorized by this section. The Division may identify in advance of a declared disaster or
23	emergency rules that may be waived, and the extent the rules may be waived, upon a
24	disaster or emergency being declared in accordance with Article 1 of Chapter 166A of the
25	General Statutes. The Division may also waive rules under this subsection during a
26	declared disaster or emergency upon the request of an emergency management agency
27	and may rescind the waiver if, after investigation, the Division determines the waiver
28	poses an unreasonable risk to the health, safety, or welfare of any of the persons
29	occupying the facility. The emergency management agency requesting temporary shelter
30	or temporary services under this section shall notify the Division within 72 hours of the
31	time the preapproved waivers are deemed by the emergency management agency to
32	apply.
33	(e) <u>As used in this section, 'emergency management agency' is as defined in G.S.</u>
34	<u>166A-4(2)</u> ."
35	Section 2. Article 1 of Chapter 131D of the General Statutes is amended by
36	adding the following new section to read:
37	"§ 131D-7. Limitation on liability for certain adult care homes providing shelter or
38	services during disaster or emergency; waiver of rules.
39	(a) In addition to the applicable limits on liability under G.S. 166A-15, an adult
40	care home licensed under this Article that provides, with or without compensation,
41	temporary shelter or temporary services to individuals during a disaster or emergency
42	declared in accordance with Article 1 of Chapter 166A of the General Statutes, at the
43	request of an emergency management agency implementing an emergency management

1	plan or program approved by the governmental entity having authority over the
2	emergency management agency, is not liable for any personal injury, wrongful death,
3	property damage, or other loss caused by the adult care home's acts or omissions in the
4	provision of shelter or services in accordance with this subsection.
5	(b) The immunity provided in subsection (a) of this section applies only to shelter
6	or services:
7	(1) The adult care home is licensed to provide during its ordinary course of
8	business.
9	(2) Provided in accordance with an agreement between the adult care home
10	and the emergency management agency.
11	(3) Provided for not more than 45 days after the declaration of the
12	emergency or disaster, unless the 45-day immunity period is extended
13	by an executive order issued by the Governor under the Governor's
14	emergency executive powers.
15	(c) The immunity provided in subsection (a) of this section does not apply if it is
16	determined that the personal injury, wrongful death, property damage, or other loss was
17	caused by the gross negligence, wanton conduct, or intentional wrongdoing of the adult
18	care home.
19	(d) The Division of Facility Services may temporarily waive, during disasters or
20	emergencies declared in accordance with Article 1 of Chapter 166A of the General
21	Statutes, any rules of the Commission pertaining to adult care homes to the extent
22	necessary to allow the adult care home to provide the temporary shelter and temporary
23	services requested by the emergency management agency as authorized by this section.
24	The Division may identify in advance of a declared disaster or emergency rules that may
25	be waived, and the extent the rules may be waived, upon a disaster or emergency being
26	declared in accordance with Article 1 of Chapter 166A of the General Statutes. The
27	Division may also waive rules under this subsection during a declared disaster or
28	emergency upon the request of an emergency management agency and may rescind the
29	waiver if, after investigation, the Division determines the waiver poses an unreasonable
30	risk to the health, safety, or welfare of any of the persons occupying the adult care home.
31	The emergency management agency requesting temporary shelter or temporary services
32	under this section shall notify the Division within 72 hours of the time the preapproved
33	waivers are deemed by the emergency management agency to apply.
34	(e) As used in this section, 'emergency management agency' is as defined in G.S.
35	<u>166A-4(2)</u> ."
36	Section 3. This act becomes effective July 1, 1999, and applies to shelter or
37	services provided on and after that date
