

- 1 (1) The voter expects to be absent from the county in which he is registered
2 during the entire period that the polls are open on the day of the
3 specified election in which the voter desires to vote;
- 4 (2) The voter is unable to be present at the voting place to vote in person on
5 the day of the specified election in which the voter desires to vote
6 because of the voter's sickness or other physical ~~disability~~. disability;
- 7 (3) The voter is incarcerated, whether in the voter's county of residence or
8 elsewhere, shall be entitled to vote by absentee ballot in the county of
9 the voter's residence in any election, specified herein, in which the voter
10 otherwise would be entitled to vote. Absentee voting shall be in the
11 same manner as provided in this Article. The chief custodian or
12 superintendent of the institution or other place of confinement shall
13 certify that the applicant is not a felon, and the certification shall be as
14 prescribed by the State Board of Elections. The State Board of
15 Elections is authorized to prescribe procedures to carry out the intent
16 and purpose of this subsection;
- 17 (3a) The voter because of the observance of a religious holiday pursuant to
18 the tenets of the voter's religion will be unable to cast a ballot at the
19 polling place on the day of the election; or
- 20 (4) The voter is an employee of the county board of elections or a precinct
21 official, observer, or ballot counter, in another precinct and the voter's
22 assigned duties on the day of the election will cause the voter to be
23 unable to be present at the voting place to vote in person and provided
24 such employee has the application witnessed by the chairman of the
25 county board of elections.

26 (a1) No-Excuse Absentee Voting for One-Stop in General Elections Only. – The
27 only type of absentee voting that is not subject to the excuse requirements of subsection
28 (a) of this section is one-stop voting as provided in G.S. 163-227.2 for elections held on
29 the day of the general elections in November of even-numbered years.

30 (b) Absentee Ballots; Exceptions. – Notwithstanding the authority contained in
31 G.S. 163-226(a), absentee ballots shall not be permitted in fire district elections.

32 (c) The Term 'Election'. – As used in this Subchapter, unless the context clearly
33 requires otherwise, the term 'election' includes a general, primary, second primary, runoff
34 election, bond election, referendum, or special election."

35 Section 2. G.S. 163-226.1 reads as rewritten:

36 "**§ 163-226.1. Absentee voting in primary.**

37 A qualified voter may vote by absentee ballot in a ~~statewide or countywide~~ partisan
38 primary provided he—the qualified voter is affiliated, at the time he—the qualified voter
39 makes application for absentee ballots, with the political party in whose primary he—the
40 qualified voter wishes to vote—vote, except that an unaffiliated voter may vote in a party
41 primary if permitted under G.S. 163-119. The official registration records of the county
42 in which the voter is registered shall be proof of whether ~~he—the qualified voter is~~

1 affiliated with a political party and of the party, if any, with which ~~he~~ the qualified voter
2 is affiliated."

3 Section 3. G.S. 163-226.3 reads as rewritten:

4 **"§ 163-226.3. Certain acts declared felonies.**

5 (a) Any person who shall, in connection with absentee voting in any ~~primary,~~
6 ~~general, municipal or special~~ election held in this State, do any of the acts or things
7 declared in this section to be unlawful, shall be guilty of a Class I felony. It shall be
8 unlawful:

9 (1) For any person except the voter's near relative ~~as defined in G.S. 163-~~
10 ~~227(e)(4)~~ or the voter's verifiable legal guardian to assist the voter to
11 vote an absentee ballot when the voter is voting an absentee ballot other
12 than under the procedure described in G.S. 163-227.2; provided that if
13 there is not a near relative or legal guardian available to assist the voter,
14 the voter may request some other person to give assistance;

15 (2) For any person to assist a voter to vote an absentee ballot under the
16 absentee voting procedure authorized by G.S. 163-227.2 except a
17 member of the county board of elections, the director of elections, an
18 employee of the board authorized by the board, the voter's near relative
19 ~~as defined in G.S. 163-227(e)(4)~~, or the voter's verifiable legal guardian;

20 (3) For a voter who votes an absentee ballot under the procedures
21 authorized by G.S. 163-227.2 to vote ~~his~~ that voter's absentee ballot
22 outside of the voting booth or private room provided to ~~him~~ the voter
23 for that purpose in or adjacent to the office of the county board of
24 elections or at the additional site provided by G.S. 163-227.2(f1), or to
25 receive assistance in getting to and from the voting booth or private
26 room and in preparing and marking ~~his~~ that voter's ballots from any
27 person other than a member of the county board of elections, the
28 director of elections, an employee of the board of elections authorized
29 by the board, a near relative of the voter ~~as defined in G.S. 163-~~
30 ~~227(e)(4)~~, or the voter's verifiable legal guardian;

31 (4) For any owner, manager, director, employee, or other person, other than
32 the voter's near relative ~~as defined in G.S. 163-227(e)(4)~~ or verifiable
33 legal guardian, to make a written request pursuant to G.S. 163-230.1 or
34 an application on behalf of a registered voter who is a patient in any
35 hospital, clinic, nursing home or rest home in this State or for any
36 owner, manager, director, employee, or other person other than the
37 voter's near relative or verifiable legal guardian, ~~or officer authorized to~~
38 ~~administer oaths acting pursuant to G.S. 163-231(a)(1)~~, to mark the
39 voter's absentee ballot or assist such a voter in marking an absentee
40 ballot;

41 (5) Repealed by Session Laws 1987, c. 583, s. 8.

42 (6) For any person to take into ~~his~~ that person's possession for delivery to a
43 voter or for return to a county board of elections the absentee ballot of

1 any voter, provided, however, that this prohibition shall not apply to a
2 voter's near relative ~~as defined in G.S. 163-227(e)(4)~~ or the voter's
3 verifiable legal guardian;

- 4 (7) Except as provided in subsections (1), (2), (3), and (4) of this section,
5 G.S. 163-231(a), G.S. 163-250(a), and G.S. 163-227.2(e), for any voter
6 to permit another person to assist ~~him~~ the voter in marking ~~his~~ that
7 voter's absentee ballot, to be in the voter's presence when a voter votes
8 an absentee ballot, or to observe the voter mark ~~his~~ that voter's absentee
9 ballot.

10 (b) The State Board of Elections or a county board of elections, upon receipt of a
11 sworn affidavit from any qualified voter of the State or the county, as the case may be,
12 attesting to first-person knowledge of any violation of subsection (a) of this section, shall
13 transmit ~~such~~ that affidavit to the appropriate district attorney, who shall investigate and
14 prosecute any person violating subsection (a)."

15 Section 4. G.S. 163-227 is repealed.

16 Section 5. G.S. 163-227.1 reads as rewritten:

17 "**§ 163-227.1. Second primary; applications for absentee ballots for voting in second**
18 **primary.**

19 A voter applying for an absentee ballot for a primary election who will be ~~absent from~~
20 ~~the county of his residence~~ eligible to vote under this Article on the day of the primary
21 and second primary shall be permitted by the county board of elections to indicate ~~such~~
22 that fact on ~~his~~ that voter's application and ~~such~~ that voter shall automatically be issued
23 an application and absentee ballot for the second primary if one is called. The county
24 board of elections shall consider ~~such~~ that indication a separate request for application for
25 the second primary and, at the proper time, shall enter ~~such~~ that voter's name in the
26 absentee register along with the listing of other applicants for absentee ballots for the
27 second primary.

28 In addition, a voter entitled to absentee ballots under the provisions of this Article
29 who did not make application for the primary or who failed to apply for a second primary
30 ballot at the time of application for a first primary ballot may ~~apply for~~ make a written
31 request for absentee ballots for a second primary not earlier than the day a second
32 primary is called and not later than 5:00 P.M. ~~on the Tuesday prior to the date on which~~
33 ~~the second primary is held~~ the date and time provided by G.S. 163-230.1.

34 All procedures with respect to absentee ballots in a second primary shall be the same
35 as with respect to absentee ballots in a first primary except as otherwise provided by this
36 section."

37 Section 6. G.S. 163-227.2 reads as rewritten:

38 "**§ 163-227.2. Alternate procedures for requesting application for absentee ballot;**
39 **'one-stop' voting procedure in board office.**

40 (a) ~~A~~ Except as provided in subsection (a1) of this section, a person expecting to
41 be absent from the county in which ~~he~~ that person is registered during the entire period
42 that the polls are open on the day of an election in which absentee ballots are authorized
43 or is eligible under G.S. 163-226(a)(2), 163-226(a)(3a), or 163-226(a)(4) may request an

1 application for absentee ballots, complete the application, ~~receive the absentee ballots,~~
2 ~~vote and deliver them sealed in a container return envelope to the county board of~~
3 ~~elections in the county in which he is registered and vote~~ under the provisions of this
4 section.

5 (a) The excuse requirements of G.S. 163-226(a) do not apply to one-stop voting
6 for elections held on the day of the general elections in November of even-numbered
7 years.

8 (b) Not earlier than the first business day after the twenty-fifth day before an
9 election, in which absentee ballots are authorized, in which ~~he a voter~~ seeks to vote and
10 not later than 5:00 P.M. ~~p.m.~~ on the Friday prior to that election, the voter shall appear in
11 person only at the office of the county board of ~~elections and elections,~~ elections, except as
12 provided in subsection (f1) of this section. That voter shall enter the voting enclosure at
13 the board office through the appropriate entrance and shall at once state his or her name
14 and place of residence to an authorized member or employee of the board. In a primary
15 election, the voter shall also state the political party with which the voter affiliates and in
16 whose primary the voter desires to vote, or if the voter is an unaffiliated voter permitted
17 to vote in the primary of a particular party under G.S. 163-119, the voter shall state the
18 name of the authorizing political party in whose primary he wishes to vote. The board
19 member or employee to whom the voter gives this information shall announce the name
20 and residence of the voter in a distinct tone of voice. After examining the registration
21 records, an employee of the board shall state whether the person seeking to vote is duly
22 registered. If the voter is found to be registered that voter may request that the chairman,
23 a member, authorized member or the director of elections of the board, or an employee of
24 the board of elections, authorized by the board, furnish him the voter with an application
25 form as specified in G.S. 163-227. The voter shall complete the application in the
26 presence of the chairman, member, director of elections or authorized member or
27 employee of the board, and shall deliver the application to that person.

28 (c) If the application is properly filled out, the ~~chairman, member, director of~~
29 ~~elections of the board, or employee of the board of elections, authorized by the board,~~
30 authorized member or employee shall enter the voter's name in the register of absentee
31 ballot applications requests, applications, and ballots issued; shall furnish the voter with
32 the instruction sheets called for by G.S. 163-229(c); and shall furnish the voter with the
33 ballots to which the application for absentee ballots applies; and shall furnish the voter
34 with a container return envelope. applies. The voter thereupon shall comply with the
35 ~~provisions of G.S. 163-231(a) except that he shall deliver the container return envelope to~~
36 ~~the chairman, member, supervisor of elections of the board, or an employee of the board~~
37 ~~of elections, authorized by the board, immediately after making and subscribing the~~
38 ~~certificate printed on the container return envelope as provided in G.S. 163-229(b). vote~~
39 in accordance with subsection (e) of this section.

40 All actions required by this subsection shall be performed in the office of the board of
41 ~~elections elections,~~ elections, except that the voting may take place in an adjacent room as
42 provided by subsection (e) of this section. For the purposes of this section only, the The
43 application under this subsection shall be signed in the presence of the chairman,

1 member, director of elections of the board, or full-time employee, authorized by the
2 board who shall sign the application and certificate as the witness and indicate the official
3 title held by him or her. Notwithstanding G.S. 163-231(a), in the case of this subsection,
4 only one witness shall be required on the certificate.

5 (d) Only the chairman, ~~member-member, employee,~~ or director of elections of the
6 board shall keep the voter's application for absentee ballots ~~and the sealed container-~~
7 ~~return envelope~~ in a safe place, separate and apart from other applications and container-
8 return envelopes. ~~At the first meeting of the board pursuant to G.S. 163-230(2) held after~~
9 ~~receipt of the application and envelope, the chairman shall comply with the requirements~~
10 ~~of G.S. 163-230(1) and G.S. 163-230(2) b. and c. If the voter's application for absentee~~
11 ~~ballots is approved by the board at that meeting, the application form and container-return~~
12 ~~envelope, with the ballots enclosed, shall be handled in the same manner and under the~~
13 ~~same provisions of law as applications and container return envelopes received by the~~
14 ~~board under other provisions of this Article. If the voter's application for absentee ballots~~
15 ~~is disapproved by the board, the board shall so notify the voter stating the reason for~~
16 ~~disapproval by first-class mail addressed to the voter at his-that voter's residence address~~
17 ~~or-and~~ at the address shown in the application for absentee ballots; and the board
18 ~~chairman shall retain the container return envelope in its unopened condition until the~~
19 ~~day of the primary or election to which it relates and on that day he shall destroy the~~
20 ~~container return envelope and the ballots therein, without, however, revealing the manner~~
21 ~~in which the voter marked the ballots.~~ enter a challenge under G.S. 163-89.

22 (e) The voter shall vote ~~his-that voter's~~ absentee ballot in a voting booth in the
23 office of the county board of elections, and the county board of elections shall provide a
24 voting booth for that purpose, provided however, that the county board of elections may
25 in the alternative provide a private room for the voter adjacent to the office of the board,
26 in which case the voter shall vote ~~his-that voter's~~ absentee ballot in that room. ~~The voting~~
27 ~~booth shall be in the office of the county board of elections.~~ If the voter needs assistance
28 in getting to and from the voting booth and in preparing and marking ~~his-that voter's~~
29 ballots or if ~~he-the voter~~ is a blind voter, only a member of the county board of elections,
30 the director of elections, an employee of the board of elections authorized by the board, a
31 near relative of the voter ~~as defined in G.S. 163-227(e)(4),~~ or the voter's verifiable legal
32 guardian shall be entitled to assist the voter.

33 (e1) If a county uses a voting system with retrievable ballots, that county's board of
34 elections may by resolution elect to conduct one-stop absentee voting according to the
35 provisions of this subsection. In a county in which the board has opted to do so, a one-
36 stop voter shall cast the ballot and then shall deposit the ballot in the ballot box or voting
37 system in the same manner as if such box or system was in use in a precinct on election
38 day. At the end of each business day, or at any time when there will be no employee or
39 officer of the board of elections on the premises, the ballot box or system shall be secured
40 in accordance with a plan approved by the State Board of Elections, which shall include
41 that no additional ballots have been placed in the box or system. Any county board
42 desiring to conduct one-stop voting according to this subsection shall submit a plan for
43 doing so to the State Board of Elections. The State Board shall adopt standards for

1 conducting one-stop voting under this subsection and shall approve any county plan that
2 adheres to its standards. The county board shall adhere to its State Board-approved plan.
3 The plan shall provide that each one-stop ballot shall have a ballot number on it in
4 accordance with G.S. ~~163-230(3)a.~~ 163-230.1(a2), or shall have an equivalent identifier
5 to allow for retrievability. The standards shall address retrievability in one-stop voting on
6 direct record electronic equipment where no paper ballot is used.

7 (f) Notwithstanding the exception specified in G.S. 163-36, counties which
8 operate a modified full-time office shall remain open five days each week during regular
9 business hours consistent with daily hours presently observed by the county board of
10 elections, commencing with the date prescribed in G.S. 163-227.2(b) and continuing until
11 5:00 ~~P.M.~~ p.m. on the Friday prior to that election or primary. The boards of county
12 commissioners shall provide necessary funds for the additional operation of the office
13 during ~~such~~ that time.

14 (f1) Notwithstanding any other provision of this section, a county board of
15 elections by unanimous vote of all its members may provide for one or more sites in that
16 county for absentee ballots to be applied for and cast under this section. Any site other
17 than the county board of elections office shall be in any building or part of a building that
18 the county board of elections is entitled under G.S. 163-129 to demand and use as a
19 voting place. Every individual staffing any of those sites shall be a member or full-time
20 employee of the county board of elections or an employee of the county board of
21 elections whom the board has given training equivalent to that given a full-time
22 employee. Those sites must be approved by the State Board of Elections as part of a Plan
23 for Implementation approved by both the county board of elections and by the State
24 Board of Elections which shall also provide adequate security of the ballots and
25 provisions to avoid allowing persons to vote who have already voted. The Plan for
26 Implementation shall include a provision for the presence of political party observers at
27 each one-stop site equivalent to the provisions in G.S. 163-45 for party observers at
28 voting places on election day."

29 Section 7. G.S. 163-228 reads as rewritten:

30 "**§ 163-228. Register of absentee ~~ballot applications~~ requests, applications, and**
31 **ballots issued; a public record.**

32 The State Board of Elections shall ~~design~~ approve an official register and ~~provide a~~
33 ~~source of supply thereof from in~~ which the ~~chairman~~ of the county board of elections in
34 each county of the State shall ~~purchase a book to be called the register of absentee ballot~~
35 ~~applications and ballots issued in which shall be recorded~~ record the following
36 information:

(c) Instruction Sheets. – In time for use not later than 50 days before a statewide primary, general or county bond election, the county board of elections shall prepare and print a sufficient number of sheets of instructions on how voters are to prepare absentee ballots and return them to the ~~chairman of the~~ county board of elections."Section 9. G.S. 163-230 is repealed.

Section 10. G.S. 163-230.1 reads as rewritten:

"§ 163-230.1. Simultaneous issuance of absentee ballots with application.

(a) When a A qualified voter personally requests by mail who is eligible to vote by absentee ballot under G.S. 163-226(a)(1), or that voter's near relative or verifiable legal guardian, shall request in writing an application for absentee ballots, so that the county board of elections receives the request not later than 5:00 p.m. on the Tuesday before the election. an application for absentee ballots, The county board of elections shall enter in the register of absentee requests, applications, and ballots issued the information required in G.S. 163-228 as soon as each item of that information becomes available. Upon

1 receiving the application, the county board of elections shall cause to be mailed to that
2 voter in a single package:

3 (1) ~~The official ballots the voter is entitled to vote if his application is~~
4 ~~approved; vote;~~

5 (2) ~~A container-return envelope for the ballots, upon the outside of which~~
6 ~~shall be printed the appropriate application form as provided in G.S.~~
7 ~~163-227; printed in accordance with G.S. 163-229; and~~

8 (3) ~~A large envelope (similar to a No. 14 or larger manila envelope) in~~
9 ~~which the container return envelope with the ballots may be returned~~

12 (4) ~~An instruction sheet.~~

13 The ballots, ~~envelopes envelope,~~ and instructions shall be mailed to the voter by the
14 county board's ~~chairman, secretary or director~~ chairman, member, officer, or employee as
15 determined by the board and entered in ~~its official minutes.~~ the register as provided by
16 this Article.

17 ~~On the back of the large transmittal envelope shall be clearly printed or stamped the~~
18 ~~following statement:~~

23 (a1) Absence for Sickness or Physical Disability. – Notwithstanding the provisions
24 of subsection (a) of this section, if a voter expects to be unable to go to the voting place to
25 vote in person on election day because of that voter's sickness or other physical disability,
26 that voter or that voter's near relative or verifiable legal guardian may make written
27 request in person for absentee ballots to the board of elections of the county in which the
28 voter is registered after 5:00 p.m. on the Tuesday before the election but not later than
29 5:00 p.m. on the day before the election. The county board of elections shall enter in the
30 register of absentee requests, applications, and ballots issued the information required in
31 G.S. 163-228 as soon as each item of that information becomes available. The county
32 board of elections shall personally deliver to the requester in a single package:

33 (1) The official ballots the voter is entitled to vote;

34 (2) A container-return envelope for the ballots, printed in accordance with
35 G.S. 163-229; and

36 (3) An instruction sheet.

37 (a2) Delivery of Absentee Ballots and Container-Return Envelope to Applicant. –
38 When the county board of elections receives a request for applications and absentee
39 ballots, the board shall promptly issue and transmit them to the voter in accordance with
40 the following instructions:

41 (1) On the top margin of each ballot the applicant is entitled to vote, the
42 chair, a member, officer, or employee of the board of elections shall
43 write or type the words 'Absentee Ballot No.' or an abbreviation

1 approved by the State Board of Elections and insert in the blank space
2 the number assigned the applicant's application in the register of
3 absentee requests, applications, and ballots issued. That person shall not
4 write, type, or print any other matter upon the ballots transmitted to the
5 absentee voter. Alternatively, the board of elections may cause to be
6 barcoded on the ballot the voter's application number, if that barcoding
7 system is approved by the State Board of Elections.

8 (2) The chair, member, officer, or employee of the board of elections shall
9 fold and place the ballots (identified in accordance with the preceding
10 instruction) in a container-return envelope and write or type in the
11 appropriate blanks thereon, in accordance with the terms of G.S. 163-
12 229(b), the absentee voter's name, the absentee voter's application
13 number, and the designation of the precinct in which the voter is
14 registered. If the ballot is barcoded under this section, the envelope may
15 be barcoded rather than having the actual number appear. The person
16 placing the ballots in the envelopes shall leave the container-return
17 envelope holding the ballots unsealed.

18 (3) The chair, member, officer, or employee of the board of elections shall
19 then place the unsealed container-return envelope holding the ballots
20 together with printed instructions for voting and returning the ballots, in
21 an envelope addressed to the voter at the post office address stated in the
22 request, seal the envelope, and mail it at the expense of the county board
23 of elections: Provided, that in case of a request received after 5:00 p.m.
24 on the Tuesday before the election under the provisions of subsection
25 (a1) of this section, in lieu of transmitting the ballots to the voter in
26 person or by mail, the chair, member, officer, or employee of the board
27 of elections may deliver the sealed envelope containing the instruction
28 sheet and the container-return envelope holding the ballots to a near
29 relative or verifiable legal guardian of the voter.

30 The county board of elections may receive written requests for applications earlier
31 than 50 days prior to the election but shall not mail applications and ballots to the voter or
32 issue applications and ballots in person earlier than 50 days prior to the election, except
33 as provided in G.S. 163-227.2. No election official shall issue applications for absentee
34 ballots except in compliance with this Article.

35 (b) The application shall be ~~completed,~~ completed and signed by the voter
36 personally, the ballots marked, the ballots sealed in the container-return envelope, and the
37 large envelope affidavit certificate completed as provided in G.S. 163-227 and G.S. 163-
38 231. The container-return envelope shall be placed in the large transmittal envelope for
39 return to the chairman of the county board of elections.

40 (c) At its next official meeting after return of the completed container-return
41 envelope and large envelope with the voter's ballots, the county board of elections shall
42 determine whether the container-return envelope and large envelope have has been
43 properly executed. If the board determines that ~~both~~ the container-return envelope and

1 ~~large envelope have~~ has been properly executed, it shall approve the application and
2 deposit the container-return envelope with other container-return envelopes for the
3 envelope to be opened and the ballots counted at the same time as all other container-
4 return envelopes and absentee ballots.

5 (c1) Required Meeting of County Board of Elections. – During the period
6 commencing on the third Tuesday before an election, in which absentee ballots are
7 authorized, the county board of elections shall hold one or more public meetings each

20 final subject only to such review as may be necessary in the event of an election contest.

13 witnesses, and shall indicate their address. When thus executed, the sealed container-

1 Section 23. Article 3 of Chapter 163 of the General Statutes is amended by
2 adding a new section to read:

4 The Executive Secretary-Director, as chief State elections official, may exercise
5 emergency powers to conduct an election in a district where the normal schedule for the
6 election is disrupted by any of the following:

7 (1) A natural disaster.
