April 15, 1999 A BILL TO BE ENTITLED AN ACT TO MAKE IT A CLASS 2 MISDEMEANOR TO USE IN TELEPHONIC COMMUNICATIONS WITH ANOTHER PERSON ANY WORDS LANGUAGE THREATENING THAT PERSON'S MINOR CHILD, AND TO MAKE IT A CLASS 1 MISDEMEANOR TO WILLFULLY THREATEN PHYSICAL INJURY TO THE MINOR CHILD OF ANOTHER. The General Assembly of North Carolina enacts: Section 1. G.S. 14-196(a) reads as rewritten: It shall be unlawful for any person: "(a) To use in telephonic communications any words or language of a (1) profane, vulgar, lewd, lascivious or indecent character, nature or connotation: To use in telephonic communications any words or language threatening (2) to inflict bodily harm to any person or to that person's minor child or other dependent or physical injury to the property of any person, or for the purpose of extorting money or other things of value from any person; (3) To telephone another repeatedly, whether or not conversation ensues,

for the purpose of abusing, annoying, threatening, terrifying, harassing

or embarrassing any person at the called number;
