PROGRAM(S) AFFECTED: The University of North Carolina General Administration

EFFECTIVE DATE: This act is effective when it becomes law.

BILL SUMMARY:

The bill authorizes the construction and financing, without appropriations from the General Fund, of capital improvement projects of the constituent institutions of the University of North Carolina. Section 5 of the bill allows construction and financing through lease arrangements with nonprofit corporations.

ASSUMPTIONS AND METHODOLOGY: The chart on the following pages was compiled with the assistance of the Associate Vice President - Finance for the University of North Carolina. The chart shows the cost to construct and operate the proposed campus buildings and the source of funds for each facility. The effect of the debt on students is also shown. No General Fund dollars are involved in the projects.
