A BILL TO BE ENTITLED

AN ACT TO MAKE A TECHNICAL CORRECTION TO THE LAW CLARIFYING THE STATUS OF TEACHERS PARTICIPATING IN FOREIGN EXCHANGE PROGRAMS FOR PURPOSES OF RETIREMENT AND TENURE.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 135-1(25) reads as rewritten:

7 "(25) "Teacher" shall mean any teacher, helping teacher, classroom teacher 8 in a job-sharing position as defined in G.S. 115C-302.2(b) except for a in that position, librarian, principal, supervisor, 9 beneficiary superintendent of public schools or any full-time employee, city or 10 county, superintendent of public instruction, or any full-time employee 11 of Department of Public Instruction, president, dean or teacher, or any 12 full-time employee in any educational institution supported by and 13 under the control of the State: Provided, that the term "teacher" shall 14 not include any part-time, temporary, or substitute teacher or employee 15 except for a classroom teacher in a job-sharing position, and shall not 16 include those participating in an optional retirement program provided 17 for in G.S. 135-5.1 or G.S. 135-5.4. In all cases of doubt, the Board of 18 Trustees, hereinbefore defined, shall determine whether any person is a 19 teacher as defined in this Chapter. On and after August 1, 2001, a 20 person who is a nonimmigrant alien and who otherwise meets the 21 22 requirements of this subdivision shall not be excluded from the definition of "teacher" solely because the person holds a temporary or 23 time-limited visa. Notwithstanding the foregoing, the term "teacher" 24 shall not include any nonimmigrant alien employed in elementary or 25 secondary public schools (whether employed in a full-time, part-time, 26 temporary, permanent, or substitute teacher position) and participating 27
