A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE AN
"IN GOD WE TRUST" SPECIAL REGISTRATION PLATE WITH THE
PROCEEDS GOING TO THE AUBREY MCLELLAN SOLDIER AND AIRMAN
ASSISTANCE FUND FOR FAMILIES OF DEPLOYED NORTH CAROLINA
NATIONAL GUARDSMEN.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b) reads as rewritten:

"(b) Every license plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted".

Except as otherwise provided in this subsection, a registration plate issued by the Division for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and numerals. The background of the plate shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be approved by the Division and the State Highway Patrol for clarity and ease of identification.

- (1) Friends of the Great Smoky Mountains National Park.
- (2) Rocky Mountain Elk Foundation.

- 1 (3) Blue Ridge Parkway Foundation.
- 2 (4) Friends of the Appalachian Trail.
- 3 (5) NC Coastal Federation.
- 4 (6) In God We Trust."

5 **SECTION 2.** G.S. 20-79.4(b) is amended by adding a new subdivision to
6 read:

7 "(b) Types. – The Division shall issue the following types of special registration
8 plates:

9 ...
10 (19a) In God We Trust. – Issuable to the registered owner of a motor vehicle
11 in accordance with G.S. 20-81.12. The plate shall bear the phrase 'In
12 God We Trust.'

13 ~~(19a)~~(19b) International Association of Fire Fighters. – Issuable to a member of
14 the International Association of Fire Fighters. The plate shall bear the
15 logo of the International Association of Fire Fighters. The Division
16 may not issue the plate authorized by this subdivision unless it receives
17 at least 300 applications for the plate."

18 **SECTION 3.** G.S. 20-79.7(a) reads as rewritten:

19 **"§ 20-79.7. Fees for special registration plates and distribution of the fees.**

20 (a) Fees. – Upon request, the Division shall provide and issue free of charge one
21 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
22 veteran, and an ex-prisoner of war. All other special registration plates, including
23 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
24 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
25 G.S. 20-88 plus an additional fee in the following amount:

SECTION 4. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

32 **SECTION 5.** G.S. 20-81.12 is amended by adding a new subsection to read:
33 "(b31) In God We Trust. – The Division must receive 300 or more applications for
34 the In God We Trust plate before the plate may be developed. The Division shall
35 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
36 derived from the sale of the In God We Trust plates to The Minuteman Partnership for
37 Progress and Prosperity, Inc. for the benefit of the Aubrey McLellan Soldier and
38 Airman Assistance Fund to help provide assistance to the families of North Carolina
39 National Guardsmen who have been activated and deployed in federal service."

40 **SECTION 6.** This act is effective when it becomes law.
