Short Title: Township ABC Elections. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO PERMIT CERTAIN TOWNSHIP ABC ELECTIONS.
3 The General Assembly of North Carolina enacts:

4 **SECTION 1.** G.S. 18B-600(f) reads as rewritten:

5 "(f) Township Elections. – An election may be called on any of the propositions
6 listed in G.S. 18B-602 in any township located within:

7 (1) A county where ABC stores have heretofore been established by
8 petition pursuant to law.

9 (2) A county where ABC stores have been established pursuant to law, in
10 which county according to data from the North Carolina Department
11 of Commerce: (i) one-third or more of the employment is travel
12 related, (ii) spending on travel exceeds four hundred million dollars
13 (\$400,000,000) per year, and where the entirety of two townships
14 consists of one island (and several smaller islands not making up more
15 than one percent (1%) of the total land area of the two townships)
16 where that island:

17 a. Has a population of 4,000 or over according to the most recent
18 decennial federal census;

19 b. Is located with one side facing the ocean and another side
20 facing a coastal sound.

21 (3) A county, bordering on a county eligible for township elections
22 pursuant to subdivision (1) of this subsection, where the sales of
23 alcoholic beverages are not authorized countywide and where six
24 municipalities have authorized the sale of alcoholic beverages and
25 where one municipality approved alcoholic beverage control stores but
26 they are currently out of business.

1 In the case of subdivision (2) of this section, an election may be called in the two
2 townships voting together on the proposition contained in G.S. 18B-602(h).

3 The election shall be held by the county board of elections upon request of the
4 county board of commissioners or upon petition of twenty-five percent (25%) of the
5 registered voters of the township, or in the case of subdivision (2) of this section, of the
6 two townships taken together. The county board of commissioners in any county
7 authorized to hold township elections pursuant to subdivision (3) of this subsection may
8 establish a different process under which the residents of townships in that county may
9 petition the board to call for the township elections. The election shall be conducted and
10 the results determined in the same manner as county elections held under this Article.
11 For purposes of this Article, townships holding any election under this subsection shall
12 be treated on the same basis as counties, and municipalities located within those
13 townships shall be treated on the same basis as cities. In the case of an election under
14 subdivision (2) of this subsection, the votes of the two townships counted together shall
15 determine the result of the election.

16 In order for an establishment to qualify for a permit under this subsection, the
17 establishment's gross receipts from food and nonalcoholic beverages shall be greater
18 than its gross receipts from alcoholic beverages."

19 **SECTION 2.** This act is effective when it becomes law.
