AN ACT TO SET THE COMPENSATION PAID BY THE DIVISION OF MOTOR VEHICLES TO CONTRACT AGENCIES.

4 The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(h) reads as rewritten:

Commission Contracts for Issuance of Plates and Certificates. - All 6 "(h) 7 registration plates, registration certificates, and certificates of title issued by the 8 Division, outside of those issued from the Raleigh offices of the Division and those 9 issued and handled through the United States mail, shall be issued insofar as practicable 10 and possible through commission contracts entered into by the Division for the issuance 11 of the plates and certificates in localities throughout North Carolina with persons, firms, 12 corporations or governmental subdivisions of the State of North Carolina. The Division shall make a reasonable effort in every locality, except as noted above, to enter into a 13 14 commission contract for the issuance of the plates and certificates and a record of these efforts shall be maintained in the Division. In the event the Division is unsuccessful in 15 16 making commission contracts, it shall issue the plates and certificates through the 17 regular employees of the Division. Whenever registration plates, registration certificates, and certificates of title are issued by the Division through commission 18 contract arrangements, the Division shall provide proper supervision of the distribution. 19 20 Nothing contained in this subsection will allow or permit the operation of fewer outlets 21 in any county in this State than are now being operated.

22 Commission contracts entered into by the Division under this subsection shall 23 provide for the payment of compensation on a per transaction basis. The commission contracts shall set forth what services are included in each transaction category. The 24 25 collection of the highway use tax shall be considered a separate transaction for which one dollar and twenty-seven cents (\$1.27) compensation shall be paid. The performance 26 at the same time of one or more of the remaining transactions listed in this subsection 27 shall be considered a single transaction for which one dollar and forty-three cents 28 (\$1.43) compensation shall be paid. 29
