

- 1 (1) Condition. The applicant's general condition must reflect adequate
2 capital, liquidity, reserves, earnings, and asset composition necessary
3 for safe and sound operation of the resulting bank.
- 4 (2) Management. The management and the board of directors must be
5 capable of supervising a sound banking operation and overseeing the
6 changes that must be accomplished in the conversion from an
7 association or savings bank to a bank.
- 8 (3) Public Convenience. The ~~Commission~~ Commissioner ~~must determine that the~~
9 conversion will have a positive impact on the convenience of the
10 public and will not substantially reduce the services available to the
11 public in the market area.
- 12 (4) Transition. Within a reasonable time after the effective date of the
13 conversion, the resulting bank must divest itself of all assets and
14 liabilities that do not conform to State banking law or rules. The length
15 of this transition period shall be determined by the Commissioner and
16 shall be specified when the application for conversion is approved.

17 In evaluating each of these conditions, the ~~Commission~~ Commissioner shall consider
18 a comparison of the relevant financial ratios of the applicant with the average ratios of
19 North Carolina banks of similar asset size. The ~~Commission may~~ Commissioner shall
20 not approve a conversion where the applicant presents an undue supervisory concern or
21 has not been operated in a safe and sound manner."

22 **SECTION 3.** G.S. 53-17.2(f) reads as rewritten:

23 "(f) If the ~~State Banking Commission~~ Commissioner approves the plan of
24 conversion, then the association or savings bank shall submit the plan to the
25 stockholders or members as provided in subsection (g). After approval of the plan of
26 conversion, the Commissioner of Banks shall supervise and monitor the conversion
27 process and shall ensure that the conversion is conducted pursuant to law and the
28 association's or savings bank's approved plan of conversion."

29 **SECTION 4.** G.S. 53-43 reads as rewritten:

30 "**§ 53-43. General powers. Powers.**

37 ~~by receiving deposits, by buying and selling exchange, coin, and~~

40 ~~not take and receive interest or discounts in advance where the~~
41 ~~effective rates of interest or discounts collected shall exceed the~~
42 ~~maximum rates of interest provided under this section, G.S. 24 1.1 and~~
43 ~~24 1.2 if such interest or discount had not been collected in advance.~~

- 1 ~~(2) To adopt regulations for the government of the corporation not~~
2 ~~inconsistent with the Constitution and laws of this State.~~
- 3 ~~(3) To purchase, hold, and convey real estate for the following purposes:~~
4 ~~a. Such as shall be necessary for the convenient transaction of its~~
5 ~~business, including furniture and fixtures, with its banking~~
6 ~~offices and other spaces to rent as a source of income, which~~
7 ~~investment shall not exceed fifty percent (50%) of its~~
8 ~~unimpaired capital fund: Provided, that this fifty percent (50%)~~
9 ~~limitation shall not apply to banking houses, furniture and~~
10 ~~fixtures leased for the purposes set forth in this subdivision.~~
11 ~~Provided, further, that if any bank shall demonstrate to the~~
12 ~~satisfaction of the Commissioner of Banks that an investment of~~

25 ~~judgments or decrees obtained and rendered for debts due to it,~~

27 ~~property referred to in this subdivision shall be sold by such~~

31 ~~Any and all powers and privileges heretofore granted and given~~
32 ~~to any person, firm, or corporation doing a banking business in~~
33 ~~connection with a fiduciary and insurance business, or the right~~
34 ~~to deal to any extent in real estate, inconsistent with this~~
35 ~~Chapter, are hereby repealed.~~
- 36 ~~(4) Nothing contained in this section shall be deemed to authorize banking~~
37 ~~corporations to engage in the business of dealing in investment~~
38 ~~securities: Provided, however, that the term "dealing in investment~~
39 ~~securities" as used herein, shall not be deemed to include the~~
40 ~~purchasing and selling of securities without recourse, solely upon~~
41 ~~order, and for the account of, customers; and provided further, that~~
42 ~~"investment securities," as used herein, shall not be deemed to include~~
43 ~~obligations of the United States, or general obligations of any state or~~
44 ~~of any political subdivision thereof, or of cities, towns, or other~~

1 corporate municipalities of any state or obligations issued under
2 authority of the Federal Farm Loan Act, as amended, or issued by the
3 federal home loan banks or the Home Owner's Loan Corporation.

4 Any provision in conflict with this subdivision contained in the
5 articles of incorporation heretofore issued to any banking corporation
6 is hereby revoked.

8 (6) Maintain separate departments and deposit in its commercial
9 department to the credit of its trust department all uninvested fiduciary
10 funds of cash and secure, under rules and regulations of the State
11 Banking Commission, all such deposits in the name of the trust
12 department whether in consolidated deposits or for separate fiduciary
13 accounts, by segregating and delivering to the trust department such
14 securities as may be eligible for the investment of the sinking funds of
15 the State of North Carolina, equal in market value to such deposited
16 funds, or readily marketable commercial bonds having not less than a
17 recognized "A" rating equal to one hundred and twenty five per
18 centum (125%) of such deposits. Such securities shall be held by the
19 trust department as security for the full payment or repayment of all
20 such deposits, and shall be kept separate and apart from other assets of
21 the trust department. Until all of such deposits shall have been
22 accounted for to the trust department or to the individual fiduciary
23 accounts, no creditor of the bank shall have any claim or right to such
24 security. When fiduciary funds are deposited by the trust department in
25 the commercial department of the bank, the deposit thereof shall not be
26 deemed to constitute a use of such funds in the general business of the
27 bank and the bank in such instance shall not be liable for interest on
28 such funds. To the extent and in the amount such deposits may be
29 insured by the Federal Deposit Insurance Corporation, the amount of
30 security required for such deposits by this section may be reduced.

31 The Banking Commission shall have power to make such rules and
32 regulations as it may deem necessary for the enforcement of the
33 provisions of the preceding paragraph, and such authority shall exist
34 and is hereby conferred under the general authority heretofore
35 conferred upon said Commission as well as by this paragraph.

36 (7) To issue, advise and confirm letters of credit authorizing the
37 beneficiaries thereof to draw upon the institution or its correspondents.

38 (8) To receive money for transmission.

39 (9) To become a member of a clearinghouse association and to pledge
40 assets required for its qualification.

41 (10) To provide for the performance of bank service corporation services,
42 such as data processing services and bookkeeping, subject to such
43 rules and regulations as may be adopted by the State Banking
44 Commission.

1 (a) General Powers. – Except as otherwise specifically provided by this Chapter,
2 a bank shall have the powers conferred upon corporations by the North Carolina
3 Business Corporation Act, Chapter 55 of the General Statutes, including the power to:

- 4 (1) Carry on the business of banking.
5 (2) Make any investments authorized by G.S. 53-47 or any other section
6 of this Chapter.
7 (3) Engage in any other activities approved by rule, order, or interpretation
8 of the Commissioner of Banks.

9 For the purposes of this section, the "business of banking" includes, without
10 limitation, discounting and negotiating promissory notes, drafts, bills of exchange, and
11 other evidences of indebtedness; receiving deposits; issuing, advising, and confirming
12 letters of credit; receiving money for transmission; and loaning money on personal
13 security or real or personal property.

14 (b) Parity Powers. – A bank also has the power to engage:

- 15 (1) As principal in any activity permissible for a national bank under any
16 law, including the National Bank Act, 12 U.S.C. § 21, as well as
17 activities recognized as permissible for a national bank in any
18 regulation, official circular, bulletin, order or written interpretation
19 issued by the Office of the Comptroller of the Currency.
20 (2) As principal in any activity that is permissible, or determined by the
21 Federal Deposit Insurance Corporation to be permissible, for a bank
22 under the Federal Deposit Insurance Act, 12 U.S.C. § 1813, and
23 regulations thereunder.
24 (3) As principal in any activity that is permissible for a savings and loan
25 association or savings bank organized, respectively, under Chapters
26 54B and 54C of the General Statutes, or that is permissible for a
27 federally chartered savings association or federally chartered savings
28 bank under the Home Owners' Loan Act of 1933, 12 U.S.C. § 1461
29 through §1468 and regulations thereunder.
30 (4) In "trust business", as that term is defined by G.S. 53-301(50).
31 (5) In any activity other than as principal pursuant to the Federal Deposit
32 Insurance Act, 12 U.S.C. § 1813, and regulations thereunder.

33 (c) Incidental Powers. – In addition to the other powers described in this section,
34 a bank has the power to exercise all other powers that are reasonably necessary,
35 convenient, or complementary to the exercise of the powers authorized in subsections
36 (a) and (b) of this section.

37 (d) Prior Approval Required. – Except as provided in subsection (e) of this
38 section, a bank which proposes to engage in any new activity shall apply to the
39 Commissioner of Banks for approval to engage in the activity before its
40 commencement. If the activity will be conducted in a subsidiary in which the bank
41 intends to make an investment, the bank shall apply to the Commissioner of Banks for
42 approval to engage in the activity before entering into the investment. The bank shall
43 not engage in the activity or make the investment unless and until the Commissioner of
44 Banks issues a written approval of the application. For the purpose of this subsection,

1 the terms "subsidiary" and "investment" have the same meanings as set forth in G.S.
2 53-47.

3 An application for approval shall contain a description of the proposed activity and
4 any other information required by the Commissioner of Banks. A copy of any notice or
5 application the bank is required to file with any federal banking regulator shall also be
6 provided to the Commissioner of Banks.

7 For the purposes of this section, a "new activity" is any business activity in which
8 the bank is not currently engaged. The extension or relocation of an existing activity
9 into a new department, division, or subsidiary of the bank shall not be considered a
10 "new activity"; provided, however, that any investment in a subsidiary shall be subject
11 to all applicable provisions of this Chapter pertaining to investments by banks,
12 including G.S. 53-47.

13 (e) Exceptions. – No application for approval to engage in a new activity shall be
14 required, provided all of the following conditions are met as of the date the activity is
15 commenced:

16 (1) The activity is one described in subsections (a), (b), or (c) of this
17 section.

18 (2) The bank has received a composite rating of 1 or 2 under the Uniform
19 Financial Institutions Rating System in connection with its most recent
20 examination.

21 (3) No notice or application to engage in the activity is required to be filed
22 by the bank with any federal banking regulator.

23 A bank commencing an activity without prior application and approval pursuant to
24 this subsection shall notify the Commissioner of Banks in writing of the commencement
25 of the activity no later than the 30th day after the earlier of (i) commencing the activity;
26 or (ii) if applicable, making an investment in an entity through which the activity is to
27 be conducted.

28 (f) Continuing Authority of the Commissioner of Banks. – Nothing in this
29 section shall be construed as being in derogation of the Commissioner of Banks'
30 ongoing authority under this Chapter to take corrective action regarding the activities of
31 any bank which the Commissioner deems appropriate in order to ensure the continued
32 integrity, safety, and soundness of an individual bank and the State banking system in
33 general."

34 **SECTION 5.** G.S. 53-47 reads as rewritten:

35 **"§ 53-47. Limitations on ~~investments in stocks~~ subsidiary and other investments.**

36 (a) In addition to any powers or investments authorized by any other section of
37 this Chapter, a bank may invest in the capital stock or other securities of any other state,
38 national or foreign bank or trust company, and in any other industrial bank, savings
39 bank, Morris Plan bank, savings and loan association, bankers' bank or other deposit
40 taking entity chartered or existing under any federal, state, or foreign law including, but
41 not limited to, the capital stock of clearing corporations defined in G.S. 25-8-102, the
42 capital stock or other securities of central reserve banks whose capital stock exceeds one
43 million dollars (\$1,000,000) and the capital stock of an Edge or Agreement corporation.
44 As used in this Chapter, the term "bankers' bank" means an insured depository financial

1 institution, organized and chartered to do business exclusively with other banks and
2 savings institutions, and the stock of which, or the stock of the holding company which
3 controls such bank, is owned exclusively (except to the extent directors' qualifying
4 shares are required by law) by banks or savings institutions. To constitute a central
5 reserve bank as contemplated by this Chapter, at least fifty percent (50%) of the capital
6 stock of such bank shall be owned by other banks. The investment of any bank in the
7 capital stock of such central reserve bank or bank organized under the "Edge Act", (12
8 U.S.C. § 611 et seq.) shall at no time exceed ten percent (10%) of the paid-in capital and
9 permanent surplus of the bank making the investment.

10 (b) ~~A bank may invest, without limitation, in a corporation, firm, partnership, or~~
11 ~~company:~~

12 (1) ~~Which is a bank operating subsidiary, or~~

13 (2) ~~To protect the bank from loss.~~

14 A bank may make an investment in a subsidiary that will be operated as a bank
15 operating subsidiary or as a DPC subsidiary. Investments made pursuant to this
16 subsection shall not be subject to the seventy-five percent (75%) of unimpaired capital
17 fund limit contained in subsection (c) of this section.

18 (c) ~~In addition to the foregoing, upon 30 days prior written notice to the~~
19 ~~Commissioner of Banks, providing such detail as the Commissioner may require, a~~
20 ~~bank may invest, invest up to, in the aggregate, up to seventy-five percent (75%) of its~~
21 ~~unimpaired capital fund in the stock or assets of other corporations, firms, partnerships,~~
22 ~~or companies which are: subsidiaries which are or will be primarily engaged in:~~

23 (1) ~~Primarily engaging in activities~~ Activities permissible for national
24 banks or bank holding companies under applicable laws, rules,
25 regulations or orders;

26 (2) ~~Primarily engaging in activities of a financial nature, Activities that~~
27 are financial in nature or incidental to a financial activity, including the
28 transmission or processing of information or data relating to such
29 activities. For the purpose of this subsection, activities of a financial
30 nature shall include, but not be limited to, that are financial in nature
31 include insurance activities, all forms of securities activities, including
32 underwriting, distribution, and brokerage, together with such and any
33 other activities as the Commissioner of Banks shall determine by
34 regulation rule or order; or

35 (3) ~~Engaging in any other activity approved by the Commissioner of~~
36 ~~Banks. Other activities determined by the Commissioner of Banks to be~~
37 permissible for a bank or a bank operating subsidiary.

38 (c1) A bank operating subsidiary may make an investment of any size in a lower
39 tier subsidiary.

40 (c2) A bank or bank operating subsidiary proposing to make an investment
41 described in subsection (b), (c), or (c1) of this section shall give prior written notice to
42 the Commissioner of Banks, providing such detail as the Commissioner may require.
43 Unless the Commissioner of Banks, within 30 days following receipt of the notice,
44 notifies the bank or bank operating subsidiary that the Commissioner objects to the

1 proposed investment, the bank or bank operating subsidiary may complete the
2 investment. However, the Commissioner of Banks may extend the period within which
3 to object to the proposed investment if the Commissioner determines that it raises issues
4 which require additional information or additional time for analysis. If the objection
5 period is so extended, the bank or bank operating subsidiary may proceed with respect
6 to the proposed investment.

7 (d) Any state or national bank subsidiary which engages in an activity subject to
8 licensure and/or regulation under other than Chapter 53 of the General Statutes shall be
9 subject to licensure and/or regulation on a basis that does not arbitrarily discriminate by
10 the appropriate regulatory agency which licenses and/or regulates nonbanks which
11 engage in the same activity.

12 ~~(e) Unless otherwise notified by the Commissioner within 30 days following~~
13 ~~receipt of the written notice, a bank may complete its investment in the stock or assets~~
14 ~~of the other corporation, firm, partnership, or company, or commence a new activity~~
15 ~~through an existing subsidiary. The Commissioner may extend the 30 day period if the~~
16 ~~Commissioner determines that the proposed investment or activity raises issues which~~
17 ~~require additional information or additional time for analysis. If the 30 day period is~~
18 ~~extended, the bank may proceed with respect to the proposed investment or activity only~~
19 ~~upon written approval of the Commissioner of Banks.~~

20 (f) The Commissioner of Banks shall monitor the impact of investment activities
21 of banks under this section on the safety and soundness of such banks. Any stocks
22 owned or hereafter acquired in excess of the limitations herein imposed shall be
23 disposed of at public or private sale within six months after the date of acquiring the
24 stocks, and if not so disposed of, they shall be charged to profit and loss account, and no
25 longer carried on the books as an asset. The limit of time in which said stocks shall be
26 disposed of or charged off the books of the bank may be extended by the Commissioner
27 of Banks if in the Commissioner's judgment it is for the best interest of the bank that
28 such extension be granted; provided that the limitations imposed in this section on the
29 ownership of stock in or securities of corporations are suspended only to the extent that
30 any bank operating under the supervision of the Commissioner of Banks may subscribe
31 for and purchase shares of stock in or debentures, bonds, or other types of securities of
32 any corporation organized under the laws of the United States for the purposes of
33 insuring to depositors a part or all of their funds on deposit in banks where and to such
34 extent as such stock or security ownership is required in order to obtain the benefits of
35 such deposit insurance for its depositors.

36 (g) The prior notice requirement of subsection (c2) of this section shall not apply
37 if:

38 (1) The bank has received a composite rating of 1 or 2 under the Uniform
39 Financial Institutions Rating System in connection with its most recent
40 examination at the time of the investment; and

41 (2) Each activity of the subsidiary in which the investment is to be made is
42 either:

43 a. One in which the bank is then engaged or has previously been
44 engaged, directly or through a different subsidiary, and for

1 which all necessary approvals of federal bank regulatory
2 agencies and of the Commissioner of Banks have previously
3 been obtained and remain in effect; or

- 4 b. One for which no prior notice or application for approval to any
5 federal banking regulator is required.

6 A bank that makes an investment pursuant to the exception created by this
7 subsubsection shall nevertheless notify the Commissioner of Banks in writing of the
8 investment within 30 days thereafter.

9 (h) A bank may invest through purchase, lease, or otherwise in any interest in
10 bank premises, furniture, equipment, and fixtures as may be necessary for the
11 convenient transaction of its business. The total of all investments authorized by this
12 subsubsection shall not exceed fifty percent (50%) of the bank's unimpaired capital fund;
13 provided, however, that the value of leased bank premises, furniture, equipment, and
14 fixtures shall be included in the bank's total investments only to the extent that the
15 related lease may be capitalized under current generally accepted accounting principles
16 consistently applied.

17 If any bank demonstrates to the satisfaction of the Commissioner of Banks that an
18 investment of more than fifty percent (50%) of its unimpaired capital fund in its bank
19 premises, furniture, equipment, and fixtures would promote the convenience of the
20 general public in transacting its banking business and would not adversely affect the
21 financial stability of the bank, the Commissioner of Banks may authorize the bank to
22 invest more than fifty percent (50%) of its unimpaired capital funds in its bank
23 premises, furniture, equipment, and fixtures.

24 (i) A bank may purchase, hold, and convey real estate other than bank premises
25 for the following purposes:

- 26 (1) As security for loans made or moneys due to it when that real estate
27 has been mortgaged to it in good faith.
28 (2) When the real estate has been purchased at sales upon foreclosures of
29 mortgages and deeds of trust held or owned by it, on judgments or
30 decrees obtained and rendered for debts due to it, or in settlements
31 affecting security of those debts. All real property referred to in this
32 subdivision shall be sold by the bank within five years after it is
33 acquired unless, upon application by the board of directors, the
34 Commissioner of Banks extends the time within which the sale shall
35 be made.

36 (j) Nothing in this section shall be construed as being in derogation of the
37 Commissioner of Banks' ongoing authority under this Chapter to take corrective action
38 regarding the activities of any bank which the Commissioner deems appropriate in order
39 to ensure the continued integrity, safety, and soundness of an individual bank and the
40 State banking system in general.

41 (k) The following definitions apply in this section:

- 42 (1) "Bank operating subsidiary" means a subsidiary which:
43 a. Is under the control of a bank; and

- 1 b. Engages only in activities in which a bank may engage pursuant
2 to G.S. 53-43.
- 3 (2) "Bank premises" means any improved or unimproved real estate,
4 whether or not open to the public, which is utilized, intended to be
5 utilized, or has previously been utilized in connection with any activity
6 or business in which the bank is or was engaged or intends to be
7 engaged.
- 8 (3) "Control" means an ownership interest in a subsidiary which:
9 a. Constitutes more than fifty percent (50%) of the total ownership
10 interests in the subsidiary; or
11 b. Constitutes fifty percent (50%) or less of the total ownership
12 interests in the subsidiary but is required to be consolidated
13 with the bank pursuant to generally accepted accounting
14 principles.
- 15 (4) "DPC subsidiary" means any subsidiary in which the bank has
16 acquired in good faith an ownership interest through foreclosure or
17 other realization on collateral by way of a compromise of a disputed or
18 contested claim or to avoid a loss in connection with a debt previously
19 contracted.
- 20 (5) "Lower-tier subsidiary" means any bank operating subsidiary in which
21 a bank operating subsidiary has an ownership interest.
- 22 (6) "Ownership interest" means any beneficial equity or similar interest,
23 whether direct or indirect, including stock, limited or general
24 partnership interests, or shares in a limited liability company.
- 25 (7) "Subsidiary" means any corporation, partnership, business trust,
26 association, joint venture, pool, syndicate, limited liability company, or
27 any other similar business organization in which a bank has an
28 ownership interest."

29 **SECTION 6.** G.S. 53-48 reads as rewritten:

30 **"§ 53-48. Limitation of loans.**

31 (a) The total loans and extensions of credit, both direct and indirect, by a bank to
32 a person, other than a municipal corporation for money borrowed, including in the
33 liabilities of a firm the liabilities of the several members thereof, outstanding at one time
34 and not fully secured, as determined in a manner consistent with subsection (b) of this
35 section, by collateral having a market value at least equal to the amount of the loan or
36 extension of credit shall not exceed the greater of fifteen percent (15%) of the
37 unimpaired capital fund of the ~~bank.~~ bank or the percentage permitted for national banks
38 in this State or by statute or regulation of the Comptroller of the Currency.

39 (b) The total loans and extensions of credit, both direct and indirect, by a bank to
40 a person outstanding at one time and fully secured by readily marketable collateral
41 having a market value, as determined by reliable and continuously available price
42 quotations, at least equal to the amount of the ~~funds—~~ loan or extension of credit
43 outstanding shall not exceed the greater of ten percent (10%) of the unimpaired capital
44 fund of the ~~bank.~~ bank or the percentage permitted for national banks by statute or

1 regulation of the Comptroller of the Currency. This limitation shall be separate from and
2 in addition to the limitation contained in subsection (a) ~~above of this section.~~

3 (c) The discount of bills of exchange drawn in good faith against actual existing
4 values, the discount of solvent trade acceptances or other solvent commercial or
5 business paper actually owned by the person negotiating the same, loans or extensions
6 of credit secured by a segregated deposit account in the lending bank, the purchase of
7 bankers acceptances of the kind described in section 13 of the Federal Reserve Act and
8 issued by other banks, and the purchase of any notes and the making of any loans,
9 secured by not less than a like face amount of bonds of the United States, or an agency
10 of the United States, or other obligations guaranteed by the United States Government,
11 or State of North Carolina or certificates of indebtedness of the United States, or agency
12 thereof, or other obligations guaranteed by the United States Government, shall not be
13 considered as money borrowed within the meaning of this section: Provided, however,
14 that the limitations of this section shall not apply to loans or obligations to the extent
15 that they are secured or covered by guarantees or by commitments or agreements to take
16 over or purchase the same, made by any federal reserve bank or by the United States or

24 ~~the bank.~~ bank and under the name of the bank as set forth in its
25 Certificate of Incorporation filed with the Office of the Secretary of
26 State, except that the Commissioner of Banks may permit the
27 operation of a branch or limited service facility under an assumed
28 name under the conditions and terms imposed by the Commissioner if

8 ~~requirements of that type of banking office.~~

9 Upon 30 days written notice to the Commissioner of Banks, a bank may discontinue
10 any limited service facility operation; provided, however, if a limited service facility has
11 within five years preceding the proposed closing date been a branch of any bank, it shall
12 comply with the requirements of subsection (e) below before closing. operation.

13 (d1) Subject to such rules and regulations as may be prescribed by the State
14 Banking Commission with regard to their use, maintenance and supervision, any bank
15 may establish off the premises of any principal office, branch or limited service facility
16 a customer-bank communications terminal, point-of-sale terminal, automated teller
17 machine, automated banking facility or other direct or remote information-processing
18 device or machine, whether manned or unmanned, through or by means of which
19 information relating to any financial service or transaction rendered to the public is
20 stored and transmitted, instantaneously or otherwise, to or from a bank or other nonbank
21 terminal; and the establishment and use of such a device or machine shall not be
22 deemed a branch or limited service facility, and the capital requirements and standards
23 for approval of a branch or limited service facility, all as set forth in subsections (b) and
24 (c) of this section, shall not be applicable to the establishment of any such off-premises
25 terminal device or machine.

26 (e) A bank may, upon resolution by the board of directors, discontinue a branch
27 office subject to the following:

28 (1) The bank shall notify the Commissioner in writing of its intent to close

31 to close a branch and statistical or other information in support of such

23 prior approval of the Commissioner. The Commissioner shall not give approval for a
24 bank to purchase any portion of its shares of stock unless the Commissioner determines
25 the bank will remain well-capitalized following the purchase. In approving a purchase,
26 the Commissioner may impose any conditions that are prudent and necessary to protect
27 the interests of the shareholders and creditors of the bank."

30 section shall be in addition to and not in derogation of any specific rule-making
31 authority by any other provision of this Chapter."

33 **"§ 53-160. License to do business.**

34 Before any such bank or trust company is authorized to act in any fiduciary capacity
35 without bond, it must be licensed by the Commissioner of Banks of the State. For such

35 principal or a branch manager shall consent to a federal and State
36 criminal history record check and submit a set of that individual's

2 revoking that person's license as a mortgage broker or mortgage
3 banking industry or denying or revoking that person's license as
4 a mortgage broker or mortgage banker.

6 character, or general fitness requirements under G.S. 53-243.05
7 or any bond or capital requirements under this Article.
8 h. Has been the executive officer or controlling shareholder or

10 mortgage banker who has been subject to an order or injunction
11 described in sub-subdivision d., e., or f. of this subdivision.
12 i. Has failed to pay the proper filing or renewal fee under this
13 Article. However, the Commissioner may enter only a denial
14 order under this sub-subdivision, and the Commissioner shall
15 vacate the order when the deficiency has been corrected."
