1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
3 NATIONAL MULTIPLE SCLEROSIS SOCIETY SPECIAL REGISTRATION
4 PLATE.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

7 "(b) Types. – The Division shall issue the following types of special registration
8 plates:

9 ...

10 (27j) National Multiple Sclerosis Society. – Issuable to the registered owner
11 of a motor vehicle in accordance with G.S. 20-81.12. The plate shall
12 have the logo of the National Multiple Sclerosis Society and the
13 telephone number "1-800-FIGHT MS" on the plate. The Division shall
14 not use the name and logo of the National Multiple Sclerosis Society
15 unless the National Multiple Sclerosis Society licenses, without
16 charge, the State to use the name and logo on the plate. The Division
17 must receive 300 or more applications for the plate before it may be
18 developed."

19 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

20 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
21 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
22 veteran, and an ex-prisoner of war. All other special registration plates, including
23 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
24 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
25 G.S. 20-88 plus an additional fee in the following amount:

3 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

4 "(b) Distribution of Fees. – The Special Registration Plate Account and the
 5 Collegiate and Cultural Attraction Plate Account are established within the Highway
 6 Fund. The Division must credit the additional fee imposed for the special registration
 7 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 8 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 9 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 10 Trust Fund, which is established under G.S. 113-44.15, as follows:

18 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:
19 "(b39) National Multiple Sclerosis Society. – The Division must receive 300 or more
20 applications for the National Multiple Sclerosis Society plate before the plate may be
21 developed. The Division shall transfer quarterly the money in the Collegiate and
22 Cultural Attraction Plate Account derived from the sale of the National Multiple
23 Sclerosis Society plates to the National Multiple Sclerosis Society, a North Carolina
24 nonprofit corporation, for its public awareness programs."

25 **SECTION 5.** This act is effective when it becomes law.
