A BILL TO BE ENTITLED

1  
2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
3 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF  
4 REPRESENTATIVES AND THE PRESIDENT PRO TEMPORE OF THE  
5 SENATE, TO MAKE TECHNICAL CHANGES TO VARIOUS TERMS, AND TO  
6 AMEND THE APPOINTMENT OF THE MEMBERSHIP OF THE EDENTON  
7 HISTORICAL COMMISSION.

8       Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
9 appointments to public offices upon the recommendation of the Speaker of the House of  
10 Representatives and the President Pro Tempore of the Senate; and

11       Whereas, the Speaker of the House of Representatives and President Pro  
12 Tempore of the Senate have made recommendations; Now, therefore,  
13 The General Assembly of North Carolina enacts:

36 "**§ 143B-98. Edenton Historical Commission – members; selection; compensation;**  
37 **quorum.**

38           The Edenton Historical Commission shall consist of 33 members, ~~18-22~~ appointed  
39 by the Governor to serve at his pleasure, ~~12 elected by the Commission from time to~~  
40 ~~time according to the procedure it adopts, members appointed by the Governor~~ four  
41 appointed by the President Pro Tempore of the Senate, four appointed by the Speaker of  
42 the House of Representatives, and, ex officio, the Mayor of the Town of Edenton, the  
43 Chairman of the Board of Commissioners of Chowan County, and the Secretary of  
44 Cultural Resources or his designee.

1 All the present members of the Commission may continue to serve, at the pleasure  
2 of the Governor, until the end of his present term of office. The Commission shall elect  
3 its own officers, and the members of the Commission shall serve without pay and  
4 without expense allowance from State funds. The Commission shall determine its  
5 requirements for a quorum."

6 **SECTION 3.1.(b)** Members of the Edenton Historical Commission  
7 appointed by the Governor as of July 1, 2005, shall continue to serve at the pleasure of  
8 the Governor. Members of the Edenton Historical Commission elected by the  
9 Commission as of July 1, 2005, shall no longer serve unless subsequently appointed.
