A HOUSE RESOLUTION ADOPTING REFORM RULES OF THE HOUSE OF 1 2 REPRESENTATIVES FOR THE SHORT SESSION OF THE 2005 HOUSE OF 3 **REPRESENTATIVES.** 4 Be it resolved by the House of Representatives: 5 SECTION 1. The permanent rules of the House of Representatives as 6 adopted by House Resolution 318, 2005 Regular Session, read as rewritten: 7 "I. Order of Business 8 RULE 1. Convening Hour, Limitation on Friday, Night, and Sunday 9 Legislative Sessions. – The House shall convene each legislative day at the hour fixed by the House. In the event the House adjourns on the preceding legislative day without 10 having fixed an hour for reconvening, the House shall convene on the next legislative 11 12 day at 2:00 P.M. During January and February of 2005, no sessions may be held on Friday. No session shall continue after 10:00 P.M. on Monday nor after 9:00 P.M. on 13 any other days, and the Speaker shall adjourn the House without motion at that point, 14 except that a motion may be made as to the time and day of next convening. No session 15 shall be held on Sunday. The actual time shall govern the applicability of this rule and 16 the clock in the chamber shall not be followed if the time on the clock is not the 17 18 accurate time. 19 RULE 2. Opening the Session. – At the convening hour on each legislative day, the Speaker shall call the members to order and shall have the session opened with 20 prayer. At the convening hour on the first day of each legislative week, the Speaker, or 21 22 the Speaker's designee, shall lead the members in the Pledge of Allegiance to the 23 American Flag. 24 RULE 3. Quorum. – (a) A quorum consists of a majority of the qualified 25 members of the House.

(b) Should the point of a quorum be raised, the doors shall be closed, and
the Clerk shall call the roll of the House, after which the names of those not responding
shall again be called. In the absence of a quorum, 15 members are authorized to compel

the attendance of absent members and may order that absentees for whom no sufficient 1 2 excuses are made be taken into custody wherever they may be found by special 3 messenger appointed for that purpose. RULE 4. Approval of Journal. – (a) The Standing Committee on Rules, 4 5 Calendar, and Operations of the House shall cause the Journal of the House to be 6 examined daily before the hour of convening to determine if the proceedings of the 7 previous day have been correctly recorded. Immediately following the opening prayer and upon appearance of a 8 (b) 9 quorum, the Speaker shall call for the Journal report by the Chair of the Standing 10 Committee on Rules, Calendar, and Operations of the House, or by a Representative designated by the Chair, as to whether the proceedings of the previous day have been 11 12 correctly recorded. Without objection, the Speaker shall cause the Journal to stand 13 approved. 14 RULE 5. Order of Business of the Day. – After the approval of the Journal 15 of the preceding day, unless otherwise ordered by the Speaker, requested by the Speaker or a member of the House, and approved by a majority of the members present, the 16 17 House shall proceed to business in the following order: 18 The receiving of petitions, memorials, and papers addressed to the (1)General Assembly or to the House; 19 Messages from the Governor: 20 (1a)21 (2)Ratification of bills; Reports of standing committees and permanent subcommittees; 22 (3) Reports of select committees: 23 (4) Reports of referral by standing committee Chairs of bills to permanent 24 (5) 25 subcommittees; 26 (6)First reading and reference to committee of bills and resolutions; 27 Messages from the Senate; (7)Concurrence with Senate 28 (8) amendments or Senate committee 29 substitutes: 30 (9) The unfinished business of the preceding day; Calendar (each category in accordance with Rule 40): (10)31 Local bills (roll call), third reading 32 a. 33 Local bills (roll call), second reading b. 34 Local bills, third reading c. 35 d. Local bills, second reading Public bills (roll call), third reading 36 e. Public bills (roll call), second reading f. 37 Public bills and resolutions, third reading 38 g. 39 Public bills and resolutions, second reading; h. Reading of notices and announcements. 40 (11)**II.** Conduct of Debate 41 42 RULE 6. Duties and Powers of the Speaker. - The Speaker shall have general general direction of the Hall. Hall, subject to more specific provisions of these 43 44 rules. The Speaker may name any member to perform the duties of the chair, but

substitution shall not extend beyond one day, except in the case of sickness or by leave 1 2 of the House. If the Speaker is absent and has not designated a member to perform the 3 duties of the chair, the Principal Clerk shall preside during such absence. In the case of a 4 vacancy in the office of the Speaker of the House of Representatives, the Principal 5 Clerk shall preside over the House until the House elects a Speaker. 6 RULE 7. Obtaining Floor. - (a) When any member desires recognition for 7 any purpose, the member shall rise and respectfully address the Speaker. No member 8 shall proceed until recognized by the Speaker for a purpose. When any member desires 9 recognition for a purpose that requires recognition, the member shall rise and 10 respectfully address the Speaker. When a member is seeking recognition, the Speaker may not decline to recognize that member unless a call of the question has been 11 12 sustained pursuant to Rule 19 on the question to which the member desires to be recognized. No member shall proceed until recognized by the Speaker. The Speaker has 13 14 the right to inquire for what purpose a member arises to ascertain whether the member 15 proposes business that is in order. It is the duty of the Speaker to accept or to entertain any proper motion or other matter whenever it is in order. The Speaker may not refuse 16 17 to recognize a member for a purpose that is out of order unless the Speaker states the 18 precise reason such recognition would be out of order under these rules.

(b) When a member desires to interrupt a member having the floor, the member shall first obtain recognition by the Speaker and permission of the member occupying the floor, and when such recognition and permission have been obtained, he or she may propound a question to the member occupying the floor; but he or she shall not otherwise interrupt the member having the floor, except as provided in subsection (c) of this rule; and the Speaker shall, without the point of order being raised, enforce this rule.

26 (c) A member who has obtained the floor may be interrupted only for the27 following reasons:

- 28
- (1) A request that the member speaking yield for a question,
- 29
- (2) A point of order,
- 30

(3) A parliamentary inquiry, or

31

(4) A question of privilege.

32 RULE 8. Questions of Privilege. – Upon recognition by the Speaker for that 33 purpose, any member may speak to a question of privilege for a time not to exceed three minutes. Questions of privilege shall be those affecting, first, the rights of the House 34 35 collectively, its safety, dignity, and the integrity of its proceedings; second, the rights, reputation, and conduct of members, individually, in their representative capacity only; 36 37 and shall have precedence over all other questions, except motions to adjourn. Privilege 38 may not be used to explain a vote or debate a bill. The Speaker shall determine if the 39 question is one of privilege and shall, without the point of order being raised, enforce this rule. 40

RULE 9. **Points of Order.** – (a) The Speaker shall decide questions of order <u>pursuant to these rules</u> and may speak to points of order in preference to other members arising from their seats for that purpose. Any member may appeal from the ruling of the chair on questions of order; on such appeal no member may speak more than once,

unless by leave of the House. A two-thirds-majority vote of the members present and 1 2 voting shall be necessary to sustain any appeal from the ruling of the chair. 3 When the Speaker calls a member to order, the member shall be (b) seated, except that a member called to order may clear a matter of fact, or explain, but 4 5 shall not proceed in debate so long as the decision stands. If the member appeals from 6 the ruling of the chair and the decision by a two-thirds-majority vote of the members present be in favor of the member called to order, the member may proceed; if 7 8 otherwise, the member shall not; and if the case, in the judgment of the House, requires 9 it, the member shall be liable to censure by the House. 10 RULE 10. Limitations on Debate. – (a) No member shall speak on, debate, or solicit cosponsors for a bill or resolution at its first reading. 11 12 (b) No member shall speak more than twice on the main question nor 13 longer than 20 minutes for the first speech and 10 minutes for the second speech; nor 14 shall the member speak more than twice upon an amendment or motion to reconsider, 15 re-refer, appeal, or postpone or any motion on concurrence, and then not longer than 10 16 minutes for the first speech and five minutes for the second speech. 17 (c) A member may speak only once and for not more than 20 minutes on 18 the question of the adoption of a minority report. 19 (d) The House, by consent of a majority of the members present, may 20 suspend the operation of subsections (b) and (c) of this rule during any debate on any 21 particular question before the House. 22 RULE 11. Reading of Papers. – When there is a call for the reading of the 23 text of a paper which has been presented to the House and there is objection to such 24 reading, the question shall be determined by a majority vote of the members of the 25 House present. Except for protests permitted by the Constitution, no member may have material printed in the Journal until said material has been presented to the House and 26 27 the printing approved by the House, and said material shall not exceed 1,000 words. RULE 12. General Decorum. - (a) The Speaker shall preserve order and 28 29 decorum. 30 (b) Decency of speech shall be observed and disrespect to personalities carefully avoided. 31 32 (c) When the Speaker is putting any question, or addressing the House, no person shall speak, stand up, walk out of, or cross the House nor, when a member is 33 34 speaking, engage in disruptive discourse or pass between the member and the chair. 35 (d) Food or beverages shall not be permitted on the floor of the House during the first two hours of the daily session. 36 37 The reading of newspapers shall not be permitted on the floor of the (e) 38 House while the House is in session. 39 Smoking shall not be permitted on the floor of the House or in the (f) 40 galleries at any time. The consumption of food or beverages shall not be permitted in 41 the galleries at any time. 42 Special recitals and performances by musicians or other groups shall (g) not be permitted on the floor of the House; and special guests of members of the House 43 shall not be permitted on the floor of the House. 44

1	(h) Members shall observe appropriate attire, coat and tie for male
2	members and dignified dress for female members.
3	(i) The use of wireless telephones shall not be permitted in the House
4	Chamber.
5	(j) Placards, stickers, or signs not approved by the Speaker are not
6	permitted in the House Chamber.
7	III. Motions
8	RULE 13. Motions Generally (a) Every motion shall be reduced to
9	writing if the Speaker or any two members request it. No motion relating to a bill shall
10	be in order which does not identify the bill by its number and short title.
11	(b) When a motion is made, it shall be stated by the Speaker, or, if written,
12	it shall be handed to the chair and read aloud by the Speaker or Clerk before debate.
13	(c) After a motion has been stated by the Speaker or read by the Speaker
14	or Clerk, it shall be in the possession of the House; but it may be withdrawn before a
15	decision or amendment, except in case of a motion to reconsider, which motion, when
16	made by a member, shall be in possession of the House and shall not be withdrawn
17	without leave of the House.
18	RULE 14. Motions, Order of Precedence. – When there are motions before
19	the House, the order of precedence is as follows:
20	To adjourn.
21	To lay on the table.
22	Previous question.
23	To recess.
24	To postpone indefinitely.
25	To reconsider.
26	To postpone to a day certain.
27	To re-refer.
28	To amend an amendment.
29 20	To amend.
30	To pass the bill.
31 32	No motion to lay on the table, to postpone indefinitely, to postpone to a day certain, to re-refer, or to make a particular amendment, being decided, shall be again
32 33	allowed at the same stage of the bill or proposition.
33 34	RULE 15. Motion to Adjourn. – (a) A motion to adjourn shall be seconded
35	before the motion is put to the vote of the House.
36	(b) A motion to adjourn shall be decided without debate and shall always
37	be in order, except when the House is voting or some member is speaking; but a motion
38	to adjourn shall not follow a motion to adjourn until debate or some other business of
39	the House has intervened.
40	RULE 16. Motion to Table. $-(a)$ A motion to table shall be seconded before
41	the motion is put to the vote of the House and is in order except when a motion to
42	adjourn is before the House.
43	(b) A motion to table shall be decided without debate.
44	(c) A motion to table shall not be paired with a motion to reconsider.
	*

A motion to table a bill shall constitute a motion to table the bill and 1 (d)2 all amendments thereto. 3 When the question before the House is the adoption of an amendment (e) 4 to a bill or resolution, a motion to table the bill is not in order; and a motion to table an 5 amendment applies to the amendment only, and the motion may not expressly or by 6 implication or construction be expanded to include a motion to table the bill also. 7 When a question has been tabled, it shall not thereafter be considered (f)8 except on motion to reconsider under Rule 18 or to remove from the table approved by a 9 two-thirds vote. 10 RULE 17. Motion to Postpone Indefinitely. – A motion to postpone indefinitely is in order except when a motion to adjourn or to lay on the table or for the 11 12 previous question or to recess is before the House. However, after one motion to 13 postpone indefinitely has been decided, another motion to postpone indefinitely shall 14 not be allowed at the same stage of the bill or proposition. When a question has been 15 postponed indefinitely, it shall not thereafter be considered except on motion to 16 reconsider under Rule 18 or to place on the favorable calendar approved by a two-thirds 17 vote. 18 RULE 18. Motion to Reconsider. - (a) When a question has been decided, 19 it is in order for any member to move for the reconsideration thereof on the same or the 20 succeeding legislative day; provided that if the vote by which the motion was originally 21 decided was taken by a recorded vote, only a member of the prevailing side may move for reconsideration. 22 23 (b)A motion to reconsider shall be determined by a majority vote, except 24 the following shall require a two-thirds vote: a second or subsequent motion to reconsider and a motion to reconsider: 25 26 (1)A vote upon a motion to table, 27 (2)A motion to postpone indefinitely, A motion to remove a bill from the unfavorable calendar, 28 (3) 29 A motion that a bill be read twice on the same day, or (4) 30 A motion to remove from the table. (5) 31 (c) A motion to reconsider the vote by which a person has been elected as 32 Speaker or Speaker Pro Tempore shall not be in order. This subsection of this rule 33 cannot be suspended. 34 RULE 19. Previous Question. – (a) The previous question may be called 35 only by: (1) The Chair of the Committee on Rules, Calendar, and Operations of the 36 House: 37 38 The member submitting the report on the bill or other matter under (2)39 consideration; 40 The member introducing the bill or other matter under consideration; (3)41 or 42 (4) The member in charge of the measure, who shall be designated by the chair of the standing committee or permanent subcommittee reporting 43 44 the same to the House at the time the bill or other matter under

(3) Any other question upon direction of the Speaker or upon motion of any member supported by one-fifth of the members present.

7 (c) When the electronic voting system is used, 15 seconds shall be 8 allowed for voting on the question before the House, unless the Chair shall direct 9 otherwise. The system shall be set to close automatically when that time has expired. 10 Once the system is locked, the vote shall be recorded and printed.

11 (d) The voting station at each member's desk in the Chamber shall be used 12 only by the member to which the station is assigned. Under no circumstances shall any 13 other person vote at a member's station. It is a breach of the ethical obligation of a 14 member either to request that another person vote at the requesting member's station or 15 to vote at another member's station. The Speaker shall enforce this rule without 16 exception.

17 (e) When the electronic voting system is used, the Speaker shall state the 18 question and shall then state substantially the following: "All in favor vote 'ave'; all opposed vote 'no'; the Clerk will open the vote." In order to have the vote recorded, the 19 20 member must vote by the electronic voting system within the time allowed for that vote, 21 unless the voting station assigned to a member is malfunctioning. The Speaker shall enforce this rule without exception. After the allotted time for voting has elapsed, the 22 23 Speaker shall say: "The Clerk will now lock the machine and record the vote." After the 24 machine is locked and the vote recorded, the Speaker shall announce the vote and 25 declare the result.

(f) One copy of the machine printout of the vote record of all votes taken
on the electronic voting system shall be filed in the office of the Principal Clerk, and
two copies shall be filed in the Legislative Library where the copies shall be open to
public inspection. A legible copy of the bill, amendment, or motion on which the vote
was taken shall be filed with the printout of the vote in the Legislative Library.

When the Speaker ascertains that the electronic voting system is 31 (g) 32 inoperative before a vote is taken or while a vote is being taken on the electronic voting system, the Speaker shall announce that fact to the House, and any partial electronic 33 34 voting system voting record shall be voided. In such a case, if the North Carolina 35 Constitution or the Rules of the House require a call of the ayes and noes, the Clerk shall call the roll of the House, and the ayes and noes shall be taken manually and shall 36 be recorded on the Journal. All roll call votes shall be taken alphabetically. If, after a 37 38 vote is taken on the electronic voting system, it is discovered that a malfunction caused 39 an error in the electronic voting system printout, the Speaker shall direct the Reading Clerk and the Principal Clerk to verify and correct the printout record and so advise the 40 41 House.

42 (h) For the purpose of identifying motions on which the vote is taken on43 the electronic voting system, the motions are coded as follows:

(1) To adjourn.

(2)To lay on the table. 1 2 (3) Previous question. 3 (4) To recess. To postpone indefinitely. 4 (5) 5 To reconsider. (6)To postpone to a day certain. 6 (7)To re-refer. 7 (8) 8 (9) To amend an amendment. 9 (10)To amend. 10 (11)To concur or not concur. (12) Miscellaneous. 11 12 RULE 21. Voice Votes: Stating Ouestions. – (a) All other votes except 13 those required to be taken on the electronic voting system shall be taken by voice vote. 14 (b) When a voice vote is taken, the Speaker shall put the question 15 substantially as follows: "Those in favor (as the question may be) will say 'Aye'', and after the affirmative voice has been expressed, "Those opposed will say 'No". 16 17 (c) No statement, explanation, debate, motion, parliamentary inquiry, or 18 point of order shall be allowed once the voice vote has begun. Any point of order or parliamentary inquiry may be raised, however, after the completion of the vote. 19 20 RULE 22. Determining Questions. – (a) Unless otherwise provided by the 21 Constitution of North Carolina or by these rules, all questions shall be determined by a simple majority of the members present and voting. 22 23 No member may vote unless the member is in the Chamber when the (b) 24 question is put. This subsection of this rule cannot be suspended. 25 RULE 23. Voting by Division. – Any member may call for a division of the members upon the question before the result of the vote has been announced. Upon a 26 27 call for a division, the Speaker shall cause the number voting in the affirmative and in 28 the negative to be determined. The Speaker or other presiding officer may not disregard 29 a timely call for a division by a member. Upon a division and count of the House on any 30 question, no member away from the member's seat shall be counted. RULE 24. Roll Call Vote. – (a) Before a question is put, any member may 31 32 call for the ayes and noes. The Speaker or other presiding officer may not disregard a 33 timely request for the ayes and noes. If the call is sustained by one-fifth of the members present, the question shall be decided by the ayes and noes upon a roll call vote. 34 35 (b) Every member who is in the Hall of the House when the question is put shall vote upon a call of the ayes and noes, unless excused pursuant to Rule 24.1A. 36 RULE 24.1A. Excuse From Deliberations and Voting on a Bill. – (a) Any 37 38 member shall, upon request, be excused from the deliberations and voting on a 39 particular bill, but to do so must make that request after the second reading of the bill and before any motion or vote on the bill or any amendment thereto. If the reason for 40 the request arises at some point later in the proceedings, the request may be made at that 41 42 time. (b) 43 The member may make a brief oral statement of the reasons for making the request. The member may send forward to the Principal Clerk, on a form 44

provided by the Clerk, a concise written statement of the reason for the request, and the 1 2 Clerk shall include this statement in the Journal. 3 The member so excused shall not debate the bill or any amendment to (c) 4 the bill, vote on the bill, offer or vote on any amendment to the bill, or offer or vote on 5 any motion concerning the bill at that reading, any subsequent reading, or any 6 subsequent consideration of the bill. 7 (d) A member may request that his or her excuse from deliberations on a 8 particular bill be withdrawn. 9 RULE 24.1B. Division of Amendments. - Any member may call for an 10 amendment to be divided into two or more amendments to be voted on separately, and the Speaker shall determine whether the amendment admits of such a division. 11 12 RULE 25. Voting by Speaker. – In all elections the Speaker may vote. In all other instances the Speaker may vote or may reserve this right until there is a tie in 13 14 which event the Speaker may vote; but in no instance may the Speaker vote twice on the 15 same question. 16 V. Committees 17 RULE 26. Standing Committees and Permanent Subcommittees 18 **Generally.** – (a) The Speaker party caucus of the political party which has a majority of the House members (the "majority caucus") shall appoint a chair, or cochairs, of 19 20 every standing committee, permanent subcommittee, and select committee, if any. In 21 the construction of these rules, the word "chair" as applied to a committee extends to and includes a cochair of the committee. The Speaker shall have the exclusive right and 22 23 authority to establish select committees, but this does not exclude the right of the House 24 by resolution to establish select committees. 25 (b) All The majority party members and the minority party members of all permanent subcommittees of each standing committee shall be appointed by the 26 27 Speaker, majority caucus and the minority caucus respectively, and the members appointed, along with the chair of the standing committee, shall constitute the standing 28 29 committee of which the permanent subcommittee is a part. The Speaker majority caucus and the minority caucus shall appoint all members of permanent subcommittees at the 30 beginning before the end of the tenth legislative day of the first regular session in a 31 32 manner to reflect the partisan membership of the House. The appointments by each 33 caucus shall be in a manner determined by that caucus, and each caucus shall report its appointments to the Principal Clerk. 34 35 (c) The Speaker majority caucus shall appoint the majority party members, and the minority caucus shall appoint the minority party members of all 36 standing committees having no permanent subcommittees at the beginning- before the 37 38 end of the tenth legislative day of the first regular session. The House by resolution shall establish the size of each committee and permanent subcommittee. The 39 resolution shall provide how many members are to be appointed by the majority caucus 40 and how many by the minority caucus, in a manner to reflect the partisan membership 41 42 of the House. House on a mathematical basis. If the two largest parties have a different number of members, the majority party shall have at least one more member on each 43

committee and subcommittee than the minority party, except that the Ethics Committee 1 2 shall have an equal number of members from the majority and minority parties. 3 (d) Each chair of a permanent subcommittee shall be a vice-chair of the 4 standing committee of which it is a permanent subcommittee. The Speaker may name 5 other members as vice-chairs of the standing committee. The Speaker may name one or 6 more vice-chairs for any standing committee not having permanent subcommittees. The chair of the standing committee shall be a voting member of each 7 (e) 8 permanent subcommittee of the standing committee. Either the chair or acting chair, designated by the chair or by the 9 (f) 10 Speaker, and five other members of the standing committee or permanent subcommittee, or a majority of the standing committee or permanent subcommittee, 11 12 whichever is fewer, shall constitute a quorum of that standing committee or permanent subcommittee. For purposes of determining a quorum, the persons designated by the 13 14 Speaker when serving only as ex officio members under subsection (h) of this rule, shall be counted among the membership of the committee or subcommittee only when 15 16 present. 17 In any joint meeting of the Senate and House committees or (g) subcommittees, the House standing committee or permanent subcommittee reserves the 18 19 right to vote separately. 20 Four members designated by the Speaker at the time of appointments (h) 21 of chairs of standing committees are ex officio members of every standing committee and permanent subcommittee with the right to vote. 22 23 This rule is subject to the provisions of House Resolution 1 of the (i) 24 2005 Regular Session of the General Assembly, as applicable. RULE 28. **Standing Committee and Permanent Subcommittee Meetings.** - (a) Standing committees and permanent subcommittees of standing committees shall be furnished with suitable meeting places pursuant to a schedule established by the Chair of the Standing Committee on Rules, Calendar, and Operations of the House. Select committees shall be furnished with suitable meeting places as their needs require by the Chair of the Standing Committee on Rules, Calendar, and Operations of the House.

38 (b) Subject to the provisions of subsection (c) of this rule, standing 39 committees and permanent subcommittees thereof shall permit other members of the 40 General Assembly, the press, and the general public to attend all sessions of said 41 standing committees or permanent subcommittees.

42 (c) The Chair or other presiding officer shall have general direction of the 43 meeting place of the standing committee or permanent subcommittee, and, in case of 44 any disturbance or disorderly conduct therein, or if the peace, good order, and proper

conduct of the legislative business is hindered by any person or persons, the Chair or 1 2 presiding officer shall have power to exclude from the session any individual or 3 individuals so hindering the legislative business.

Procedure in the standing committees and permanent subcommittees 4 (d)5 shall be governed by the rules of the House, so far as the same may be applicable to 6 such procedure. Before a question is put, any member may call for the ayes and noes. If the call is sustained by one-fifth of the members present, the question shall be decided 7 8 by the ayes and noes upon a roll call vote. All roll call votes shall be taken 9 alphabetically and shall be subject to Rule 21(c). No presiding officer may disregard a 10 timely call for the ayes and noes or for a division on a question before the committee or standing subcommittee. 11

No standing committee or permanent subcommittee shall meet on any 12 (e) 13 day when the House shall not convene except by permission of the Speaker or by 14 approval of the House by resolution adopted by a majority vote of the House.

15 No standing committee or permanent subcommittee shall meet during (f)16 any session of the House. Standing committees and permanent subcommittees shall 17 meet at their regularly scheduled hour. No permanent subcommittee shall meet at the 18 same time that its standing committee is meeting. Standing committees and permanent 19 subcommittees may meet at other times as authorized by the Chair of the Standing 20 Committee on Rules, Calendar, and Operations of the House in order to assure the 21 availability of the meeting room and that no conflicts will exist with the meetings of other bodies. All standing committee and permanent subcommittee meetings shall 22 23 adjourn no later than:

15 minutes preceding a regular session of the House, and (1)

10 minutes preceding the hour of the next regularly scheduled standing (2)committee or permanent subcommittee meeting.

27 Any call or notice of a standing committee or permanent subcommittee (g) meeting between legislative sessions shall be mailed to each member of the standing 28 29 committee or permanent subcommittee at least five days prior to such meeting. If a 30 member of the body so requests in writing to the chair of the standing committee or permanent subcommittee, the member shall be notified by certified mail of the 31 32 meetings.

33 During standing committee and permanent subcommittee meetings, (h) 34 the chair may exercise the right to vote, or may reserve this right until there is a tie, in 35 which event the chair may vote, but in no instance may the chair vote twice on the same question. 36

37 RULE 28.1. Ethics Committee Investigations Into Violations of the Open 38 Meetings Law. Investigations. – (a) On its own motion, or in response to signed and 39 sworn complaint of any individual filed with the Standing Committee on Ethics, the Committee shall inquire into any alleged violation by members of the House of the 40 Open Meetings Law (Article 33C of Chapter 143 of the General Statutes), as the same 41 42 may be amended in the future. any rule, standard of conduct, or law that applies to the conduct of the business of the House or the conduct of House members. 43

1	(b) If, after such preliminary investigation as it may make, the Committee
2	determines to proceed with an inquiry into the conduct of any individual, the Committee
3	shall notify the individual as to the fact of the inquiry and the charges against the

19	(4) Refer the matter to the House for appropriate action.
20	(d) The Ethics Committee shall consider complaints against any presiding

22	the attention of the presiding officer who thereafter failed to

24	RULE 29. Notice of Standing Committee and Permanent Subcommittee
25	Meetings and Hearings Public notice of all standing committee and permanent
26	subcommittee meetings shall be given in the House. The chair of the standing
27	committee or permanent subcommittee shall notify or cause to be notified the sponsor
28	of each bill which is set for hearing or consideration before the standing committee or
29	permanent subcommittee as to the date, time, and place of that meeting.
30	RULE 29.1. Public Hearings (a) Requests for a public hearing shall be
31	made in writing to the chair of the standing committee and, if applicable, the chair of the
32	permanent subcommittee to which the bill has been referred. The chair of the standing
33	committee may schedule a public hearing by the standing committee as a whole after
34	the adjournment of a regular daily House session. The chair of the permanent
35	subcommittee may schedule a public hearing before the permanent subcommittee at its

subcommittee may schedule a public hearing before the permanent subcommittee at its
 regularly scheduled hour. Denial of a request made by a House member may be
 appealed to the Speaker.

Notice shall be given not less than five calendar days prior to public hearings.
These notices shall be issued as information for the press and shall be posted in the
places designated by the Principal Clerk.

41 (b) Persons desiring to appear and be heard at a public hearing shall
42 submit their requests to the chair of the standing committee or permanent subcommittee.
43 The standing committee or permanent subcommittee chair may designate one or more
44 members to arrange the order of appearance of interested parties. A brief written

statement of testimony may be submitted without oral presentation and shall be 1 2 incorporated into the minutes of the public hearing. 3 RULE 29.2. Minutes to Legislative Library. - The chair of a standing committee or a permanent subcommittee shall ensure that written minutes are compiled 4 5 for each of the body's meetings. The minutes shall indicate the members present and the 6 actions taken at the meeting. Not later than 20 days after the adjournment of each session of the General Assembly, the chair shall deliver the minutes to the Legislative 7 8 Library. The Speaker of the House may grant a reasonable extension of time for filing 9 said minutes upon written application of the chair. 10 RULE 30. Standing Committee of the Whole House. - (a) A Standing Committee of the Whole House shall not be formed, except by suspension of the rules, 11 12 if there be objection by any member. 13 (b) After passage of a motion to form a Standing Committee of the Whole 14 House, the Speaker shall appoint a chair to preside in the standing committee, and the 15 Speaker shall leave the dais. 16 (c) The rules of procedure in the House shall be observed in the Standing 17 Committee of the Whole House, so far as they may be applicable, except the rule 18 limiting the time of speaking and the previous question. 19 In the Standing Committee of the Whole House, a motion that the (d) 20 standing committee rise shall always be in order, except when a member is speaking, 21 and shall be decided without debate. 22 (e) When a bill is submitted to the Standing Committee of the Whole 23 House, it shall be read and debated by sections, leaving the preamble to be last 24 considered. The body of the bill shall not be defaced or interlined, but all amendments, 25 noting the page and line, shall be duly entered by the Principal Clerk on a separate paper as the same shall be agreed to by the standing committee and be so reported to the 26 27 House. After report, the bill shall again be subject to be debated and amended by sections before a question on its passage be taken. 28 29 **VI. Handling of Bills** 30 RULE 31. Introduction of Bills and Resolutions. - (a) All bills and resolutions shall be introduced by submitting same to the Principal Clerk's office on the 31 32 legislative day prior to the first reading and reference thereof according to the following 33 schedule: by 30 minutes after adjournment each Monday; and by 3:00 P.M. each 34 Tuesday, Wednesday, Thursday, and Friday. 35 (b) Bills shall not become resolutions provided the Senate has a similar rule. Resolutions shall not become bills. Resolutions are not law but may be used when 36 a law is not necessary for the purpose contained therein. Resolutions shall not be used to 37 38 appropriate funds for any purpose, but may be used to create study commissions or 39 committees or establish investigative committees, to honor deceased persons, and to adopt House rules and internal affairs. Resolutions cannot amend, repeal, or modify a 40 statute; nor do they have life beyond the term of the session during which they are 41 42 adopted.

43 (c) Every bill or resolution shall be read in regular order of business, 44 except upon permission of the Speaker or on the report of a standing committee. 1 (d) All bills and resolutions shall show in their captions a brief descriptive 2 statement of the true substance of same, which captions may thereafter be amended. 3 Captions of public bills may be amended only by amendment proposed by the standing 4 committee to which the bill was referred. Third reading shall not be had on any bill or 5 resolution on the same day that such caption is amended.

6 (e) A Substitute Bill shall be covered with the same color jacket as the 7 original bill and shall be prefaced as follows: "House Committee Substitute 8 for_____".

9

(f) House Resolutions need not be read more than twice.

10 (g) All memorializing, celebration, commendation, and commemoration 11 resolutions, except those honoring the memory of deceased persons, shall be excluded 12 from introduction and consideration in the House.

(h) Any reference in these rules to bills shall extend to resolutions unless
the context requires otherwise.

15 RULE 31.1. **Deadlines on Introduction and Receipt; Single Subject Rule.** 16 – (a) All public bills or resolutions recommended by commissions or standing 17 committees authorized or directed by act or resolution of the General Assembly to 18 report to the 2005 Regular Session of the General Assembly, or to report prior to 19 convening of that session, must have been submitted to the Bill Drafting Division of the 20 Legislative Services Office by 4:00 P.M. on March 9, 2005, and must be introduced not 21 later than 3:00 P.M. on March 16, 2005; and

(a1) All bills prepared to be introduced for departments, agencies, or
institutions of the State must have been submitted to the Bill Drafting Division of the
Legislative Services Office by 4:00 P.M. on March 9, 2005, and must be introduced not
later than 3:00 P.M. on March 16, 2005. A bill introduced under this subsection shall be
identified as an Agency Bill after its short title.

(a2) All local bills must have been submitted to the Bill Drafting Division
of the Legislative Services Office by 4:00 P.M. on March 22, 2005, and must be
introduced not later than 3:00 P.M. on March 30, 2005.

30 (b) All public bills which would not be required to be re-referred to the
31 Appropriations or Finance Committees under Rule 38 must have been submitted to the
32 Bill Drafting Division of the Legislative Services Office by 4:00 P.M. on April 13,
33 2005, and must be introduced not later than 3:00 P.M. on April 20, 2005.

34 All public bills which under Rule 38 would be required to be (c) 35 re-referred to the Appropriations Committee, or to both the Appropriations and Finance Committees, or to the Finance Committee, must have been submitted to the Bill 36 37 Drafting Division of the Legislative Services Office by 4:00 P.M. on May 4, 2005, and 38 must be introduced not later than 3:00 P.M. on May 11, 2005. If any bill is eligible for 39 introduction on account of the date only under this subsection, and the bill is amended so that qualifying appropriation or tax law change does not remain in the bill, it shall not 40 be eligible for further consideration. For the purpose of this section, a "tax law change" 41 42 includes any provision that would require a bill under Rule 38(b) to be referred to the Standing Committee on Finance. 43

In order to be eligible for consideration by the House during the first 1 (d) 2 Regular Session, all Senate bills other than finance or appropriations bills which would 3 be required to be re-referred to the Appropriations or Finance Committees under Rule 4 38 or adjournment resolutions must be received and read on the floor of the House as a 5 message from the Senate no later than May 19, 2005; provided that a message from the 6 Senate received by the next legislative day stating that a bill has passed its third reading 7 and is being engrossed shall comply with the requirements of this subsection and provided that the Senate has a similar rule. 8

9 (d1) Except by motion approved by a majority of members of the House 10 present and voting, no public House bill other than the Current Operations 11 Appropriations Act or the Capital Improvement Appropriations Act may contain more 12 than one subject.

13 (e) This rule, other than subsection (d1), does not apply to bills 14 establishing districts for Congress or State or local entities. This rule, other than 15 subsection (d1), does not apply to measures ratifying an amendment or amendments to 16 the Constitution of the United States.

17 RULE 32. Reference to Standing Committee and to Permanent 18 Subcommittee; Serial Referrals. - (a) Each bill not introduced on the report of a 19 standing committee shall immediately upon its first reading be referred by the Speaker 20 to such the standing committee or permanent subcommittee as the Speaker deems 21 appropriate. whose usual jurisdiction relates to the subject matter of the bill. The Speaker at the same time may order that, if the bill is reported with any favorable 22 23 recommendation or without prejudice, it be re-referred automatically upon the 24 committee report to another committee or permanent subcommittee designated in the order. Each joint resolution or House resolution not introduced on the report of a 25 standing committee shall immediately upon its first reading either be referred by the 26 27 Speaker to a standing committee or permanent subcommittee or be calendared on the date designated by the Speaker, as the Speaker deems appropriate. 28

(b) The standing committee chair may refer each bill referred to the standing committee to the permanent subcommittee specifically charged with the subject matter of the bill. A report of that referral shall be made in writing and submitted to the body pursuant to Rule 5(5). Except as provided in Rule 36, the permanent subcommittee to which the bill is referred shall report the bill back to the full standing committee. That subcommittee report shall include one of the following recommendations:

- (1) Favorable, without prejudice, or unfavorable as to the original bill with the recommendation that the report be made to the standing committee;

14	standing committee chair may re-refer the bill to another permanent subcommittee of
15	that standing committee.
16	Upon recommendation to the standing committee, the bill shall be before that
17	body for further action unless the permanent subcommittee chair reports the bill directly
18	pursuant to Rule 36.
19	RULE 33. Papers Addressed to the House Petitions, memorials, and
20	other papers addressed to the House shall be presented by the Speaker. A brief
21	statement of the contents thereof may be made orally by the introducer before reference
22	to a committee, but such papers shall not be debated or decided on the day of their first
23	being read unless the House shall direct otherwise.
24	RULE 34. Introduction of Resolutions and Bills, Copies Required. – (a)
25	Whenever any resolution or bill is introduced, a duplicate copy thereof shall be attached
26	thereto, and the Principal Clerk shall cause said duplicate copy to be numbered as the
27	original resolution or bill is numbered and shall cause the same to be available at all
28	times to the member introducing the same.
29	(b) Numbering of House Bills shall be designated as "H.B" (No.
30	following). A Joint Resolution shall be designated as "H.J.R" (No. following). A
31	House Resolution shall be designated as "H.R" (No. following).
32	(c) Whenever any resolution or bill is filed for introduction, it shall be in a
33	House bill jacket containing 30 copies and in the form designated by the Speaker. Any
34	resolution or bill not accompanied by the required number of copies shall be returned
35	immediately to the introducer. The Clerk shall stamp the copies with the number
36	stamped upon the original bill.
37	RULE 35. Duplicating and Availability of Copies of Bills (a) The
38	Legislative Services Officer shall cause such bills as are introduced to be duplicated in
39	such numbers as may be specified by the Speaker. The Legislative Services Officer
40	shall cause one copy of each resolution and public bill for each member to be delivered
41	to the member's committee assistant or legislative assistant who shall place it in the
42	appropriate notebook on the member's desk. If a member so requests, a second copy
43	shall be delivered to the member's committee assistant or legislative assistant who shall
44	place it in the member's office. The remaining copies shall be placed in the Printed Bills

3 (b) A public bill is a bill affecting 15 or more counties. A local bill is one 4 affecting fewer than 15 counties. No public bill and, upon objection by a member, no 5 local bill may be considered unless copies of the bill have been made available to the 6 entire membership of the House.

RULE 35.1. Assessment Reports. – (a) Every bill or resolution proposing 7 the establishment of an occupational or professional licensing board, as defined in 8 9 Article 18A of Chapter 120 of the General Statutes, or a study for the need to establish 10 such a board shall have attached to the jacket of the original bill or resolution at the time of its consideration on second and third readings by the House or by any standing 11 12 committee or permanent subcommittee of the House an assessment report from the 13 Legislative Committee on New Licensing Boards pursuant to Article 18A of Chapter 14 120 of the General Statutes. The assessment report shall not constitute any part of the 15 expression of legislative intent proposed by the formation of a licensing board. Upon receipt of the request, the Legislative Committee on New Licensing Boards shall 16 prepare and return the assessment report as soon as possible but not later than 60 days, 17 18 reserving the right to extend this time to 90 days.

19 (b) Every legislative proposal introduced in the House or received in the 20 House from the Senate, proposing the incorporation of a municipality shall have 21 attached to the jacket of the original bill at the time of its consideration on second or third readings by the House or by any committee of the House prior to a favorable 22 23 report, a recommendation from the Joint Legislative Commission on Municipal 24 Incorporations, established by Article 20 of Chapter 120 of the General Statutes. The 25 recommendation of the Joint Legislative Commission on Municipal Incorporations shall be made in accordance with the provisions and criteria set forth in Article 20 of Chapter 26 27 120 of the General Statutes and shall include the findings required to be made by 28 G.S. 120-166 through G.S. 120-170.

RULE 36. **Report by Standing Committee or Permanent Subcommittee.** – 30 (a) **When Reports Required.** – All House bills and resolutions <u>which have 10 or more</u> 31 <u>co-sponsors shall be reported from the standing committee or permanent subcommittee</u> 32 to which referred with such recommendations as the standing committee or permanent 33 subcommittee may desire to make except in the case where the principal introducer 34 requests in writing to the chair of the standing committee or permanent subcommittee 35 that the bill not be considered.

With the written approval of the chair of the standing committee and with the recommendation of the subcommittee pursuant to Rule 32(b)(4) through (6), the chair of the permanent subcommittee may report the bill directly to the floor with that recommendation. If a permanent subcommittee recommends reporting a bill to the floor and the chair of the standing committee fails to give approval, the bill shall be deemed to have been reported to the standing committee with the same recommendation as the subcommittee would have made to the House.

43 (b) **Favorable Report.** – When a standing committee or permanent 44 subcommittee reports a bill with the recommendation that it be passed, the bill shall be

1	placed on the favorable calendar on the day and in the order designated by the Chair of
2	the Standing Committee on Rules, Calendar, and Operations of the House, but no later
3	than the fourth legislative day after submission of the report or Senate message under
4	Rule 43.2 or Rule 43.3(a), the second legislative day following the report unless:
5	(1) The bill is re-referred to the Committee on Appropriations or
6	Committee on Finance under Rule 38 or was serially referred under
7	Rule 32; or
8	(2) The bill has not yet been placed on the calendar, and the Speaker refers
9	the bill to another committee. committee, if such referral is approved
10	by a majority vote of the House; or
11	(3) The principal sponsor of the bill requests in writing that the Chairman
12	of the Standing Committee on Rules, Calendar and Operations of the
13	House delay the calendaring of the bill for up to two legislative days.
14	In order to <u>delay placing place</u> a bill on the calendar for a legislative day, notice shall be
15	given by the Chair of the Standing Committee on Rules, Calendar, and Operations of
16	the House orally in the House or in writing to the Principal Clerk.
17	When a committee substitute is adopted and receives a favorable report by the
18	committee or permanent subcommittee, the standing committee or permanent

26	(c) Report Without Prejudice. – When a standing committee reports a
27	bill without prejudice, the bill shall be placed on the favorable calendar in the same
28	manner as provided in subsection (a) of this rule.
29	(d) Postponed Indefinitely. – When a standing committee reports a bill
30	with the recommendation that it be postponed indefinitely and no minority report
31	accompanies it, the bill shall be placed on the unfavorable calendar.
32	(e) Unfavorable Report. – When a standing committee reports a bill with
33	the recommendation that it not be passed and no minority report accompanies it, the bill
34	shall be placed on the unfavorable calendar.
35	(f) Minority Report. – When a bill is reported by a standing committee
36	with a recommendation that it not be passed or that it be postponed indefinitely but it is
37	accompanied by a minority report signed by at least one-fourth of the members of the
38	standing committee who were present and voting when the bill was considered in
39	standing committee, the question before the House shall be: "The adoption of the

43	RULE 36.1. Fiscal Notes. – (a) The Chair or Cochair of the Appropriations
44	Committee, of the Finance Committee, or of the Standing Committee on Rules,

Calendar, and Operations of the House, upon the floor of the House, may request that a fiscal analysis be made of a bill, resolution, or an amendment to a bill or resolution which is in the possession of the House and that a fiscal note be attached to the measure, which request shall be allowed when, in the opinion of the Speaker, the fiscal effects of that measure are not apparent from the language of the measure.

6 (b) The fiscal note shall be filed and attached to the bill or amendment 7 within two legislative days of the request. If it is impossible to prepare a fiscal note 8 within two legislative days, the Director of Fiscal Research shall, in writing, so advise 9 the Speaker, the Principal Clerk, and the member introducing or proposing the measure 10 and shall indicate the time when the fiscal note will be ready.

11 (c) The fiscal note shall be prepared by the Fiscal Research Division on a 12 form approved by the Chair of the Standing Committee on Rules, Calendar, and 13 Operations of the House as to content and form and signed by the staff member or 14 members preparing it. If no estimate in dollars is possible, the fiscal note shall indicate 15 the reasons that no estimate is provided. The fiscal note shall not comment on the merit 16 but may identify technical problems. The Fiscal Research Division shall make the fiscal 17 note available to the membership of the House.

18 (d) A sponsor of a bill or amendment may deliver a copy of the bill or 19 amendment to the Fiscal Research Division for the preparation of a fiscal note. The 20 sponsor shall attach the fiscal note to the bill when filed or to the amendment when its 21 adoption is moved.

(e) The sponsor of a bill or amendment to which a fiscal note is attached who objects to the estimates and information provided may reduce to writing the objections. These objections shall be appended to the fiscal note attached to the bill or amendment and to the copies of the fiscal note available to the membership.

(f) Subsection (a) of this rule shall not apply to the Current Operations
 Appropriations Bill or the Capital Improvement Appropriations Bill. This rule shall not
 apply to a bill or amendment requiring an actuarial note under these rules.

RULE 36.2. Actuarial Notes. – (a) Every bill or resolution proposing any
 change in the law relative to any:

31 32 (1) State, municipal, or other retirement system funded in whole or in part out of public funds; or

 Program of hospital, medical, disability, or related benefits provided for teachers and State employees, funded in whole or in part by State funds;

shall have attached to it at the time of its consideration by any standing committee or 36 permanent subcommittee a brief explanatory statement or note which shall include a 37 38 reliable estimate of the financial and actuarial effect of the proposed change to that 39 retirement or pension system. The actuarial note shall be attached to the jacket of each proposed bill or resolution which is reported favorably by any standing committee or 40 any permanent subcommittee, shall be separate therefrom, and shall be clearly 41 42 designated as an actuarial note. A bill described in subdivision (a)(1) of this rule shall be referred to the Committee on Pensions and Retirement upon its introduction in 43 accordance with G.S. 120-111.3. 44

1 (b) The sponsor of the bill or resolution shall present a copy of the 2 measure, with a request for an actuarial note, to the Fiscal Research Division, which 3 shall prepare the actuarial note as promptly as possible but not later than two weeks 4 after the request is made unless an extension of time is agreed to by the sponsor as being 5 necessary in the preparation of the note. Actuarial notes shall be prepared in the order of 6 receipt of request and shall be transmitted to the sponsor of the measure. The actuarial 7 note of the Fiscal Research Division shall be prepared and signed by an actuary.

8 The sponsor of the bill or resolution shall also present a copy of the (c) 9 measure to the actuary employed by the system or program affected by the measure. Actuarial notes shall be prepared and transmitted to the sponsor of the measure not later 10 than two weeks after the request is received, unless an extension of time is agreed to by 11 12 the sponsor as being necessary in the preparation of the note. The actuarial note shall be attached to the jacket of the measure. The provisions of this subsection may be waived 13 14 by the measure's sponsor for a measure affecting local government retirement or 15 pension plans not administered by the State or any local government program of hospital, medical, disability, or related benefits for local government employees not 16 17 administered by the State.

18 (d) The note shall be factual and shall, if possible, provide a reliable 19 estimate of both the immediate effect and, if determinable, the long-range fiscal and 20 actuarial effect of the measure. If, after careful investigation, it is determined that no 21 dollar estimate is possible, the note shall contain a statement to that effect, setting forth 22 the reasons why no dollar estimate can be given. No comment or opinion shall be 23 included in the actuarial note with regard to the merits of the measure for which the note 24 is prepared. Technical and mechanical defects in the measure may be noted.

25 (e) When any permanent subcommittee or standing committee reports a measure to which an actuarial note is attached at the time of permanent subcommittee or 26 27 standing committee consideration, with any amendment of such nature as would substantially affect the cost to or the revenues of any retirement or pension system, or 28 29 program of hospital, medical, disability, or related benefits for teachers or State 30 employees, the chair of the permanent subcommittee or standing committee reporting the measure shall obtain from the Fiscal Research Division an actuarial note of the fiscal 31 32 and actuarial effect of the proposed amendment. The actuarial note shall be attached to 33 the jacket of the measure. An amendment to any bill or resolution shall not be in order if the amendment affects the costs to or the revenues of a State-administered retirement or 34 35 pension system, or program of hospital, medical, disability, or related benefits for teachers or State employees, unless the amendment is accompanied by an actuarial note, 36 prepared by the Fiscal Research Division, as to the actuarial effect of the amendment. 37

(f) The Fiscal Research Division shall make all relevant actuarial notes
 available to the membership of the House.

RULE 39.1. **Recall of Bill From Permanent Subcommittee.** – When a House bill has been referred to a permanent subcommittee, if after 10 legislative days the subcommittee has failed to act thereon, or at any time, with the agreement of the subcommittee chair, the standing committee chair may re-refer the bill from that permanent subcommittee to another permanent subcommittee of the same standing committee provided the report of the re-referral shall be made pursuant to Rule 32.

RULE 39.2. Re-Referral of Bills From One Standing Committee to
 Another Standing Committee. – Upon consent of the sponsor of the bill, the Speaker,

the chair of the standing committee from whom the bill is to be re-referred, and the 1 2 chair of the standing committee to whom the bill is to be re-referred, the chair of the 3 standing committee from whom the bill is to be re-referred or the Chair of the Standing 4 Committee on Rules, Calendar, and Operations of the House may move for a re-referral 5 to another standing committee, and the bill shall be re-referred upon vote of the majority 6 present during a regular session of the House. RULE 39.3. Discharge petition. - A motion to discharge a committee from 7 consideration of a bill or resolution may be filed with the Principal Clerk if 8 9 accompanied by a petition signed by 61 members of the House asking that the

10 committee be discharged from further consideration of the bill or resolution. No petition may be circulated for signatures until 10 legislative days after the bill has been referred 11 12 to the committee. No petition may be circulated for signature until notice has been given on the floor of the House that the petition is to be circulated. Calendars and Schedules of Business. - The Clerk of the House 24 shall prepare a daily schedule of business, including the Calendar of Bills and Resolutions for consideration and debate that day, in accordance with the Order of 25 Business of the Day (Rule 5). The Clerk shall number all bills and resolutions in the 26 order in which they are introduced. All bills and resolutions shall be taken up by the full 27 house as they appear in each category (Rule 5(10)) in the order they were placed on the 28 29 Calendar under Rule 36(b). The Speaker shall not vary from the order unless a majority 30 of the members present agree.

RULE 41. **Reading of Bills.** – (a) Every bill shall receive three readings in the House prior to its passage. The first reading and reference to standing committee of a House bill shall occur on the next legislative day following its introduction. The first reading and reference to standing committee of a Senate bill shall occur on the next legislative day following its receipt on messages from the Senate. The Speaker shall give notice at each subsequent reading whether it is the second or third reading.

(b) No bill shall be read more than once on the same day without the
concurrence of two-thirds of the members present and voting; provided, no bill
governed by Article II, Section 23 of the North Carolina Constitution or described in
Rule 20(a)(2) herein shall be read twice on one day under any circumstance.

Legislative Officers and Employees 9 RULE 45. Elected Officers. - (a) The House shall elect its Speaker from 10 among its membership. The election of the Speaker shall be by a call of the roll of the members of the House and may not be done by resolution or be combined with any 11 12 other matter. 13 (b) The House shall elect its Speaker Pro Tempore from among its 14 membership who shall perform such duties as the Speaker may assign. 15 (c) The House shall elect a Principal Clerk, who shall continue in office 16 until another is elected. The Speaker may appoint a Reading Clerk and shall appoint a 17 Sergeant-at-Arms, both of whom shall serve at the Speaker's pleasure. The Principal 18 Clerk, Reading Clerk, and Sergeant-at-Arms shall have and perform duties and 19 responsibilities, not inconsistent with these rules, as the Speaker may assign. Unless 20 directed otherwise by the Speaker on behalf of the House, the Principal Clerk or an 21 employee designated by the Principal Clerk shall receive House bills not approved by the Governor. 22 23 RULE 46. Assistants to Principal Clerk and Sergeant-at-Arms. - The 24 Principal Clerk and the Sergeant-at-Arms may appoint, with the approval of the 25 Speaker, such assistants as may be necessary to the efficient discharge of the duties of their respective offices. 26 27 RULE 47. Speaker's Staff; Chaplain; and Pages. – (a) The Speaker may appoint one or more staff members to the Speaker, a Chaplain of the House, and pages 28 29 to wait upon the sessions of the House. 30 When the House is not in session, the pages shall be under the (b) 31 supervision of the Supervisor of Pages. 32 The Speaker, at the request of a member, may appoint honorary pages. (c) 33 RULE 48. Member's Staff. – (a) Each standing committee and permanent 34 subcommittee shall have a committee assistant. The committee assistant to a standing 35 committee or permanent subcommittee shall serve as staff to the chair of the standing 36 committee or permanent subcommittee. 37 Each member shall be assigned a legislative assistant, unless the (b) 38 member has a committee assistant to serve as legislative assistant. 39 The selection and retention of committee assistants, legislative (c) assistants, and office assistants shall be the sole prerogative of the individual member or 40 members. The committee assistants, legislative assistants, and office assistants shall adhere to such uniform rules and regulations not inconsistent with these rules regarding hours and other conditions of employment as the Legislative Services Commission shall fix by appropriate regulations.

6 RULE 49. Compensation of Legislative Assistants. - No clerk, committee 7 assistant, legislative assistant, office assistant, or other person employed or appointed 8 under Rules 46, 47, and 48 hereof shall receive during such employment, appointment, 9 or service any compensation from any department of the State government, and there 10 shall not be voted, paid, or awarded any additional pay, bonus, or gratuity to any of them; but they shall receive only the pay now provided by law for such duties and 11 12 services. This rule shall not apply to employment, appointment, or service or to the 13 receipt of compensation or additional pay, bonus, or gratuity from another department 14 of State government between regular sessions of the General Assembly.

VIII. Privileges of the Hall

16 RULE 50. Admittance to Floor. - No person except members, officers, and 17 employees of the General Assembly who have been issued identification tags as 18 provided by this rule, and former members of the General Assembly who are not 19 registered under the provisions of Article 9 of Chapter 120 of the General Statutes, shall 20 be allowed on the floor of the House during its session, unless permitted by the Speaker 21 or otherwise provided by law. Employees of the General Assembly shall wear identification tags, approved by the Legislative Services Officer, when on the floor of 22 23 the House.

RULE 51. Admittance of Press. – Reporters wishing to take down debates may be admitted by the Speaker, who shall assign such places to them on the floor or elsewhere, to effect this object, as shall not interfere with the convenience of the House. Reporters admitted to the floor of the House shall observe the same requirements of attire for members contained in Rule 12(h).

RULE 52. Extending Courtesies. – Courtesies of the floor, galleries, or lobby shall be extended at the discretion of the Speaker and only by the Speaker. Requests by members to extend these courtesies shall be typewritten and delivered to the Speaker. No member shall orally ask the Speaker to extend these courtesies during the daily session.

RULE 53. **Order in House Chamber, Galleries, and Lobby.** – In case of any disturbance or disorderly conduct in the House Chamber, galleries, or lobby, the Speaker or other presiding officer is empowered to order the same to be cleared to the extent they deem necessary.

IX. General Rules

RULE 54. Attendance of Members. – No member or officer of the House
shall be absent from the service of the House without leave, unless from sickness or
disability.

RULE 55. Documents to Be Signed by the Speaker. – All acts, addresses,
and resolutions and all warrants and subpoenas issued by order of the House shall be
signed by the Speaker or other presiding officer.

RULE 56. Printing or Reproducing Materials. – There shall be no printing 1 2 or reproducing of paper(s) that are not legislative in essence except upon approval of the 3 Speaker. 4 RULE 57. Placement or Circulation of Materials. – Persons other than 5 members of the House shall not place or cause to be placed any materials on members' 6 desks in the House Chamber without obtaining approval of the Speaker. Any material 7 placed on members' desks in the House Chamber, or circulated to House members 8 anywhere in the Legislative Building or the Legislative Office Building, shall bear the 9 name of the originator. 10 RULE 58. Rules, Rescission, and Alteration. - (a) These rules shall not be permanently rescinded or altered except by House simple resolution passed by a 11 12 two-thirds majority vote of the members present and voting. The introducer of the resolution must on the floor of the House give notice of intent to introduce the 13 14 resolution on the legislative day preceding its introduction. 15 (b) Except as otherwise provided herein, the House upon two-thirds vote of the members present and voting may temporarily suspend any rule. 16 17 RULE 59. Cosponsorship of Bills and Resolutions. - (a) Any member 18 wishing to cosponsor a bill or resolution which has been introduced may do so by appearing in the office of the Principal Clerk for such purpose within one-half hour 19 20 following the adjournment of the session during which such bill or resolution was first 21 read and referred. 22 (b) Members wishing to jointly sponsor legislation should indicate such to 23 the drafter at the time the bill is requested or upon filing the bill with the Principal 24 Clerk's office. The names of the members who are the primary sponsors shall be listed in the order requested by them, followed by the words (Primary Sponsors); and the 25 remaining names of members cosponsoring shall follow. No more than four members 26 27 may be listed as primary sponsors. No member shall permit anyone, other than that member's committee 28 (c) 29 assistant, legislative assistant, office assistant, or another member, to have possession of 30 and solicit for bill or resolution cosponsorship, the jacket of a bill or resolution. RULE 60. Correcting of Typographical Errors. – The Legislative Services 31 32 Officer may correct typographical errors appearing in House bills or resolutions provided that such corrections are made before ratification and do not conflict with any 33 actions or rules of the Senate and provided further that such correction be approved by 34 35 the Chair of the Standing Committee on Rules, Calendar, and Operations of the House, the Speaker, or other presiding officer. 36 37 RULE 61. Assignment of Seats. - The assignment of seats shall be made 38 within each party caucus, with each member choosing a seat in order of seniority. The 39 Democratic members shall be seated in the 60 seats to the Speaker's left in the chamber, and the Republican members shall be seated in the 60 seats to the Speaker's right in the 40

41 chamber, except that to the extent that members of one party are in the majority, the

42 excess shall be seated first in the center aisle seats on the other side of the chamber,
 43 being allocated first front to rear. After initial assignment of seats, a member shall

44 continue to occupy the seat to which initially assigned until assigned a permanent seat;

once assigned a permanent seat, the member shall occupy it for the entire biennial
session. In event of vacancy, that member's successor will occupy the seat of the
member replaced for the remainder of the biennial session.

RULE 61.1. Office Assignments. - The Chair of the Standing Committee on 4 5 Rules, Calendar, and Operations of the House shall assign to each member an office space. The office assignments shall be made on the basis of seniority, with the Chair of 6 the Committee on Rules, Calendar, and Operations of the House making assignments in 7 8 conformity with the request of each member to the extent practicable. When available, 9 chairs of standing committees and permanent subcommittees shall be assigned an office 10 adjacent to the room in which the standing committee or permanent subcommittee generally meets if the Chair so desires. The Speaker shall be assigned an office of his or 11 12 her choice.

13 RULE 61.2. Convening and Assigning Seats in the New House. – (a) The 14 Principal Clerk of the previous House of Representatives shall convene the House of 15 Representatives at 12:00 noon on the date established by law for the convening of each 16 regular session and preside over the body until the members elect a Speaker. In the case 17 of a vacancy, inability, or refusal to so serve, the duty shall devolve upon the 18 Sergeant-at-Arms of the prior House, and in the case of a vacancy in that office, or 19 inability or refusal to so serve, the duty shall devolve upon the Reading Clerk of the 20 prior House.

21 (b) It shall be the duty of the Chair of the Standing Committee on Rules, Calendar, and Operations of the House of the prior House to assign temporary seats to 22 23 the members of the House of Representatives in its Chamber. In the case of the inability 24 or refusal to serve of the Chair of the Standing Committee on Rules, Calendar, and 25 Operations of the House, the Speaker of the prior House of Representatives shall appoint a person to assign seats to members of the House of Representatives in its 26 27 Chamber. In the event that the party that had a majority of members in the prior House will no longer have a majority of members in the new House, then the duty assigned in 28 29 this subsection to the Chair of the Committee of the prior House shall instead be the 30 duty of the person nominated as Speaker by the majority party caucus for the new House, or some member-elect designated by the Speaker-nominee. In the event no party 31 32 will have a majority, then the duty assigned in this subsection to the Chair of the 33 Committee of the prior House shall instead be the joint duty of one person chosen each by the caucuses of the two parties having the greatest numbers of members. 34

RULE 62. Matters Not Covered in These Rules. – Except as herein set out,
 the rules of Mason's Manual of Legislative Procedure shall govern the operation of the
 House."
