39 (\$169,380) for the 2006-2007 fiscal year to establish the additional assistant district
40 attorneys authorized by this act.

41 **SECTION 3.** There is appropriated from the General Fund to the Judicial 42 Department the sum of ninety-six thousand seven hundred eight dollars (\$96,708) for 43 the 2006-2007 fiscal year to establish two additional victim witness assistant positions 44 for Prosecutorial District 24. 1

**SECTION 4.** This act becomes effective July 1, 2006.
