1	<b>SECTION 3.</b> There is appropriated from the General Fund to the Judicial
2	Department the sum of sixty-one thousand eighty-nine dollars (\$61,089) for the
3	2006-2007 fiscal year to establish a new forensic scientist position for District 20 until
4	December 31, 2006, and to serve District 20A effective January 1, 2007.
5	<b>SECTION 4.</b> Sections 1 and 2 of this act become effective January 1, 2007.

6 The remainder of this act becomes effective July 1, 2006.
