A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR THREE ADDITIONAL ASSISTANT DISTRICT ATTORNEYS FOR PROSECUTORIAL DISTRICT 20A AND A FORENSIC SCIENTIST POSITION FOR PROSECUTORIAL DISTRICT 20/20A. The General Assembly of North Carolina enacts:

**SECTION 1.** Effective January 1, 2007, G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

**SECTION 2.** There is appropriated from the General Fund to the Judicial Department the sum of one hundred thirty-four thousand four hundred twelve dollars (\$134,412) for the 2006-2007 fiscal year to establish the three additional assistant district attorneys authorized by this act.

**SECTION 3.** There is appropriated from the General Fund to the Judicial Department the sum of sixty-one thousand eighty-nine dollars (\$61,089) for the
