SECTION 3. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the

1 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 2 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 3 Trust Fund, which is established under G.S. 113-44.15, as follows:

11 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:
12 "(b39) Shag Dancing. – The Division must receive 300 or more applications for the
13 Shag Dancing plate before the plate may be developed. The Division shall transfer
14 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
15 from the sale of Shag Dancing plates to the Hall of Fame Foundation."

16 **SECTION 5.** This act is effective when it becomes law.
