23	SECTION 3. G.S. 20-79.7(b) reads as rewritten:	

Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

SECTION 4. G.S. 20-81.12 is amended by adding a new subsection to read: "(b62) Triangle Native American Society. – The Division must receive 300 or more applications for the Triangle Native American Society plate before the plate may be developed. The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of Triangle Native American Society plates to the Triangle Native American Society, Inc., to provide scholarships for Native American Indians living in North Carolina who attend accredited State-supported colleges and universities in North Carolina."

SECTION 5. This act is effective when it becomes law.
