1 2 3	A BILL TO BE ENTITLED AN ACT TO ESTABLISH THE ADVISORY COMMISSION ON HOSPITAL INFECTION CONTROL AND DISCLOSURE.			
4	Whereas, the Centers for Disease Control and Prevention (CDC) reports that			
5	approximately 2,000,000 people annually become ill from hospital-acquired infections,			
6 7	called nosocomial infections, and about 90,000 people die each year from hospital-acquired infections; and			
8	Whereas, the CDC reports that hospital-acquired infections add at least			
9	\$5,000,000 annually to the nation's health care bill; and			
10	Whereas, a Pennsylvania report on hospital-acquired infections found that			
11	76% of the cost for treating infections in that state was billed to public health insurance;			
12	and			
13	Whereas, the CDC reports that despite the risks associated with nosocomial			
14	infections, information on nosocomial infection rates is hard to obtain, even though			
15	basic data is compiled as hospitals monitor infections, particularly in intensive care			
16	units and following surgery; and			
17	Whereas, the CDC estimates, based on voluntary reporting, that			
18	hospital-acquired infections have become America's leading cause of death from			
19	infectious disease;			
20	Whereas, it is the intent of the General Assembly to enact a law requiring			
21	public disclosure of hospital-acquired infection incidence rates to become effective in			
22	2009; Now, therefore,			
23	The General Assembly of North Carolina enacts:			
24	SECTION 1.(a) There is established the Advisory Commission on Hospital			
25	Infection Control and Disclosure (Advisory Commission). The purpose of the Advisory			
26	Commission is to prepare State agencies, hospitals, and the public for the reporting and			
27	public disclosure of hospital-acquired infection incidence rates as may be required by			
28	law for specific clinical procedures under the following categories:

4	SECT	FION 1.(b) The Advisory Commission shall consist of 13 members
5	appointed as fol	lows:
6	(1)	Four shall be appointed by the General Assembly upon the
7		recommendation of the Speaker of the House of Representatives, as
8		follows:
9		a. One member who is a hospital infection control professional, as
10		recommended by the North Carolina Hospital Association;
11		b. One physician who is a member of the Society for Health Care
12		Epidemiology, as recommended by the Society for Health Care
13		Epidemiology;
14		c. The Director of the Statewide Program for Infection Control
15		and Epidemiology at the School of Medicine of the University
16		of North Carolina at Chapel Hill; and
17		d. One who is a member of the general public but who is neither a
18		health care professional nor affiliated with a health care facility.
19	(2)	Four shall be appointed by the General Assembly upon the
20		recommendation of the President Pro Tempore of the Senate, as
21		follows:
22		a. One physician who is a member of the Society for Health Care
23		Epidemiology, as recommended by the Society for Health Care
24 25		Epidemiology;
25 26		b. One member who is a hospital infection control professional, as
26		recommended by the North Carolina Hospital Association;
27		c. The Director of the Duke Inspection Control Network, or the
28 29		d. One who is a member of the general public but who is neither a
29 30		health care professional nor affiliated with a health care facility.
31	(3)	Five shall be appointed by the Governor, as follows:
32	(\mathbf{J})	a. A representative of the North Carolina Institute of Medicine, as
33		recommended by the North Carolina Institute of Medicine;
34		b. The Director of the NC Center for Hospital Quality and Patient
35		Safety;
36		c. The Director of the Consumer Protection Division of the Office
37		of the NC Attorney General;
38		d. The State Health Director; and
39		e. The State Epidemiologist.
40	The C	Governor shall appoint the Chair of the Advisory Committee.
41		FION 1.(c) Subject to the approval of the Legislative Services
42		e Advisory Commission may meet in the State Legislative Building or
43		Office Building. The Legislative Services Commission, through the
44	-	vices Officer, shall assign professional staff to assist in the work of the

The Directors of Legislative Assistants for the House of 1 Advisory Commission. 2 Representatives and the Senate shall assign clerical staff to the Advisory Commission, 3 and the expenses relating to the clerical employees shall be borne by the Advisorv 4 Commission. The Advisory Commission, while in the discharge of its official duties, 5 may exercise all the powers provided under G.S. 120-19 and G.S. 120-19.1 through 6 G.S. 120-19.4. The Commission may meet during a regular or extra session of the 7 General Assembly, subject to the approval of the President Pro Tempore of the Senate 8 and the Speaker of the House of Representatives. Members of the Commission shall 9 receive per diem, subsistence, and travel allowances in accordance with G.S. 138-5 or 10 G.S. 138-6, as applicable.

11 SECTION 2.(a) The Advisory Commission shall be meaningfully involved 12 in the development of all aspects of the methodology used for collecting, analyzing, and 13 disclosing publicly the information on hospital-acquired infection incidence rates, 14 including collection methods, formatting, and methods and means for release and 15 dissemination.

16 **SECTION 2.(b)** The Advisory Commission shall develop a process to 17 ensure that information and data on hospital-acquired infection incidence rates available 18 for dissemination to the general public shall not be made available in any form unless 19 the information and data have been reviewed, adjusted, and validated according to the 20 following process:

- (1) The entire methodology for collecting and analyzing the data shall be
 disclosed to all relevant organizations and to all hospitals and
 ambulatory surgical facilities that are the subject of any information to
 be made available to the public before any public disclosure of the
 information or data.
 - (2) Data collection and analytical methodologies shall be used that meet accepted standards of validity and reliability before any information is made available to the public.
 - (3) Comparisons among hospitals and freestanding ambulatory surgical facilities shall adjust for patient case mix and other relevant risk factors and control for provider peer groups, when appropriate.
 - (4) The limitations of the data sources and analytic methodologies used to develop comparative hospital and freestanding ambulatory surgical facility information shall be clearly identified and acknowledged, including the appropriate and inappropriate uses of the data.
 - (5) To the greatest extent possible, comparative hospital and freestanding ambulatory surgical facility information initiatives shall use standard-based norms derived from widely accepted provider-developed practice guidelines.
- 40(6)Comparative hospital and freestanding ambulatory surgical facility41information and other information that the statewide data processor or42Department has compiled regarding the hospital or freestanding43ambulatory surgical facility shall be shared with the hospital or44freestanding ambulatory surgical facility under review prior to public

1 2	dissemination of the information, and the hospital or freestanding ambulatory surgical facility shall have 30 days to make corrections and
$\frac{2}{3}$	to add helpful explanatory comments about the information before the
4	publication.
5	(7) Safeguards shall be implemented to:
6	a. Protect against the unauthorized use or disclosure of hospital
7	and freestanding ambulatory surgical facility information; and
8	b. Protect against the dissemination of inconsistent, incomplete,
9	invalid, inaccurate, or subjective hospital or freestanding
10	ambulatory surgical facility data.
11	(8) A process to ensure the quality and accuracy of information reported
12	by a hospital or freestanding ambulatory surgical facility under this
13	section and its data collection, analysis, and dissemination
14	methodologies are evaluated regularly.
15	(9) A process to ensure that only the most basic identifying information
16	from submitted reports are used, and except as otherwise authorized by
17	Article 11A of Chapter 131E of the General Statutes, information
18	identifying a patient, employee, or licensed professional shall not be
19	released.
20	SECTION 2.(c) The Advisory Commission shall establish standardized
21 22	criteria and methods for data submitted to the statewide data processor under G.S. 131E-214.2.
22 23	SECTION 3.(a) The Advisory Commission shall submit an interim report
23 24	on its activities to the General Assembly on or before May 1, 2008. The Advisory
24 25	Commission shall submit its final report to the 2009 General Assembly upon its
25 26	convening with recommendations and proposed legislation for requiring
20 27	hospital-acquired infection incidence rates public disclosure. Upon submission of its
28	final report, the Commission shall terminate.
29	SECTION 3.(b) It is the intent of the General Assembly to enact legislation
30	before adjournment sine die of the 2009 General Assembly requiring hospitals to report
31	and publicly disclose hospital-acquired infection incidence rates.
32	SECTION 4. The Legislative Services Officer shall allocate funds
33	appropriated to the General Assembly for this purpose to implement this act.
34	SECTION 5. This act is effective when it becomes law.
