Short Title: Medicaid County Share/Phase Out. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO PHASE OUT THE COUNTY SHARE OF THE NONFEDERAL SHARE
3 OF MEDICAL ASSISTANCE PROGRAM COSTS.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Notwithstanding any other provision of law to the contrary, the
6 county share of the nonfederal share of Medical Assistance Program costs, excluding
7 administrative costs, shall be as follows for counties designated as enterprise tier
8 counties under G.S. 105-129.3, and all other counties:

- 9 (1) Effective July 1, 2007, through June 30, 2009, nine percent (9%) for
10 enterprise tier one counties.
11 (2) Effective July 1, 2009, through June 30, 2011, six percent (6%) for
12 enterprise tier one counties.
13 (3) Effective July 1, 2009, twelve percent (12%) for all counties except
14 enterprise tier one counties.
15 (4) Effective July 1, 2010, nine percent (9%) for all counties except
16 enterprise tier one counties.
17 (5) Effective July 1, 2011, six percent (6%) for all counties.
18 (6) Effective July 1, 2012, three percent (3%) for all counties.

19 Effective July 1, 2013, one hundred percent (100%) of the nonfederal share of Medical
20 Assistance Program costs, excluding administrative costs, shall be borne by the State.

21 **SECTION 2.** Effective July 1, 2009, G.S. 108A-54 reads as rewritten:

22 "**§ 108A-54. Authorization of Medical Assistance Program.**

23 The Department is authorized and empowered to establish a Medical Assistance
24 Program from ~~federal, State and county~~ federal and State appropriations and to adopt
25 rules and regulations under which payments are to be made in accordance with the
26 provisions of this Part. ~~The nonfederal share may be divided between the State and the~~
27 ~~counties, in a manner consistent with the provisions of the federal Social Security Act,~~

1 ~~except that the share required from the counties may not exceed the share required from~~
2 ~~the state. If a portion of the nonfederal share is required from the counties, the boards of~~
3 ~~county commissioners of the several counties shall levy, impose and collect the taxes~~
4 ~~required for the special purpose of medical assistance as provided in this Part, in an~~
5 ~~amount sufficient to cover each county's share of such assistance."~~

6 **SECTION 3.** This act becomes effective July 1, 2007.
