1	A BILL TO BE ENTITLED
2	AN ACT TO INCREASE THE PROTECTION OF CHILDREN WHO RIDE IN THE
3	BACK OF PICKUP TRUCKS OR OPEN BEDS OF VEHICLES BY RAISING
4	THE MINIMUM AGE, REMOVING THE EXEMPTION THAT MAKES
5	ALLOWANCE FOR SMALL COUNTIES, AND MODIFYING THE
6	EXEMPTION THAT MAKES AN ALLOWANCE FOR AGRICULTURAL
7	ENTERPRISES, AND INCREASE THE PENALTIES.
8	The General Assembly of North Carolina enacts:
9	<b>SECTION 1.</b> G.S. 20-135.2B reads as rewritten:
10	"§ 20-135.2B. Transporting children under <u>12-16</u> years of age in open bed or open
11	cargo area of a vehicle prohibited; exceptions.
12	(a) The operator of a vehicle having an open bed or open cargo area shall insure
13	ensure that no child under <u>1216</u> years of age is transported in the bed or cargo area of
14	that vehicle. An open bed or open cargo area is a bed or cargo area without permanent
15	overhead restraining construction.
16	(b) Subsection (a) of this section does not apply in any of the following
17	circumstances:
18	(1) An adult is present in the bed or cargo area of the vehicle and is
19	supervising the child.
20	(2) The child is secured or restrained by a seat belt manufactured in
21	compliance with Federal Motor Vehicle Safety Standard No. 208,
22	installed to support a load strength of not less than 5,000 pounds for
23	each belt, and of a type approved by the Commissioner.
24	(3) An emergency situation exists.
25	(4) The vehicle is being operated in a parade pursuant to a valid permit.

1	(5) The vehicle is being operated in an agricultural enterprise.enterprise,
2	including providing transportation to and from the principal place of
3	the agricultural enterprise.
4	(6) The vehicle is being operated in a county that has no incorporated area
5	with a population in excess of 3,500.
6	(c) Any person violating this section shall have committed an infraction and shall
7	pay a penalty of <u>not more than</u> twenty-five dollars (\$25.00).(\$25.00), even if more than
8	one child less than 16 years of age is riding in the open bed or open cargo area of a
9	vehicle. Conviction of an infraction under this section has no consequence other than
10	payment of a penalty. A person found responsible for a violation of this section may not
11	shall be assessed court costs.
12	(d) No drivers license points or insurance surcharge shall be assessed on account
13	of violation of this section. A violation of this section shall not constitute negligence per
14	<u>se.</u> "
15	SECTION 2. This act becomes effective October 1, 2008, and applies to
16	offenses committed on or after that date.
