9 SECTION 1. Effective upon convening of the 2009 Regular Session of the
 10 General Assembly, G.S. 120-3 reads as rewritten:

11 "§ 120-3. Pay of members and officers of the General Assembly.

(a) <u>Members and certain officers of the General Assembly shall receive annual</u>
 salaries and expense allowances, both payable monthly, as follows:

21 The Speaker of the House shall be paid an annual salary of thirty-eight thousand one 22 hundred fifty one dollars (\$38,151) payable monthly, and an expense allowance of one 23 thousand four hundred thirteen dollars (\$1,413) per month. The President Pro Tempore 24 of the Senate shall be paid an annual salary of thirty-eight thousand one hundred 25 fifty one dollars (\$38,151) payable monthly, and an expense allowance of one thousand 26 four hundred thirteen dollars (\$1,413) per month. The Speaker Pro Tempore of the 27 House shall be paid an annual salary of twenty-one thousand seven hundred thirty-nine dollars (\$21,739) payable monthly, and an expense allowance of eight hundred 28

1 thirty six dollars (\$836.00) per month. The Deputy President Pro Tempore of the Senate 2 shall be paid an annual salary of twenty one thousand seven hundred thirty nine dollars 3 (\$21,739) payable monthly, and an expense allowance of eight hundred thirty-six 4 dollars (\$836.00) per month. The majority and minority leaders in the House and the majority and minority leaders in the Senate shall be paid an annual salary of seventeen 5 6 thousand forty-eight dollars (\$17,048) payable monthly, and an expense allowance of 7 six hundred sixty-six dollars (\$666.00) per month. 8 Every other member of the General Assembly shall receive increases in (h)9 annual salary only to the extent of and in the amounts equal to the average increases received by employees of the State, effective upon convening of the next Regular 10 11 Session of the General Assembly after enactment of these increased amounts, except no 12 such increase is granted upon the convening of the 1997 Regular Session of the General 13 Assembly. Accordingly, upon convening of the 1997 Regular Session of the General 14 Assembly, every other member of the General Assembly shall be paid an annual salary 15 of thirteen thousand nine hundred fifty one dollars (\$13,951) payable monthly, and an 16 expense allowance of five hundred fifty-nine dollars (\$559.00) per month. 17 (c) The salary and expense allowances provided in this section are in addition to 18 any per diem compensation and any subsistence and travel allowance authorized by any 19 other law with respect to any regular or extra session of the General Assembly, and 20 service on any State board, agency, commission, standing committee and study 21 commission." 22 **SECTION 2.** Effective upon convening of the 2009 Regular Session of the 23 General Assembly, G.S. 120-3.1(a)(3) reads as rewritten: 24 In addition to compensation for their services, members of the General "(a) 25 Assembly shall be paid the following allowances: 26 27 (3) A subsistence allowance for meals and lodging at a daily rate equal to 28 the maximum per diem rate for federal employees traveling to Raleigh, 29 North Carolina, as set out at 58 Federal Register 67959 (December 22, 30 1993), of one hundred thirty-four dollars (\$134.00) while the General 31 Assembly is in session and, except as otherwise provided in this 32 subdivision, while the General Assembly is not in session when, with 33 the approval of the Speaker of the House of Representatives in the case of Representatives or the President Pro Tempore of the Senate in case 34 35 of Senators, the member is: 36 Traveling as a representative of the General Assembly or of its a. 37 committees or commissions, or 38 Otherwise in the service of the State. b. 39 A member who is authorized to travel, whether in or out of session, within the United States outside North Carolina, may elect to receive, 40 41 in lieu of the amount provided in the preceding paragraph, a 42 subsistence allowance of twenty-six dollars (\$26.00) a day for meals, 43 plus actual expenses for lodging when evidenced by a receipt 44 satisfactory to the Legislative Services Officer, the latter not to exceed
