(b) Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

SECTION 4. G.S. 20-81.12 is amended by adding a new subsection to read: "(b73) Retired Piedmont Airlines Employee. – The Division must receive 300 or more applications for a Retired Piedmont Airlines Employee plate before the plate may be developed. The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of Retired Piedmont Airlines Employee plates to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships and family assistance for retired Piedmont Airlines employees and their families, including surviving spouses and dependents, suffering economic hardship."

SECTION 5. This act is effective when it becomes law.
