An S Corporation is not subject to the tax levied in this section. The tax is a percentage 8 9 of the taxpayer's State net income computed as follows: Income Years Beginning 10 Tax 11 In 1997 7.5% In 1998 7.25% 12 13 In 1999 7% 14 After 1999 6.9%. 1
