The (e) 4 Management and Operations Committee shall conduct the Council's business between quarterly 5 meetings. 6 (f) Administration. - The Director of the CGIA shall be secretary of the Council and 7 provide staff support as it requires. 8 Reports. - The Council shall report at least annually to the Governor and to the Joint (g) 9 Legislative Commission on Governmental Operations. 10 Committees. - The Council may establish work groups, as needed, and shall oversee (h) the standing committees created in this subsection. Each standing committee shall adopt 11 12 bylaws, subject to the Council's approval, to govern its proceedings. Except as otherwise 13 provided, the Chair of the Council shall appoint the standing committee chairs from 14 representatives listed in subsections (b), (c), or (d) of this section. The standing committees are 15 as follows: 16 (1)State Government GIS User Committee. - Membership shall consist of 17 representatives from all interested State government departments. The Chair 18 of the Council shall appoint the committee chair from one of the State 19 agencies represented in subsection (d) of this section. 20 (2) Local Government Committee. – Membership shall consist of 21 representatives from organizations and professional associations that 22 currently serve or represent local government GIS users, the North Carolina 23 League of Municipalities, the North Carolina Association of County 24 Commissioners, and Lead Regional Organizations. The committee shall 25 elect one of its members to the Council. 26 Federal Interagency Committee. – Membership (3) shall consist of 27 representatives from all interested federal agencies and Tribal governments 28 with an office located in North Carolina. The appointed federal 29 representative serving pursuant to subdivision (b)(4) of this section shall 30 serve as the Chair of the Federal Interagency Committee. 31 Statewide Mapping Advisory Committee. - This committee shall (4) 32 consolidate statewide mapping requirements and attempt to gain statewide 33 support for financing cooperative programs. The committee shall also advise 34 the Council on issues, problems, and opportunities relating to federal, State, 35 and local government geospatial data programs. GIS Technical Advisory Committee. - This committee shall develop the 36 (5) 37 statewide technical architecture for GIS and anticipate and respond to GIS 38 technical opportunities and issues affecting State, county, and local 39 governments in North Carolina. 40 (6)Management and Operations Committee. - This committee shall consider 41 management and operational matters related to GIS and other matters that 42 are formally requested by the Council. The committee membership shall 43 consist of the Chair of the Council, the State Budget Officer, the chair of 44 each of the standing committees of the Council, and other members of the 45 Council appointed by the Chair." 46 SECTION 3. G.S. 147-33.72H reads as rewritten: 47 "§ 147-33.72H. Information Technology Fund. 48 There is established a special revenue fund to be known as the Information (a) 49 Technology Fund, which may receive transfers or other credits as authorized by the General 50 Assembly. Money may be appropriated from the Information Technology Fund to meet

State portal operations, and the administration of systemwide procurement procedures. 1 2 Expenditures involving funds appropriated to the Office of Information Technology Services 3 from the Information Technology Fund shall be made by the State CIO in consultation with the 4 Information Technology Advisory Board. By October 1 of each year, the State CIO shall 5 submit to the Joint Legislative Oversight Committee on Information Technology a report on all expenditures involving funds appropriated to the Office of Information Technology Services 6 7 from the Information Technology Fund for the preceding fiscal year. Interest earnings on the 8 Information Technology Fund balance shall be credited to the Information Technology Fund. 9 In addition to the purposes listed in subsection (a) of this section, the Information (b) 10 Technology Fund shall be used (i) to fund the Center for Geographic Information and Analysis 11 (CGIA) in its legislatively mandated duties under G.S. 143-725(b); (ii) to fund acquiring and managing, at the lowest cost, data layers useful to multiple State and local organizations, 12 13 according to the priorities set by the North Carolina Geographic Information Coordinating Council; and (iii) to fund the development, operation, and maintenance of NC OneMap, the 14 statewide GIS data clearinghouse and warehouse and provider of Internet access to State 15 geographic information. The Information Technology Fund may receive private grants and gifts 16 17 and may include State, federal, local, and matching funds for this purpose." 18 **SECTION 4.** This act is effective when it becomes law.
