7 SCHOOL OF OPTOMETRY, AS RECOMMENDED BY THE LEGISLATIVE
8 RESEARCH COMMISSION STUDY COMMITTEE ON HEALTH CARE PROVIDER
9 PRACTICE SUSTAINABILITY AND TRAINING/ADDITIONAL TRANSPARENCY IN
10 HEALTH CARE.

11 The General Assembly of North Carolina enacts:

12 **SECTION 1.(a)** By December 1, 2014, the Board of Governors of The University
13 of North Carolina shall evaluate and report to the Joint Legislative Oversight Committee on
14 Health and Human Services and the Fiscal Research Division on the feasibility of establishing a
15 school of optometry at one or more of the following constituent institutions:

- 16 (1) The University of North Carolina at Chapel Hill.
17 (2) East Carolina University.
18 (3) Elizabeth City State University.
19 (4) Fayetteville State University.
20 (5) North Carolina Agricultural and Technical State University.
21 (6) North Carolina Central University.
22 (7) Winston-Salem State University.

23 **SECTION 1.(b)** The report shall include at least all of the following:

- 24 (1) A breakdown of any projected capital, operational, or other expenditures
25 necessary for establishing and operating a school of optometry affiliated
26 with the institution.
27 (2) A breakdown of all funds available to assist the institution with these
28 expenses.
29 (3) A projected number of applicants for the affiliated school of optometry.

30 **SECTION 2.** The North Carolina Independent Colleges and Universities, Inc.,
31 (NCICU) is encouraged to examine and report by December 1, 2014, to the Joint Legislative
32 Oversight Committee on Health and Human Services and the Fiscal Research Division on the
33 feasibility of establishing a school of optometry affiliated with an NCICU college or university.
34 The report should include at least all of the following:

7 **SECTION 3.** This act is effective when it becomes law.
