1 A HOUSE RESOLUTION HONORING NORTH CAROLINA EXTENSION AND  
2 COMMUNITY ASSOCIATION, INC., ON THE ONE HUNDREDTH ANNIVERSARY  
3 OF ITS FOUNDING.

4 Whereas, the forerunner to the modern Extension and Community Association in  
5 North Carolina was Extension Homemakers and Home Demonstration; and

6 Whereas, in 1911, Dr. I.O. Schaub recruited Jane S. McKimmon for the position as  
7 the first North Carolina State home demonstration agent; and

8 Whereas, beginning 100 years ago, Jane S. McKimmon worked to improve the  
9 quality of rural life and helped this State prevail during the Great Depression and two World  
10 Wars by the formation of community clubs of volunteers to support the work of Home  
11 Demonstration; and

12 Whereas, North Carolina Federation of Home Demonstration Clubs merged with the  
13 State Council of Negro Home Demonstration Clubs of North Carolina to become North  
14 Carolina Extension Homemakers Association in 1966 and North Carolina Extension &  
15 Community Association in 1999; and

16 Whereas, North Carolina Extension & Community Association was led through the  
17 last century by a succession of outstanding leaders, including Dr. Jane S. McKimmon, Ada  
18 Dalla Pozza, Dr. Judy Mock, Dr. Martha Johnson, Dr. Sandy Zaslów, and Dr. Marshall Stewart  
19 from North Carolina State University and North Carolina Agricultural & Technical State  
20 University; and

21 Whereas, from its modest beginnings Extension & Community Association has  
22 grown to a diverse, wide-ranging statewide organization of adult volunteers supporting the  
23 professional extension staff from North Carolina's two land-grant universities, North Carolina  
24 Agricultural & Technical State University in Greensboro and North Carolina State University  
25 in Raleigh; and

26 Whereas, Extension & Community Association is organized in all of North  
27 Carolina's 100 counties and the North Carolina Cherokee Reservation; and

28 Whereas, Extension & Community Association views the family, in all its diverse  
29 forms, as the cornerstone of a healthy society and provides research-based programming to  
30 support families; and

31 Whereas, the North Carolina Extension & Community Association will be  
32 celebrating its centennial anniversary formally on October 27, 2013, and throughout 2013;  
33 Now, therefore,

34 Be it resolved by the House of Representatives:

35 **SECTION 1.** The House of Representatives honors the life and memory of Jane S.  
36 McKimmon, whose steadfast dedication and far-reaching vision established the foundation  
37 upon which today's North Carolina Extension & Community Association is built.
